Hello, Sue –

I was just speaking to Doug in finance about your damage claim process. He told me to submit an estimate to you regarding an incident that took place around 3:08 PM yesterday (6/13/2019).

I was driving southbound on US 41 around Winchester Ave. when a small block of wood fell off one of your county highway flatbed trucks and struck my 2018 Honda Accord in the front end (driver's side). He was traveling in front of me in the lane to my left, but I could not dodge the block of wood as I was pinned in on my two other sides. At the time I was actually speaking on the phone with Becky Power from your EM department. Anyway, I forgot to look for damage right away as I had to quickly attend a ceremony for one of my daughters. I remembered the incident when I arrived at work this morning and took the attached photo. It appears that the block of wood actually speared thru my driver's side front headlamp cover. I haven't check to see if the headlamp is still operational, but I will do so at the end of today.

What is you specific claim process? Doug mentioned that you need a quote and a short summary of the incident (as above). If you need another photo with the wood removed, then I'd be happy to send that, too. I just don't want to "jump the gun" on the repair work if there is some other necessary step.

Thanks for your help, and please let me know what I should do next as I do not want to get water into that space and cause more damage.
