Vaccination Exemption Information

Types of School Vaccination Requirements exemptions^{1,2}

- Religious Exemptions: 44 states have religious exemptions, but the requirements differ.
- Personal Belief (Conviction) Exemptions: Only 15 states allow personal exemptions for children whose parents have a
 philosophical or personal belief objection to vaccination.
- Medical Exemptions: All states allow exemption from vaccination requirements for medical reasons. 5 states allow only medical exemptions.

Vaccine Facts³

- 88% of U.S. adults said the benefits of the MMR vaccine outweigh the risks
- 8 in 10 U.S. adults said MMR vaccination should be a requirement in order to attend public schools because of the potential risk for others when children are not vaccinated
- Nearly 1300 students in Winnebago County schools have not been vaccinated/protected from preventable diseases for
 personal reasons compared to just over 200 students who aren't vaccinated for medical or religious reasons (data below)

 - o 2 schools have personal waiver rates above 20%
 - 1 school has a personal waiver rate of 13%
 - o 6 schools have a personal waiver rate of 5%-12%

It's not just Measles

In Winnebago County there were 93 cases of Pertussis in 2016 compared to 20 in 2015

- 1-3 weeks of being contagious before symptoms appear
- 5 days of quarantine (which means no work and no school; lost education and lost wages)
