**A. CALL TO ORDER**

Chairman Thomas Egan called the meeting of the Winnebago County Board of Supervisors to order at 6:00 P.M. from the Winnebago County Courthouse, 415 Jackson Street, Oshkosh, Wisconsin and virtually by ZOOM.

#### **H. REPORTS FROM COMMITTEES, COMMISSIONS & BOARDS**

Supervisor Powers wanted to call attention to the fact that the Winnebago County Sheriff's Department has sent a cadaver dog to the Two Rivers area to aid in the search of a missing 3-year old.

Supervisor Binder mentioned while attending the NACo conference, he did go to Senator Baldwin's office to check on the air rescue boats and was informed that we should know something on those the first part of March.

Supervisor Defferding reminded everyone that on March 13, 2024, from 12:00 – 5:00 pm at the UW Oshkosh Culver Center is the, "We Heart You Recovery Event". It is an opportunity to connect to those who participate in the county's diversion program, drug court and drug and alcohol treatment program. This is a way to connect local resources together to find out what we can do to help out those in recovery in Winnebago County. It is free and open to the public.

Supervisor Horan had the pleasure to visit the Wittman Airport and see what they do over there and encourages anyone who hasn't seen it, please do.

Supervisor Nichols stated the best way to make sure high school seniors know about the scholarship applications is to get the scholarship applications to the guidance office and highly encourages the fellow supervisors to do that. Ms. Nichols also thanked everyone for the condolences expressed after her father passed away.

Supervisor Schellenger mentioned that earlier this month, Park View Health Center (PVHC) Committee had met and it was discovered that PVHC is undergoing a Strategic Plan with a \$150,000 contract. This was a surprise to the committee. There was nothing in the recent budget that indicated that this was a change or something that was going to be there. The reason Mr. Schellenger brought it up was because in the next few months, items may be coming to this board from PVHC that should probably be treated with a fair degree of skepticism. He encouraged supervisors to pay attention to upcoming meetings to see what is coming down from PVHC.

#### **I. COUNTY EXECUTIVE'S REPORT**

Executive Doemel reported on the following topics:

- Executive Doemel provided a Winter Storm Bennet recap and how several departments, agencies and other community efforts within Winnebago County acted to keep the wheels turning during this winter weather event.
- Executive Doemel asked for any supervisor that voted "no" on the Harm Reduction Vending Machine Resolution to please reconsider their vote which could happen at any time during this meeting. There would not be any discussion or action at this meeting. The agenda item would be put on the March business meeting agenda where it could be discussed again. Executive Doemel encouraged the supervisors to accept and appropriate this grant funding to purchase the tools we need to start turning the tide.
- Executive Doemel pointed out that a draft "Results and Results Definitions", a component for the Strategic Plan is on your desk tonight. It is important to show where the process is before the county gets any further. This is an opportunity to provide input which will help us to ensure we agree on the foundation going forward. Chris Fabian will be here for the March 5, 2024, Special Orders meeting to go over this document and receive your feedback.

#### **2. Ordinance 316-022024: Amend Winnebago County General Code Chapter 7.02 "Speed Limit Regulations" to Decrease the Speed Limits in the Town of Black Wolf and Nekimi on County Trunk Highway "I" to 40 miles per hour**

WHEREAS, the Highway Committee has reviewed and recommends approval of the following amendments to the Winnebago County General Code Chapter 7.02: Speed Limit Regulations as attached; and

WHEREAS, the amendments define and decrease the speed limits in the Town of Black Wolf and Nekimi on County Trunk Highway "I" to 40 miles per hour from its intersection with W. Waukau Avenue southerly for a distance of 1.38 miles to the intersection with Hartland Road.

NOW, THEREFORE, THE WINNEBAGO COUNTY BOARD OF SUPERVISORS DOES ORDAIN AS FOLLOWS:

(9) COUNTY TRUNK HIGHWAY "I"

(a) Town of Black Wolf and Nekimi:

1. 40 miles per hour from its intersection with W. Waukau Avenue southerly for a distance of 1.38 miles to its intersection with Hartland Road.

BE IT FURTHER ORDAINED by the Winnebago County Board of Supervisors that said amendments to the General Code of Winnebago County shall become effective on the date following the date of publication.

**3. Ordinance 317-022024: Amend Winnebago County General Code Section 1.12(10) to Increase and Expand Citizen Member Compensation on Committees, Commissions, Boards and other Entities as well as Board of Canvas Citizen Member Compensation**

WHEREAS, citizen membership of Winnebago County committees, commissions, and boards as well as

other entities is integral to carry out the mission of the Winnebago County Board of Supervisors; and

WHEREAS, the Winnebago County Board of Supervisors has reviewed and upgraded compensation for Winnebago County Board Supervisors; and

WHEREAS, it is in the interest of the Winnebago County Board of Supervisors and citizens of Winnebago County to adequately compensate citizen members appointed to committees, commissions, and boards and other entities.

NOW, THEREFORE, THE WINNEBAGO COUNTY BOARD OF SUPERVISORS DOES ORDAIN AS FOLLOWS: Section 1.12 (10) is amended as follows:

Non-supervisors who are duly appointed to serve on committees, boards, commissions, who are not acting within the scope of their employment or office in so doing, shall be ~~eligible for a \$50 payment for a half day meeting (4 hours or less) but not more than \$75 per day and expense reimbursements as supervisors: (a) Board of Adjustment (b) Land Conservation Committee (c) Solid Waste Management Board (d) Committee on Aging (e) Health Board (f) Public Safety Building Board — Members at Large (g) Information Systems Committee (h) Grievance Review Board (i) Veteran Service Commission (j) Housing Authority~~ paid \$75.00 per half day of service (4 hours or less) and \$100 per full day of service (more than 4 hours). Board of Canvas Citizen Members, in recognition of the stress and concerted effort required, shall be paid \$100 per half day of service (4 hours or less) and \$150 per full day of service (more than 4 hours).

## **ITEMS REMOVED FROM CONSENT CALENDAR**

### **1. Approval of Proceedings from January 2, 2024, Special Orders Session and January 16, 2024, Adjourned Session of the Winnebago County Board of Supervisors**

Supervisor Nussbaum requested that this item be pulled from the Consent Calendar. A public comment was missed on the January 16, 2024, proceedings. The proceedings were amended to add this information.

### **10. Resolution 325-022024: Support the SPEAR (Sturgeon Protected and Exempt from Absurd Regulations) Act which Exempts Wisconsin from Any Listing of Lake Sturgeon under the Endangered Species Act**

WHEREAS, the US Fish & Wildlife Service is currently considering recommending that lake sturgeon be listed as an endangered species under the Federal Endangered Species Act; and

WHEREAS, the 1973 Federal Endangered Species Act was designed to protect critically imperiled species from extinction; and

WHEREAS, lake sturgeon in Wisconsin are abundant in many waters, and are not identified by Wisconsin endangered species laws as either endangered or threatened, nor heading towards extinction; and

WHEREAS, Wisconsin has a world-renowned statewide lake sturgeon conservation, management and recovery program implemented over 100 years ago, and is currently recognized as a world leader in effective and sustainable management of sturgeon populations and fisheries; and

WHEREAS, the citizens of Winnebago County, the greater Winnebago System region, and the state have worked in partnership with the Wisconsin Department of Natural Resources over the last 50 years to develop, fine tune, and continuously improve and implement the Wisconsin and Winnebago System Sturgeon Management Programs; and

WHEREAS, Federal Endangered Species Act listing of lake sturgeon as endangered will bring an unnecessary intrusion of federal bureaucracy and regulation into Wisconsin, seriously hampering the state's ability to continue its long-term world class sturgeon management program in its historic form, and potentially seriously impacting lake sturgeon research and management activities and fisheries in the state in a negative fashion. Additionally, it will ignore the cultural importance and economic impact of lake sturgeon and sturgeon spearing in Wisconsin.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it supports the SPEAR (Sturgeon Protected and Exempt from Absurd Regulations) Act which exempts Wisconsin from any listing of lake sturgeon under the Endangered Species Act.

## **L. Presentation of Resolutions and Ordinances previously tabled or laid over to a day certain, and disposition of same**

### **1. Resolution 313-012024: Approving \$500,000 from the Spirit Fund's Government Identified Community Projects Category to Expand the Building of NOVA Counseling Services Facilities**

WHEREAS, Nova Counseling Services (hereinafter "Nova") is a State of Wisconsin-licensed provider of medically monitored residential treatment for people suffering from substance use disorders; and

WHEREAS, treatment at Nova is for individuals who have lost control of their lives and need a safe, structured environment in which to learn about their disease. Nova provides therapy to change the behaviors that accompany substance use; and

WHEREAS, for over four decades, Nova has been grounded in the 12 Steps of Alcoholics Anonymous® philosophy and believes it is the surest way to recover from the disease. Education about the illness, knowledge of the 12 Steps, and caring feedback are the cornerstones for change; and

WHEREAS, Nova provides treatment in a variety of ways, including a 28-day residential program, 90-day transitional program (Terra Program), Family Program and outpatient aftercare; and

WHEREAS, an expansion of Nova's existing facilities will better serve people suffering from substance use disorder, including the STAR Program.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that \$500,000 from the Spirit Fund's Government Identified Community Project category be approved to expand the facilities of Nova Counseling Services. This funding is contingent on Nova remaining committed to its mission to strengthen the lives of individuals, families, and the community.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that upon completion, Nova Counseling Services will submit supporting documentation to the Winnebago County Finance Director outlining the expenditures. The documentation will be submitted within 6 months of the completion of the project but not to exceed 5 years from date of disbursement.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that Nova Counseling Services shall be responsible for reimbursement to Winnebago County for any disbursed funds which are determined by Winnebago County to have been misused or misappropriated. Any reimbursement of funds which is required by Winnebago County shall be due within 45 days after giving written notice to recipient of such misuse or misappropriation.

**M. Presentation of new Resolutions and Ordinances and disposition of same**

**1. Resolution 324-022024: Establish Salaries for County Clerk, Register of Deeds, and County Treasurer of Winnebago County**

WHEREAS, the next four-year term of office will begin in January 2025 for the Winnebago County Clerk, County Treasurer, and Register of Deeds; and

WHEREAS, section 59.22 of the Wisconsin Statutes requires that any changes in the compensation for these elected positions must be adopted by the County Board of Supervisors earlier than the first date for filing nomination papers for the upcoming term, which in this case is April 15, 2024; and

WHEREAS, reasonable salaries are necessary to attract well-qualified candidates to these full-time elected positions; now, therefore:

BE IT RESOLVED by the Winnebago County Board of Supervisors that the annual salary rates for the following elected officials of Winnebago County for the term commencing after January 1, 2025 shall be as follows:

**2. Resolution 326-022024: Ratifying Tentative Agreement between Winnebago County and the Winnebago County Deputies' Association Covering January 1, 2024 through December 31, 2026**

WHEREAS, the existing collective bargaining agreement between Winnebago County and the Winnebago County Deputies' Association expired on December 31, 2023; and

WHEREAS, a Tentative Agreement has been reached which specifies changes for a successor collective bargaining agreement to cover the calendar years 2024, 2025, and 2026; and

WHEREAS, the Tentative Agreement has been ratified by the Deputies' Association; and

WHEREAS, the Tentative Agreement incorporates many of the practices that had been put into place by previous Memoranda of Understanding, such as schedule changes, rules on the switching of shifts, accelerated benefits, and compensation, as well as other, relatively minor, language changes; and

WHEREAS, this Tentative Agreement takes into account recent changes in the labor market for law enforcement officers, such as a very substantial increase in pay for jailers employed by the state Department of Corrections as well as recent contract settlements for the City of Oshkosh police department and for several comparable county law enforcement bargaining units; and

WHEREAS, some of the most noteworthy changes in the Tentative Agreement are as follows:

- Patrol and Corrections schedule changing from 8-hour shifts working 6 days then off 3 days, to 12-hour shifts working 4 days then off 5 days.
  - Standardizing other schedules to 40 hours/week by either working 8-hour shifts or 10-hour shifts.
  - Updating the guidelines to provide for the switching of shifts among employees.
  - Adjusting the hours of sick time earned to better align with a 12-hour schedule.
  - Modifying the language regarding Holidays to simplify and clean up language that more precisely identifies how earned and paid out upon leaving employment. This clarification minimizes misunderstandings and therefore reduces future grievances.
  - Codifies changes in an existing MOU regarding the vacation earning schedule and ability to base earnings on service in another agency in similar capacity.
  - Minimizes opportunity to pay out earned, but unused benefit time, which streamlines payroll operations.
  - Expands the type of paid time off that can be utilized to supplement funeral leave to support employees facing loss.
  - Patrol and Corrections Deputies will return to following the same wage table. In January 2022, Patrol Deputies received a \$3.00/hour pay increase across all steps due to market issues which resulted in a high turnover rate and lack of qualified applicants. This Tentative Agreement will provide Corrections Deputies that same \$3.00/hour increase as of January 2024. This will keep those positions competitive with the State DOC rates.
  - The length in time for each pay step has been lengthened by six months.
  - The starting pay rate increases 3.0% each year, steps in the middle increase 4% each year, and the maximum rate increases 4.5% each year;
- and

WHEREAS, ratification of this Tentative Agreement will position the County well with respect to recruitment and retention of deputies in the Sheriff's Office, while providing fair compensation to those officers, and is in the best interests of Winnebago County; and

WHEREAS, sufficient funds have been set aside in the 2024 salary contingency to cover the costs associated with this Agreement;

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it ratifies the Tentative Agreement between Winnebago County and the Winnebago County Deputies' Association covering January 1, 2024 through December 31, 2026, and that the County Executive and County Clerk are authorized to execute a new collective bargaining agreement reflecting its terms.

BE IT FURTHER RESOLVED that the additional wage and benefit expenses associated with this Tentative Agreement for calendar year 2024 may be transferred from the salary contingency account to appropriate labor expense accounts for the Sheriff's Office.

WHEREAS, on March 31, 2021, the Wisconsin Supreme Court declared Wisconsin's statewide mask mandate invalid; and

WHEREAS, when dealing with the local conditions related to the COVID-19 virus, local authorities should exercise common sense; and

WHEREAS, health decisions are best made by individuals, not government; and

WHEREAS, it is the right of individuals to choose whether to wear a mask and whether to be vaccinated; and

WHEREAS, citizens have lived with COVID-19 for over 3 years and have been provided information regarding how to protect themselves from COVID-19 and are fully capable of making their own decisions; and

WHEREAS, lockdowns, vaccine, and mask mandates have been shown to have a negative impact on economies and mental health; and

WHEREAS, some entities are considering and have imposed new mask mandates in response to an apparent resurgence of the COVID-19 virus.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it encourages individuals to make educated personal healthcare decisions to continue to slow the spread of the COVID-19 virus.

BE IT FURTHER RESOLVED that the Winnebago County Board of Supervisors does not intend to support nor impose any lockdowns, vaccine, or mask mandates related to COVID-19 or its variants.

BE IT FURTHER RESOLVED that the Winnebago County Board of Supervisors wishes to communicate to the people of Winnebago County and to state and federal authorities:

- In the absence of a state or federal lockdown, vaccine, or mask mandate, Winnebago County does not intend to create or enforce a mandate;
- If the state or federal government creates a lockdown, vaccine, or mask mandate, Winnebago County shall not voluntarily use its resources in support of the same and shall comply only to the extent required by law or superior authority;
- As a statement of policy, Winnebago County believes that such mandates are not proper;
- As a matter of Constitutional Law, Winnebago County believes that the prior precedent should not apply to current circumstances.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that a copy of this resolution shall be forwarded to Winnebago County's state and federal delegations, Governor Evers, all other Wisconsin Counties, and the Wisconsin Counties Association.

**4. Resolution 328-022024: Winnebago County Statement Regarding Informed Choice and Consent to Make Personal Healthcare Decisions**

WHEREAS, on July 30, 2020, Governor Tony Evers issued Emergency Order #1 mandating face coverings (masks) throughout Wisconsin; and

WHEREAS, studies published in Cochrane.org and referenced in a New York Times article of February 21, 2023, suggested that masks and mask mandates were not as an effective deterrent as indicated by mandates; and

WHEREAS, on March 31, 2021, the Wisconsin Supreme Court declared Wisconsin's statewide mask mandate invalid; and

WHEREAS, when dealing with local conditions related to the COVID-19 virus, local authorities should exercise discretion; and

WHEREAS, health decisions are best made by individuals in conjunction with their physician or other health care provider without bureaucratic overreach; and

WHEREAS, the rights of individuals to choose best for themselves and family is a paramount foundation of the United States Constitution and the Wisconsin State Constitution; and

WHEREAS, now, after more than three (3) years, information regarding medicinal and physical intervention has been published that differs from initial response recommendations; and

WHEREAS, according to non-partisan research facility, the Brookings Institution and its March 2022 conclusion, mandates, lockdowns, and school closures from Local, State, and Federal policies have led to "schools (facing) severe staff shortages, high rates of absenteeism and quarantines, and rolling school closures. Furthermore, students and educators continue to struggle with mental health challenges, higher rates of violence and misbehavior, and concerns about lost instructional time." "[T]est score gaps between studies in low-poverty and high-poverty elementary schools grew by approximately 20% in math" and more; and

WHEREAS, some entities are and have considered reinstating these same mandates and restrictions.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it encourages individuals to make educated personal healthcare decisions in conjunction with their healthcare advisors, including physicians and the Winnebago County Board of Health.

BE IT FURTHER RESOLVED that the Winnebago County Board of Supervisors does not intend to impose a one size fits all approach.

BE IT FURTHER RESOLVED that the Winnebago County Board of Supervisors wishes to communicate:

- In the absence of a state or federal order, Winnebago County does not intend to create or enforce blanket or universal mandates;
- Winnebago County shall not voluntarily utilize monetary or personnel resources in support of a State or Federal created mandate of lockdowns, medicinal or physical devices, absent the freedom of informed consent;
- Winnebago County believes the freedom of choice to the individual as guaranteed through the United States Constitution and State of Wisconsin Constitution should be paramount;
- Winnebago County's practices beginning in the spring of 2020 relating to the Covid-19 pandemic should not apply to current or future healthcare situations.

**13. Resolution 337-022024:                    Approving \$500,000 from the Spirit Fund's Government Identified Community Projects Category to Build an Emergency Service Training Facility for the Neenah/Menasha Fire Department**

WHEREAS, Neenah-Menasha Fire Rescue consists of committed professionals whose mission is to provide the highest standard of service through prevention, education, fire suppression, emergency medical response, technical rescue and community interaction to preserve the quality of life and property for all of those within the Cities of Neenah and Menasha; and

WHEREAS, Live Fire Training is essential to the health and safety of firefighters and communities; and  
WHEREAS, firefighters must complete eighteen (18) hours at a training facility annually, out of 192 total training hours, to meet Insurance Services Office (ISO) requirements; and

WHEREAS, the current training facility is approaching 25 years of age and has served many roles:

- 1.FVTC's main training facility from 1996-2015,
- 2.Joint Firefighter Recruit Academy (on-boarding all Neenah Menasha Fire/Rescue and City of Oshkosh firefighters) since 2019,
- 3.Routinely used by Town of Neenah Fire Department, City of Neenah Police Department, City of Menasha Police Department, Winnebago County Sheriff's Department; and

WHEREAS, in addition to Live Fire Training, this facility can simulate single or multi-family residences, high-rise structures, and commercial buildings for tactical (LE) situations along with laddering and rescue work; and

WHEREAS, providing a training facility to challenge firefighters' knowledge and skills will reduce the risk in the field, and

WHEREAS, the Neenah/Menasha Fire Department completed a Spirit Fund application on-time, requesting \$500,000, and

WHEREAS, the ARPA Strategy and Outcomes Commission recommends a grant of \$500,000 from the Winnebago County Spirit Fund; and

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that \$500,000 from the Spirit Fund's Government Identified Community Project category be approved to build an emergency services training facility for the Neenah/Menasha Fire Department.

WHEREAS, the Village of Winneconne completed Spirit Fund applications for both the Barn Remodel and Winneconne Parks improvements on-time, requesting \$315,000, and  
WHEREAS, the ARPA Strategy and Outcomes Commission recommends a grant of \$324,500 from the Winnebago County Spirit Fund; and

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that \$324,500 from the Spirit Fund's Government Identified Community Project category be approved to improve and add onto boat ramps and piers, fish cleaning stations, larger bulk heads, extended parking, and upgrades to Winneconne Parks in the Village of Winneconne.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that upon completion of the project, the Village of Winneconne will submit supporting documentation to the Winnebago County Finance Director outlining the expenditures. The documentation will be submitted within 6 months of the completion of the project but not to exceed 5 years from date of disbursement.
