Subject:	Report of 2023 Audit of Winnebago County Library Borrower Registration Records

The Agreement / Plan between Winnebago County and the Winnefox Library System requires that we conduct an audit of borrower registration records every five years. Previous audits were conducted in 2013 and 2018.

In order to conduct the audit, we generate a random sample of borrower registration records and determine whether they are indeed registered in the correct community so that the circulation of library materials is "charged" correctly to either the rural towns (collectively) or to the municipalities with libraries.

First, Winnefox generated a random sample of one percent of Winnebago County active borrower registration records. An active borrower is someone who has used their card in the past twelve months. Next, we asked Winnebago County's GIS Department to determine whether the addresses in the Winnefox borrower data base matched valid addresses in the county's GIS data base. Of the 350 borrower registration records in the 2023 sample, the GIS Department staff was able to match 341. This left 9 records for Oshkosh Public Library staff to examine for possible coding errors. Addresses that were incomplete or had typographical errors were fixed and the corrected addresses checked manually against the county's GIS data base.

All of the 9 records reviewed by Oshkosh Public Library Circulation Supervisor Matt Schrottky were determined to have incorrect codes in their UserCat1 field, which corresponds to the county GIS data base's civil jurisdiction code.

Mr. Schrottky sorted each of these incorrect borrower registration records into one of the following categories:

Coding errors that affect Winnebago County funding:

1. UserCat1 field is coded for Menasha, Neenah, Omro, Oshkosh, Winneconne, or Appleton (a small portion of which is within Winnebago County), but **should have been coded for**



one of the towns. These errors have the effect of reducing county payments to the city libraries.

UserCat1 field is coded for one of the towns, but should have been coded for one of the cities mentioned in #1 above. These errors have the effect of increasing county payments to the city libraries.

Coding errors not affecting Winnebago County funding:

- 3. UserCat1 field is coded for one of the cities mentioned in #1 above, but **the wrong Winnebago County city is coded.**
- 4. UserCat1 field is coded for a Winnebago County town, but **the wrong Winnebago County town is coded.**
- 5. Unable to determine nature of the error without research.

The table on the next page presents the data from the 2023, 2018, and 2013 borrower registration audits. The 2023 results are consistent with the earlier audits, with total errors in the latest audit falling under 5% of the sample. Errors with an impact on the county budget were in favor of the county. I believe that the percentages of error are low enough to be insignificant and demonstrate that our numbers are accurate enough for the purposes of our funding formula.

In order to ensure accurate borrower records, Winnefox libraries routinely double-check the data entered for new borrower registrations and carry out monthly reviews of the records of borrowers whose cards have recently expired and been renewed.
