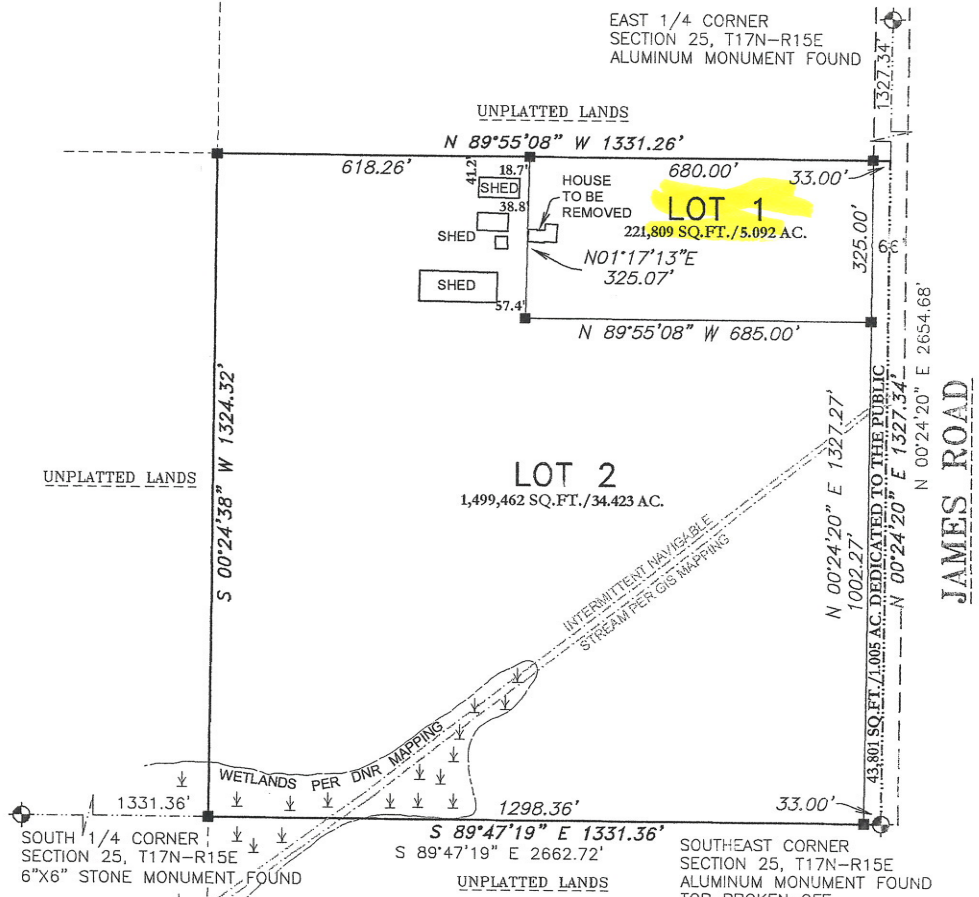

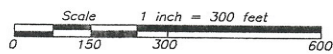

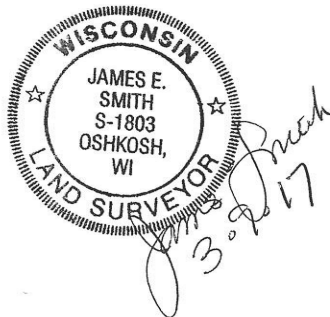

Tom Thiel said if there is an issue with the driveway and if another would be needed on the farmland, we can work that out later. Darwin Briggs asked if all the sheds are 10' away from the lot line. Tom Thiel said all setback requirements are met. Robert Kumbier said it is fine as long as the house will meet all the restrictions.

Donavon Bradley motions to allow them do what they want to do, as in the permit, seconded by Tim Oliver. Carried

6. Discuss the Sex Offender Ordinance

Len Schmick said we have been having issues with group homes. Over 1/3 of the Fire and EMS calls have been to these group homes. We have been pursuing this legally and talking with the Town Attorney. Rep Michael Schraa will be coming to May's Board meeting. The state needs to do something about this and is not allowing us, as a Town, to do anything. The state is legally binding us but state laws cannot be superseded by Town rules. We would like to have something that has effect. Constable Ralph Kalies is at a Winnebago Towns Association meeting about this subject. The Town's Attorney drafted an Ordinance for our review. Group homes are a "family unit" and cannot defer from our town. They are run by someone who is paid by the State to provide a place for people that need care. The staff is watching these people and there is a 'safe room' where the staff can go into if there are any problems. We need to find ways to make sure the residents in the area know they are there. People residing in these group homes can leave the group home and walk around to another home. We will continue to look into this to find the best way to resolve this. Tom Thiel feels this would be good to have and recommends to the Town Board to accept the Sex Offender Ordinance so we have some protection in our township, seconded by Darwin Briggs. Carried

Tom Thiel – was brought to his attention about the frontage, if it's continuous or could be broken up on lots; need 66' right-of-ways. We can talk about this at another meeting later. Suggests to the other members to look over the Ordinance and come with any suggestions.
