RESOLUTION NO. 169-72017: Authorize Release of Winnebago County's Interests in Recorded Agreement Between the City of Oshkosh and Paul Redemann

WHEREAS, upon the purchase of what is now the Winnebago County Human Services Department building, Winnebago County also was provided an interest in a recorded easement agreement between the City of Oshkosh and Paul Redemann, Document Number 695777, which was recorded with the Winnebago County Register of Deeds on February 8, 1988; and

WHEREAS, said easement is in relationship to the parking lot immediately across Washington Avenue from the Winnebago County Department of Human Services building located at 220 Washington Avenue in the City of Oshkosh; and

WHEREAS, said easement serves no purpose at the present time and creates an unnecessary encumbrance to the development of said property by the City of Oshkosh and is of no benefit to Winnebago County.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes a release of all its interests identified in a recorded easement agreement between the City of Oshkosh and Paul Redemann, dated February 2, 1988, and recorded with the Winnebago County Register of Deeds on February 8, 1988, as Document Number 695777. The real property subject to the recorded easement and, therefore, the subject of the release of easement rights is described as follows:

Parcel Number: 90200620000

Located in the City of Oshkosh, Winnebago County, Wisconsin, and originally part of Fractional Lot 1 of Section 24, Township 18 North of Range 16 East, and more particularly described:

All of Lots One (1) and Two (2(), the Easterly 60 feet of Lot Three (3), all of Lot Four (4), and the Westerly 29.2 feet of Lot Five (5), all in Block Twenty-six (26) of L.M. Miller's First Addition, 2nd Ward, City of Oshkosh. And

Lot "C" in Papendk's Plat in the 2nd Ward, City of Oshkosh per Leach's Map of 1894, originally being a part of Fractional Government Lot 2, Section 24 Township 18 North Range 16 East.

The specific easement property defined within the recorded easement is within property originally part of Fractional Lot 1 of Section 24, Township 18 North of Range 16 East, and more particularly described as:

A 15 ft easement through Lots 4 and 5 of L.M. Miller's First Addition, Block 26, 2nd Ward, City of Oshkosh, Winnebago County, Wisconsin, whose centerline is described as follows:

RESOLUTION NO. 170-72017: Appropriate \$2,252,250 to a Capital Project to Upgrade the Computer Aided Dispatch (CAD) and Records Management System (RMS) in the Sheriff's Department and Fund with future Bond Issues

WHEREAS, the current Computer-Aided Dispatch (CAD) system and Records Management System (RMS) have each reached the end of their useful lives and need to be replaced; and

WHEREAS, the current systems will no longer be supported after 2018; and

WHEREAS, a project to upgrade the systems is necessary to ensure continued functionality for serving all law enforcement and fire agencies within Winnebago County; and

WHEREAS, FoxComm, an entity formed to allow multiple counties to share the same systems, is in the process of dissolving; and

WHEREAS, each county will now be responsible for providing these vital services to the residents of Winnebago County; and

WHEREAS, the RMS is necessary to create, track, and maintain law and inmate records for all of the law enforcement agencies within Winnebago County.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby appropriates \$2,252,250 to a capital project to replace the Computer-Aided Dispatch (CAD) system and Records Management System (RMS) for the Winnebago County Sheriff's Department.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that funds to start up the capital project will be advanced from the General Fund with said fund being reimbursed through subsequent bond issues.

RESOLUTION NO. 171-72017: Authorize the Public Health Department to Accept Grant Funds from Five Separate Grand Programs, Totaling \$166,162, and Appropriate the Funds to Program Expenses

WHEREAS, the Winnebago County Public Health Department received grant funds from five separate grant programs to include the following: Refugee Grant, Alliance Wisconsin Youth Grant, Tobacco Grant, Hospital Grant, and Preparedness Grant; and

WHEREAS, the Refugee Grant and Tobacco Grant are contract adjustments that allow the Public Health Department to provide additional services; and

WHEREAS, the Preparedness Grant provides additional funding for training and travel to specified events; and

WHEREAS, the Hospital Grant is a pass-through grant for which Winnebago County is the fiscal agent. The Health Care Coalition is the agency that manages the Program, which gives approval to various hospitals and other health care providers to purchase emergency preparedness equipment, and which is then reimbursed through the Hospital Grant; and

WHEREAS, the Alliance for Wisconsin Youth Grant is a grant for the purpose of engaging youth in community change strategies related to substance abuse; and

WHEREAS, funds from each of these grants exceed the totals included in the 2017 Budget, and at the time the 2017 Budget was prepared, the amounts of these funds were estimated as the amounts were unknown; and

WHEREAS, accepting the additional funding and applying the funds to Program expenses would be beneficial to the residents of Winnebago County.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Winnebago County Public Health Department to accept additional grant funding totaling \$166,162 and appropriate the funds to Program expenses in order to meet the Grant Programs' objectives as outlined in the attached Public Health Grants Adjustment, incorporated herein by reference and made a part of this Resolution.

RESOLUTION NO. 172-72017: Authorize the Purchase of a New Passenger Car for the Public Health Department and Appropriate \$23,500 from the Public Health Department Fund Balance to Pay for the Vehicle.

WHEREAS, the Winnebago County Public Health Department currently controls three vehicles consisting of two vans and one passenger car; and

WHEREAS, the Department's travel demands have increased substantially over the years due to memberships in various coalitions, partnerships, training programs, food inspection sites, and client visits; and

WHEREAS, the Department is requesting to add a second passenger car to its vehicle fleet to reduce mileage reimbursement costs; and

WHEREAS, from 2014 through 2016, the Department's cost for mileage reimbursements to employees averaged \$20,500 per year; and

WHEREAS, adding a second passenger car will reduce the annual mileage reimbursements by approximately \$6,600; and

WHEREAS, when comparing the cost of mileage reimbursements versus owning a vehicle, the breakeven point (where the cumulative cost of ownership is less than then paying mileage) will be between the 4th and 5th year of vehicle ownership; and

WHEREAS, it would be prudent to purchase another passenger car for the Public Health Department. NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the purchase of a passenger car for the Winnebago County Public Health Department at a cost not to exceed \$23,500, with funds for the purchase to be transferred from the Department's Fund Balance Account.

Notice is hereby given that the Carol Marwede Trust dated October 18, 2002 and Carol Marwede (herein "Marwede") have a claim for \$569,000 plus interest against Winnebago County for an economic remnant of land as defined in Wis. Stata. § 32.05(3m) which has now been determined to be landlocked and inaccessible. The amount of this claim is based upon the value of this property if it had feasible access to County Highway CB. Such access no longer exists and cannot be obtained.

The details set forth below have been the subject of ongoing discussions on behalf of Marwede with County Corporation Counsel John Bodnar and County Executive Mark Harris in an effort to find mutually agreeable resolutions to the issues set forth in this claim, through both correspondence and personal meetings. Marwede remains open to continuing such discussions.

Carol Marwede, who is 83 years old, is the sole trustee and beneficiary of this Trust which she established for estate planning purposes.

The circumstances for this claim are that tax parcel #121-0521 (f/k/a 008-0521) consisting of 26.14 acres was created when the Marwede farmland was completely severed by the north/south route of highway right-of-way taken by Winnebago County to construct County Highway CB in the Town of Menasha, now known as Village of Fox Crossing.

The County has assessed this parcel of land for varying amounts over the past several years as high as \$892,000, then at \$539,000, and most recently at \$433,000. The lower amounts of assessment were made only after Marwede representatives complained to the County that until the access issue could be resolved the property was no longer worth full value.

Since Highway CB was constructed Marwede has depleted her savings by paying a total of approximately \$109,000 in real estate taxes for this parcel alone. Now she needs to sell the property because she needs money, it has been determined for the reasons below that no access exists and no reasonable access is obtainable.

Marwede has listed the property for sale with two separate local real estate brokers for as much as \$720,000, all based upon her reliance on the representations made to her in writing by Moss & Associates at the time of the land acquisition for construction of Highway CB, that the property had ingress egress access pursuant to an existing culvert entry way located on neighboring property to the north onto County Highway CB.

Winnebago County did not pay any money to Marwede for this severed parcel of landlocked property, also on the County's reliance on the representations of Moss & Associates

and corresponding belief that the Marwede property had access to the newly constructed Highway CB on the existing culvert access used by ANR Pipeline.

At the time of the taking the real estate acquisition "Consultant/Negotiator" for Winnebago County Highway Commission (Moss & Associates) representing Winnebago County declared in writing to Marwede that her property had direct access to Highway CB from a culvert entrance to a road which was later determined to be a private road, not a public road, currently owned and used by ANR Pipeline Company (herein "ANR Pipeline"), which is based in Houston, Texas. Both Marwede and the County, in reliance on that representation from the County's eminent domain land acquisition agent, Moss & Associates, moved forward under the good faith belief, based upon inaccurate information provided by Moss & Associates, that the property could be accessed from County Highway CB using this culvert entrance.

After considerable investigation and effort it has now been determined that the property is landlocked after taking into account the following factors:

- 1. <u>No Culvert Access</u>. The culvert access is not located on Marwede property and does not touch Marwede property. There is not now and never was any culvert access to this severed parcel of property after CB was constructed.
- 2. No Right to Use Private Road. ANR Pipeline has allowed Marwede to use this road permissively, but will not grant an easement to use this road to any successors or assigns of Marwede with one exception. ANR Pipeline would grant an easement to Winnebago County to use the private road and access this road from the culvert entrance at CB for County dog park purposes only, but for no other purpose and to no other party.
- 3. <u>County No Interest for Dog Park Use</u>. One County official expressed initial interest in the Marwede property for a County dog park, but more recently the County has shifted its focus to use property owned by Glatfelter for a dog park, the current status of which is believed to still be pending.
- 4. Landlocked Boundaries. The Marwede property is bonded on the east and the north by County Highway CB right-of-way and on the west by property owned by ANR Pipeline, and on the south by an existing operating railroad line.
- 5. <u>Sale Efforts</u>. Marwede retained a licensed real estate broker and listed the property for sale, but no buyers could be obtained when upon investigation these buyers learned the property was landlocked and had no access to County Highway CB
- 6. <u>New Access Points Not Feasible</u>. Marwede has explored the possibility of installing a new driveway from the Marwede property onto County Highway CB.
 - a) <u>No Driveway in Wetlands</u>. The northern portion of the Marwede property has been delineated as "wetlands" subsequent to the construction of Highway CB which was the result of storm water runoff and inadequate drainage of the

Marwede property due to the construction of County Highway CB. This wetlands condition prohibits construction of an access point at the northern end of the parcel in addition to other reasons.

- b) **Location of Existing ANR Culvert**. The existing culvert access to the ANR Pipeline property would be too close to any proposed access point on CB on the northern end of the property due to safety issues even if the wetlands do not exist.
- c) <u>Current ANR Culvert Does Not Abut Marwede Property</u>. Marwede cannot attach a separate driveway to the current culvert right-of-way entry used by ANR because Marwede's property does not extend far enough northward to abut this right-of-way access point. This obstacle is in addition to the wetlands and safety obstacles.
- d) <u>Safety Concerns in Southern Non-Wetland Area</u>. At the southwestern corner of the Marwede property Highway CB is constructed as an overpass of the Wisconsin Central Railroad at an elevation too high for a practical culvert/driveway access. Any such driveway would have a very steep grade onto the County Highway creating a dangerous condition. In addition to the elevation problem Highway CB is a curved design along the Marwede property western border further contributing to safety concerns.
- e) <u>County Highway Commissioner</u>. The site was visited by the former County Highway Commissioner and Corporation Counsel with Marwede's son, Mark Marwede, and at that time of that meeting visual observations confirmed the elevation, curve, wetlands locations, and safety concerns.
- f) <u>Consultation with Davel Engineering</u>. Marwede hired Davel Engineering to evaluate the feasibility of constructing a driveway along the southwestern boundary onto CB. Davel Engineering confirmed the safety, grade, and elevation concerns referenced above.
- 7. <u>Consultation with Village of Fox Crossing</u>. John Bodner and Marwede's legal counsel consulted with Village of Fox Crossing through its Community Development Director, George Dearborn, to see if there was any possible future development plan in this area that would create public road access to the Marwede property. No such plans exist or are any forecasted in the future.
- 8. <u>Neighboring Property Owners as Potential Buyers</u>. Marwede with the assistance of a real estate broker solicited the possible sale of this property to neighboring property owners, and in particular to Kimberly Clark as recently as April 2017, but no abutting property owners are interested in buying this property from Marwede under any circumstances.
- 9. <u>Marwede Has Now Exhausted All Efforts to Avoid Uneconomic Remnant Status</u>. Marwede with the assistance of a licensed real estate broker and attorney have

worked with County Corporation Counsel and have met with the County Executive, the former Winnebago County Highway Commissioner, a private consulting civil engineering firm, and have also consulted with the Public Works Director for the Village of Fox Crossing to explore every feasible alternative to avoid this property being classified as an uneconomic landlocked remnant, all without success, leaving no alternative but to seek payment from Winnebago County.

Marwede is entitled to payment for this landlocked parcel from the County being that it constitutes an uneconomic remnant resulting from the eminent domain proceedings undertaken for the construction of County Highway CB, combined with the misinformation provided by Moss & Associates to Marwede that Marwede had access to County CB from the culvert access immediately north of the Marwede property.

Marwede desires to avoid any further litigation to the maximum extent possible and respectfully requests that the County of Winnebago take such appropriate measures as may be necessary to pay Marwede for this property as an uneconomic remnant and to avoid litigation over this matter.

On behalf of Marwede we thank Winnebago County for giving this claim its most serious attention at the earliest possible convenience.

Direct That Funding Used to Operate the Winnebago County Navigational RESOLUTION: 2 Aids Program be Derived from Revenues Obtained from the Winnebago 3 4 **County Boat Trailer Parking Fee Program** 5

TO THE WINNEBAGO COUNTY BOARD OF SUPERVISORS: 7

- 8 WHEREAS, the Winnebago County Parks Department is responsible for Winnebago County's Navigation 9 Aids Program involving the installation, removal, and maintenance of over one hundred and twenty-three (123) 10 lighted and unlighted buoys within the Winnebago County lakes system .; and
- 11 WHEREAS, the purpose of the Navigational Aids Program is to assist boaters in reaching their destination: 12 and
- 13 WHEREAS, since the inception of the Navigational Aids Program in 1988, costs associated with operating 14 the program have been derived through the tax levy; and
- 15 WHEREAS, Winnebago County has arrived at a point in the program where a sizeable portion of the buoy 16 inventory is beginning to need refurbishing and upgrades including replacement of stainless steel rigging, repair,
- 17 painting, remarking the buoy shells, and the re-outfitting of analog bulb lanterns with digital LED fixtures; and
- 18 WHEREAS, Winnebago County's buoy inventory is in large part comprised of both nun and can buoys each 19 costing up to \$5,000 to replace; and
- 20 WHEREAS, it has been determined that the most cost-effective manner in which to address the need for 21 maintaining the buoy inventory would be to implement a phased approach whereby up to ten buoys per year are 22 selected for renovation at an average cost of \$2,000 per unit; and
- 23 WHEREAS, Winnebago County has in place a Boat Trailer Parking Fee Permit Program in which revenues 24 are collected from individuals who access the Winnebago County lakes system using any one of the County's seven 25 boat landing facilities; and
- 26 WHEREAS, funds collected through the Boat Trailer Parking Fee Permit Program are regularly applied 27 towards the maintenance and improvements performed at Winnebago County's boat landing sites; and
- 28 WHEREAS, a majority of Winnebago County' buoy inventory is dedicated towards providing boaters with a 29 means for safe access into and out of boat landings located throughout the Winnebago lakes system; and
- 30 WHEREAS, Wisconsin NR1.91(11) BOAT LAUNCHING FEES allows for launch fees to be charged for the 31 purpose of operating and maintaining facilities that directly support boating activities and that also rely on the use of 32 buoys to aid in accessing such sites; and
- 33 WHEREAS, your Park and Recreation Committee has determined that because Winnebago County's 34 Navigation Aids Program in large part exists for the purpose of enabling boaters to safely access facilities that 35 directly support boating activities, and Wisconsin NR 1.91(11) does all for buoys to be included as an allowable 36 expense for which boat launch fees can be applied towards, it would be appropriate for the funding required to 37 operate Winnebago County's Navigation Aids Program to be derived from revenues collected from the County's Boat 38 Trailer Parking Fee Permit Program.






