WINNEBAGO COUNTY BOARD MEETING TUESDAY, JANUARY 22, 2013

Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Locke.

Supervisor Eisen brought the error on Page 99 of the Board's December 18, 2012 proceedings ("Mr. Knigge" is changed to "Mrs. Knigge") to the attention of the County Clerk for correction. The correction will be made.

REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Norton encouraged Board members to contact their legislators and express their opposition to pending legislation that would reduce the Milwaukee County Board of Supervisors to part-time status and reduce set limits on their County Board's budget.

Supervisor Norton announced that because of past problems with Logisticare, the ADRC Committee has gone on record and sent letters to the state demanding that they not use Logisticare for their non-medical emergency transportation needs.

Supervisor Norton asked that the Board be given information on what the impact would be on county government if there was a federal government shutdown?

Supervisor Barker distributed information on the county's 2013 Scholarship Program. Additional copies of the brochure are available at the UW-Extension or County Clerk's Offices. It is also available on-line at the county's website.

Supervisor Kline reported that the Legislative Committee will be meeting on Monday, January 28, 2013. Supervisor Wingren reported on his attendance at the active-shooter training session at the courthouse

yesterday. It was very informative and showed that there are special situations in this building that need to be addressed and corrected.

Motion by Supervisor Robl and seconded to approve the proceedings from the December 18, 2012 Winnebago County Board meeting, as corrected earlier in the meeting. CARRIED VOICE VOTE.

COUNTY EXECUTIVE'S REPORT

Executive Harris commented on the legislation that is being discussed in Madison regarding reducing the budgets of County Boards to .25% of levy in county's with a population of more than 500,000. At this point, it would only affect Milwaukee County.

Executive Harris explained his position on the Resolution No. 151-12013, "Authorize Divestiture of the Tricounty Ice Arena." He stated that he understands the importance of all the people and organizations that are involved with the Ice Arena. Executive Harris stated that, the county also plays an important role in the ice arena by making sure that whoever manages the ice arena has "sufficient assets" to keep it operating and maintained properly.

Executive Harris stated that the county needs to continue to be a partner with the ice arena. This partnership is needed because of the probability that in the future the ice arena will incur an unexpected or large expense and they will need the county's assistance. Executive Harris said that without the county's assistance, this unexpected or large expense could force the facility to close.

Executive Harris stated that there are some problems with Resolution No. 151-12013. One issue is that the county does not have a current offer for the ice arena from the Fox Valley Youth Hockey Association, because it expired on December 31, 2012. The other issue is that the Tri-County Recreation Association has the right of first refusal, which may keep them Fox Valley Youth Hockey Association from making another offer.

Executive Harris explained that the county owns the land and the buildings, but it does not own the facility's equipment. The Tri-County Recreation Association owns the equipment. Whoever buys the building and land from the county will still need to buy or lease equipment to run the ice arena.

Winnebago County offers various recreational opportunities for its citizens, but very few in the north end of the county. The ice arena is one of these few recreational facilities in the northern end of Winnebago County and Executive Harris doesn't think the county should act to quickly to sell it

COUNTY BOARD CHAIRMAN'S REPORT

Chairman Albrecht reported that Supervisors Finch, Snider and Hegg are excused from tonight's meeting. Chairman Albrecht welcomed Supervisor Sievert back after her extended absence.

UW Education, Extension & Agriculture Committee

Supervisor Snider will replace Supervisor Englebert who has accepted an appointment to the Aviation Committee. Motion by Supervisor Robl and seconded to approve. CARRIED BY VOICE VOTE.

PRESENTATIONS BY ROBERT STONE, WINNEBAGO COUNTY VETERANS SERVICE OFFICER

Dr. Susan Iwanski

Robert Stone, Winnebago County Veterans Service Officer, introduced Dr. Susan Iwanski, an Audiologist who works very closely with the Veterans Services Department and the veterans they serve. Dr. Iwanski provides expert medical testimony for area veterans applying for benefits.

Mr. Stone presented Dr. Iwanski with an American flag that was flown over the courthouse, a certificate and a plaque thanking her for the service she provides to the county's veterans' community.

The Board recognized Dr. Iwanski with a round of applause. Dr. Iwanski stated what an honor it is to be able to serve the veterans that have served our country.

PFC Donald D. Kieper

Mr. Stone and Supervisor Paul Eisen introduced PFC Donald Kieper to the Board. Mr. Stone described Mr. Kieper's military career and the previous honors he received for his service in the U.S. Army.

Mr. Stone and Supervisor Eisen then presented Mr. Kieper with a Bronze Star medal. Mr. Kieper was recognized by the Board, the public and members of his family with a standing ovation.

Mr. Stone presented Mr. Kieper with an American flag that was flown over the courthouse and a certificate thanking him for his military service.

WITTMAN REGIONAL AIRPORT REPORT

Peter Moll, Wittman Regional Airport Director, and Chris Hallstrand, Airport Operations and Maintenance Manager, presented the Board with information on the Oshkosh® H-Series Blower that they hope to purchase in 2013.

Mr. Moll explained that the airport's current 1990 Wausau/Schmidt Blower has had significant mechanical problems over the last few years. And because of its age, it's also becoming difficult to find parts to make repairs. Mr. Moll explained how important this type of equipment is to the airport and the how difficult it is when the blower is down for repairs in the winter.

Mr. Moll explained that they are looking to purchase the Oshkosh® H-Series Blower from Bruce Equipment, Inc. He explained that because Bruce Equipment, Inc. has sold this same piece of equipment to Dane and Milwaukee Counties and has made a verbal agreement to sell it to Winnebago County for the same price, the county does not need to take bids for this piece of equipment. This provision is part of the county's Competitive Purchasing Requirements.

The estimated cost for this blower is \$708,278. The money will come from the airport's reserve funds, so the county will not be borrowing for this piece of equipment. There is no trade-in value for the old 1990 Wausau/Schmidt Blower.

Mr. Moll and Mr. Hallstrand then took questions from the Board.

ORDINANCE NO. 141-12013: Create Section 3.15 of the General Code for Winnebago County: Disposal of Unclaimed Bodies

WHEREAS, Winnebago County has not officially established a policy regarding the disposition of unclaimed bodies; and

WHEREAS, the Winnebago County Coroner has identified a need for such a policy to be established by Ordinance; and

WHEREAS, § 979.09, Wis Stats, provides the county with the authority to establish such a policy.

NOW, THEREFORE, BE IT ORDAINED by the Winnebago County Board of Supervisors that Section 3.15 of the General Code for Winnebago County: Disposal of Unclaimed Bodies, be created to read as follows:.

3.15 DISPOSAL OF UNCLAIMED BODIES

- (1) AUTHORITY: This Ordinance is created pursuant to that authority provided under § 979.09, Wis Stats.
- (2) DISPOSAL BY CREMATION:
- (a) The Winnebago County Coroner shall cause the body of an unknown or unclaimed deceased person to be cremated upon his written authorization. Cremation of an unknown or unclaimed body shall occur no earlier than seven (7) days subsequent to the pronounced date of death of the deceased person.
 - (3) COSTS:
- (a) The Winnebago County Coroner shall request the assistance of the Winnebago County Department of Human Services to determine the Medical Assistance eligibility of the deceased. Should the deceased individual be eligible for Medical Assistance, any Medical Assistance payments made on behalf of the deceased shall be used to offset cremation costs of the deceased individual's unclaimed body.
- (b) Family members of deceased individuals who refuse to claim the deceased individual's body shall not have any input into the decision regarding the means of disposition of the unclaimed body. Winnebago County shall have no obligation to pay for visitation or other funeral arrangements relating to any deceased individual whose body remains unclaimed.
- (c) Cremation costs shall not exceed \$900 unless otherwise authorized by the Personnel and Finance Committee of the Winnebago County Board of Supervisors.
- (d) The Winnebago County Coroner, within his discretion, may dispose of an unclaimed body by burial or by other means when it is in the interests of law enforcement or Winnebago County.
- (e) Nothing contained within this Ordinance shall prevent the Winnebago County Coroner or Winnebago County from filing a claim against the estate of the deceased, or using other legal means, to recover the costs of disposition of the deceased individual should it appear that assets are available within the estate of the deceased individual or otherwise to cover said disposition costs.
 - (4) EFFECTIVE DATE: This Ordinance shall take effect upon the date following the date of publication.

WHEREAS, Wisconsin's practice of replacing the dollars transferred from the State's segregated transportation fund with general obligation bonds place the State in the position of bonding to fund ongoing operations; and

WHEREAS, the debt service for these bonds is being paid for out of the State's general fund which hinders its ability to fund other programs like Shared Revenue, Youth Aids, Community Aids, and the operation of the court system in the future; and

WHEREAS, Winnebago County placed an advisory referendum on the November 2010 ballot asking, "Should the Wisconsin Constitution be amended to prohibit any further transfers or lapses from the segregated transportation fund?" and over 70% of Winnebago County's residence voted in favor of such a proposed Constitutional amendment; and

WHEREAS, 53 other counties in the State of Wisconsin also asked the same advisory referendum question with the support for such question being similar throughout other counties; and

WHEREAS, first consideration of this Constitutional amendment passed the Wisconsin State Legislature overwhelmingly last session on a bi-partisan basis; and

WHEREAS, the 2012-2013 session of the Wisconsin State Legislature has the opportunity to pass a second consideration of this Constitutional amendment and in doing so will give the citizens of the entire State of Wisconsin the opportunity to vote for amending the State Constitution to ensure transportation revenues are spent for transportation purposes; and

WHEREAS, passage of such an amendment will align ourselves with the states of Minnesota, Iowa, and Michigan in protecting the purpose for transportation user fees.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby strongly urges our State representatives to vote in favor of a second consideration of the joint resolution to protect the transportation fund, thereby giving voters across the State the opportunity to vote on a binding referendum to amend the Constitution and ensure the transportation user fees they pay will be spent for transportation purposes.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that a copy of this Resolution be transmitted to all legislators representing Winnebago County constituents in the State Legislature.
