**RESOLUTION NO. 94-102014: Adopt Revisions to Winnebago County Pay Schedules and Provide Pay Increases for 2015**

WHEREAS, it is in the best interests of Winnebago County that the salaries of all employees be adjusted periodically; and

WHEREAS, the County has considered the effects of inflation upon salaries, changes in the labor markets, the need to attract and retain qualified employees, and the desirability of treating various groups of employees equally; and

WHEREAS, since step increases are no longer in place for most County employees, it is desirable to recognize good service to the County by providing some additional pay increase to those employees who are lower in their pay ranges, thereby allowing an employee's pay to gradually move upward in the pay range as the employee's tenure with the County increases; and

WHEREAS, the undersigned Committee recommends the adjustments set forth below to the County's pay schedule, taking into account those reasons set forth above as well as a desire to restrain increases in the County budget and to act in a fiscally prudent manner; and

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the pay schedules for Administrative Employees, Courthouse Employees, Human Services Employees, Park View Health Center Employees, Highway Employees, Bridgetenders, and Professional Dispatchers to be amended by increasing the minimum and maximum pay for each range by 1.5%, across-the-board, effective January 1, 2015.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes an increase in wages for Administrative Employees, Courthouse Employees, Human Services Employees, Park View Health Center Employees, Highway Employees, Bridgetenders, and Professional Dispatchers having continuing satisfactory job performance by 1.5%, across-the-board, effective January 1, 2015.

BE IF FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes an additional increase in wages for any employee covered by the pay schedules for Courthouse Employees, Human Services Employees, Administrative Employees, Park View Health Center Employees, Highway Employees, Bridgetenders, and Professional Dispatchers having continuing satisfactory job performance and whose pay has not yet reached the maximum point of the applicable pay range, in the following amounts: 2.0% for those in the first quartile of the pay range; 1.5% for those in the second quartile of the pay range; 1.0% for those in the third quartile of the pay range; and 0.5% for those in the fourth quartile of the pay range.

WHEREAS, it is in the best interests of Winnebago County that the salaries of all employees be adjusted periodically; and

WHEREAS, the County has considered the effects of inflation upon salaries, changes in the labor markets, the need to attract and retain qualified employees, and the desirability of treating various groups of employees equally; and

~~WHEREAS, since stop increases are no longer in place for most County employees, it is desirable to recognize good service to the County by providing some additional pay increase to those employees who are lower in their pay ranges, thereby allowing an employee's pay to gradually move upward in the pay range as the employee's tenure with the County increases; and~~

WHEREAS, the undersigned Committee recommends the adjustments set forth below to the County's pay schedule, taking into account those reasons set forth above as well as a desire to restrain increases in the County budget and to act in a fiscally prudent manner; and

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the pay schedules for Administrative Employees, Courthouse Employees, Human Services Employees, Park View Health Center Employees, Highway Employees, Bridgetenders, and Professional Dispatchers to be amended by increasing the minimum and maximum pay for each range by 1.5%, across-the-board, effective January 1, 2015.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes an increase in wages for Administrative Employees, Courthouse Employees, Human Services Employees, Park View Health Center Employees, Highway Employees, Bridgetenders, and Professional Dispatchers having continuing satisfactory job performance by 1.5%, across-the-board, effective January 1, 2015.

~~BE IF FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes an additional increase in wages for any employee covered by the pay schedules for Courthouse Employees, Human Services Employees, Administrative Employees, Park View Health Center Employees, Highway Employees, Bridgetenders, and Professional Dispatchers having continuing satisfactory job performance and whose pay has not yet reached the maximum point of the applicable pay range, in the following amounts: 2.0% for those in the first quartile of the pay range; 1.5% for those in the second quartile of the pay range; 1.0% for those in the third quartile of the pay range; and 0.5% for those in the fourth quartile of the pay range.~~

BE IF FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby directs the Winnebago County Executive and the Winnebago County Human Resources Director to develop a proposed merit pay plan for Winnebago County's non-represented employees and to present such proposed plan to the Winnebago County Board's Personnel and Finance Committee within a suitable time period so as to allow such plan to be reviewed and adopted prior to the preparation of the 2016 budget.

Vote on Supervisor Thompson's motion to divide the question: Ayes: 21. Nays: 13 – Barker, Eisen, Kiel, Roh, Albrecht, Olson, Brewer, Wingren, Singstock, Neubauer, Hegg, Rasmussen and Kriescher. Absent: 2 – Ramos and Hardy. CARRIED.

Motion by Supervisor Hegg and seconded to vote on the second question—develop a merit pay plan—before the first question—1.5% across-the-board pay increase. CARRIED BY VOICE VOTE.

Supervisor Keller asked if he could make a motion to bring back the quartile portion of the original Resolution No. 94-102014. Corporation Counsel Bodnar stated that it will be up to the County Board Chairman to determine if such a motion would be in order.

Chairman Albrecht called for the vote on the second question—develop a merit pay plan—in Proposed Amended Resolution No. 94-102014: Ayes: 27. Nays: 7 – Eisen, Thompson, Lautenschlager, Norton, Warnke, Farrey and Keller. Absent: 2 – Ramos and Hardy. CARRIED.

Motion by Supervisor Keller to amend this portion of the Resolution. No second to Supervisor Keller's motion.

Chairman Albrecht stated that he would not accept Supervisor Keller's motion to amend. Motion by Supervisor Schellenger and seconded to appeal the Chairman's decision. Chairman Albrecht called for a vote on Supervisor Schellenger's motion to appeal his decision. Supervisor Wingren appealed to Corporation Counsel Bodnar as to the legality of voting on Supervisor Schellenger's motion when a vote on Supervisor Keller's motion is in progress. Corporation Counsel Bodnar stated that it was up to the County Board Chairman to decide this issue. Chairman Albrecht decided that the clerk should stop and clear the vote on Supervisor Keller's motion so that a vote can be taken on Supervisor Schellenger's motion to challenge the Chairman's decision. Supervisor Schellenger withdrew his motion since the Chairman is going to allow Supervisor Keller's motion to amend.

Motion by Supervisor Keller and seconded to include Lines 28 through 35 (quartile raises) from the original Resolution No. 94-102014 in the first question of the approved Proposed Amended Resolution No. 94-102014, which is the 1.5% across-the-board pay increase.

Supervisor Eisen called for a point of order and stated that he felt Supervisor Keller's motion is out of order because the Board already eliminated Lines 28 through 35 from the resolution when they accepted Proposed Amended Resolution No. 94-102014 earlier in the evening. Corporation Counsel Bodnar agreed that Supervisor Keller's motion is out of order, but it's up to Chairman Albrecht to decide if the motion is out of order. Chairman Albrecht determined that Supervisor Keller's motion is out of order.

Chairman Albrecht called for the vote on first question—1.5% across-the-board pay increase—in Proposed Amended Resolution No. 94-102014. Ayes: 30. Nays: 3 – Harpt, Neubauer and Farrey. Abstain: 1 – Turner. Excused: 2 – Ramos and Hardy. CARRIED.

At 7:24 p.m., Chairman Albrecht called for a brief recess. The Board reconvened at 7:36 p.m.

Executive Mark Harris began his presentation of the 2014 budget.

Motion by Supervisor Finch and seconded to adjourn until 8:30 a.m. tomorrow, Tuesday, October 28, 2014. Ayes: 19. Nays: 15 – Konetzke, Barker, Eisen, Kiel, Roh, Widener, Hamblin, Schellenger, Brewer, Wingren, Turner, Hegg, Rasmussen, Keller and Snider. Absent: 2 – Ramos and Hardy.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Locke.

### **PUBLIC HEARING**

No one addressed the Board.

Executive Harris concluded his presentation of the 2015 budget.

At 8:51 a.m., a motion was made by Supervisor Keller and seconded to reconsider Resolution 94-102014, specifically Lines 1 – 26.

Supervisor Hegg asked the Chairman if Supervisor Keller's motion was out of order. After discussion, it was determined that because Supervisor Keller did not vote on the prevailing side when the vote was taken to substitute Proposed Amended Resolution 94-102014 for the original Resolution No. 94-102014, his motion to reconsider is out of order.

Motion by Supervisor Keller and seconded to reconsider the 1.5% increase portion of Proposed Amended Resolution No. 94-102014 that was approved by the Board on October 27.

Supervisor Hegg then questioned whether Supervisor Keller's motion to reconsider can be made at this meeting based on Rule 12.7 of the Winnebago County Board of Supervisors, which indicates that a motion to reconsider can only, "be made and acted upon at the same or next succeeding adjourned (business) meeting..." After additional discussion, Chairman Albrecht ruled that voting on Supervisor Keller's motion to reconsider is appropriate.

Vote on Supervisor Keller's motion to reconsider – Ayes: 18. Nays: 9 – Konetzke, Roh, Smith, Albrecht, Gabert, Olson, Wingren, Hegg and Rasmussen. Abstain: 1 – Barker. Excused: 8 – Harpt, Kiel, Hamblin, Brewer, Hardy, Lautenschlager, Turner and Youngquist. CARRIED.

Motion by Supervisor Keller and seconded to amend Proposed Amended Resolution No. 94-102014, by adding back in to the resolution Lines 28-35 of the original Resolution No. 94-102014, which reads as follows: *BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes an additional increase in wages for any employee covered by the pay schedules for Courthouse Employees, Human Services Employees, Administrative Employees, Park View Health Center Employees, Highway Employees, Bridgetenders, and Professional Dispatchers having continuing satisfactory job performance and whose pay has not yet reached the maximum point of the applicable pay range, in the following amounts: 2.0% for those in the first quartile of the pay range; 1.5% for those in the second quartile of the pay range; 1.0% for those in the third quartile of the pay range; and 0/5% for those in the fourth quartile of the pay range.*

Motion by Supervisor Ramos and seconded to amend the increase to 2.25%. After discussion, Supervisor Eisen agreed to change his motion to a 2.25% across-the-board pay increase.

BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby amends the 2015 Winnebago County General Budget so as to delete \$339.855 from the Wage Accounts and \$49,109 from the Fringe Benefits Accounts for all Departments in the Winnebago County Budget. The difference in each department's budget shall be adjusted by the Finance Director working in conjunction with the Human Resources Director and shall be calculated as the differences between the proposed pay plan and adopted pay plan for 2015.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that the general tax levy will be reduced by \$350,846, which represents the total levy impact of these changes. The difference in totals is the result of non-levy departments such as Highway and Solid Waste.
