WHEREAS, § 59.35(1), Wis Stats, further states, "In case of a vacancy in the office of coroner, the chief deputy coroner shall in all things and with like liabilities and penalties execute the duties of the office until the vacancy is filled as provided by law"; and

WHEREAS, § 59.34(1)(b), Wis Stats, states, "The coroner shall. . .when there is no sheriff or undersheriff organized for judicial purposes, exercise all the powers and duties of sheriff until a sheriff is elected or appointed and qualified"; and

WHEREAS, the workload in the Coroner's Office justifies employment of a full-time Chief Deputy Coroner; and

WHEREAS, it would be beneficial for Winnebago County, with a population of 167,700, to employ a full-time Chief Deputy Coroner to be available to assume the duties and responsibilities of the Coroner.

BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby amends the 2014 Winnebago County General Budget so as to add \$30,000 to the Coroner's Office Budget to fund converting the part-time Deputy Coroner position to a full-time position, Account Number 51100, on Page 272 of the Winnebago County Budget.
