WINNEBAGO COUNTY BOARD MEETING TUESDAY, MAY 15, 2012

Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Lennon.

Excused: Hardy.

Motion by Supervisor Robl and seconded to adopt the agenda with the change of order of the resolutions so that No. 26-52012 is acted on before No. 15-52012. CARRIED BY VOICE VOTE.

PUBLIC HEARING

The following people spoke in opposition to Resolution No. 22-52012, "Authorize a Capital Project to Construct a Perimeter Road and Fencing Around Wittman Regional Airport at a Cost of \$5,750,000 to be Funded by Federal and State Airport Improvements Funds and Airport Fund Balance":

Rick Krumenauer, Battalion Chief, Oshkosh Fire Department, spoke in support of Resolution No. 22-52012, "Authorize a Capital Project to Construct a Perimeter Road and Fencing Around Wittman Regional Airport at a Cost of \$5,750,000 to be Funded by Federal and State Airport Improvements Funds and Airport Fund Balance".

Steve Obenauer, FAA's Manager of Airports District Office, Minneapolis, Minnesota, explained that his office oversees the State of Minnesota's and the State of Wisconsin's federally operated airports. He also stated that because of the size of the project proposed in Resolution No. 22-52012 and because it involves discretionary funding, the FAA is involved in the entire project.

COMMUNICATIONS, PETITIONS, ETC.

Petition for Zoning Amendment from Charles Nelson, for a zoning change for tax parcel no. 012-0086-02 from A-2 to M-1 for outside storage and maintenance of military, commercial and other vehicles was referred to the Planning & Zoning Committee.

REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Hegg congratulated Supervisor Eisen for being named Citizen of the Year in the Town of Menasha. Supervisor Hegg commended Supervisor Eisen for all his hard work and dedication on the County Board and was glad that the Town of Menasha recognized him. The Board recognized Supervisor Eisen with a round of applause.

Motion by Supervisor Robl and seconded to approve the County Board Proceedings from April 17, 2012 and April 24, 2012 meetings. Supervisor Konetzke asked that the, "Estimation of the Project would be \$5,000,000.00" be corrected to "\$5,750,000.00". CARRIED BY VOICE VOTE as corrected.

Supervisor Finch commenting on the April 24, 2012 Resolution No. 7-42012, stated that he feels that Supervisor Brennand had a conflict of interest with that resolution and should have abstained from voting on it.

COUNTY EXECUTIVE'S REPORT

Executive Harris reported on the Tri-County Ice Arena. He stated that it's actually a partnership between Outagamie and Winnebago Counties and another ice arena. Over the last few years, Outagamie County has not had any real involvement with the ice arena. Executive Harris stated that there are two things that may come up in regards to the ice arena:

- 1. Another group would like to be involved in the management of the ice arena.
- 2. Have Winnebago County take over Outagamie County's obligations for the ice arena.

Executive Harris explained that the current setup makes it difficult to operate and make improvements to the facility, so something needs to be done in the near future.

Executive Harris spoke to the Board about Workforce Development. He explained that Workforce Development involves a coalition of counties that is put together by and are under a contract recommended by the

State of Wisconsin. The state has divided the authority between a Workforce Development Board and the Local Elected Officials (LEO) Board. The LEO Board is made up the senior elected official of several counties. Executive Harris explained that the county continues to "struggle" in the Workforce Development area, because even though they use Department of Labor money to operate, the county could still end up being responsible. He stated that if Workforce Development ends up owing money to the Dept. of Labor in an amount that exceeds their assets, the county could potentially be liable. Executive Harris stated that they are currently trying to put together a new management team at Workforce Development. He just wanted to make sure that the Board is aware that there are still issues involving Workforce Development.

Executive Harris then spoke to the Board about Wittman Regional Airport and the resolutions that are on the Board's agenda for tonight's meeting. He pointed out that over the last ten years, Wittman Regional Airport only consumed \$3,194,000 of the county's levy. This is an extremely low amount. Executive Harris stated that the airport also produces a substantial amount of revenue for the county through hangar leases, take off/landing fees, etc.

Executive Harris explained that over the same time period, \$8.9 Million was spent at UW-Fox Valley. He stated that in both cases it's, "money well spent". He just wanted to make the point that the investment in the airport, "is relatively light of local tax dollars." Executive Harris stated that he believes Wittman Regional Airport adds value to the whole community and that there is the potential for a large number of jobs for county residents.

Executive Harris pointed out that the funding being offered by the state and federal governments for projects at the airport, comes from the sales tax on airline tickets purchased by the public. If the county doesn't use these funds, they won't be returned to the purchasers of those tickets or held in reserve, it will be given to another airport project in Wisconsin.

Executive Harris stated that the proposed perimeter road would reduce vehicle traffic on the runways and the fencing project would prevent various types of intrusion on the airport grounds. He further stated that although risks from either of these situations are probably low, it is still in the county's best interest to proceed with these projects now. Executive Harris said putting this project off could result in there being an accident at the airport that would jeopardize Winnebago County or that the county would be "compelled" to do the project with out any state or federal funding.

Executive Harris then spoke about Resolution No. 27-52012, "Adopt Revisions to the Winnebago County Administrative Salary Schedule." He stated that these employees had their step raises frozen in 2005, causing "compression" between the salaries of supervisors and their employees.

Executive Harris then took questions from the Board.

RESOLUTION NO. 27-52012: Adopt Revisions to the Winnebago County Administrative Salary Schedule

WHEREAS, the salaries of Winnebago County's non-represented employees have not kept pace with unionized employees of Winnebago County in recent years; and

WHEREAS, it is in the best interests of Winnebago County that the salaries of non-represented employees keep pace with that of unionized employees in order to attract and maintain qualified managerial and supervisory employees throughout Winnebago County departments.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes that the Winnebago County Administrative Salary Schedule be amended so as to increase the wages of covered employees having continuing satisfactory job performance by 1.0% across-the-board, effective January 1, 2013.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes that the Winnebago County Administrative Salary Schedule be amended so as to increase the wages of covered employees having continuing satisfactory job performances by an additional 1.5% (for a combined total increase of 2.5%) effective January 1, 2013, if any of the following apply:

- 1) Covered employees have not reached their control point as a salaried employee;
- 2) Covered employees have not reached the mid point in pay ranges H-1, H-2, H-3, H-4, H-5, H-6, H-7, and H-8;
- 3) Covered employees have not reached the mid point in Appendix A positions (Public Health, Park View Health Center, and Sheriff's Nursing positions);
- 4) Covered employees have not reached the mid point in Appendix B positions (craft employee positions);
- 5) Covered employees have not reached the mid point in Appendix C positions (Sheriff and District Attorney positions);
- 6) Covered employees have not reached the mid point in Appendix D positions (hourly employee positions).

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes that the Winnebago County Administrative Salary Schedule Appendix A (Rules for Administration) be amended so as to change Rule 5a to read as follows: "Weekend pay differential of \$1.00 per hour between the hours of 6:30 a.m. on Saturday and 6:30 a.m. on Monday."

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that said amendments to the Winnebago County Administrative Salary Schedule shall become effective as of January 1, 2013.

RESOLUTION NO. 28-52012: Request Sheriff to Read Declaration of Independence on Courthouse Steps on July 4, 2012

WHEREAS, the Continental Congress, by a Declaration of Independence, dated July 4, 1776, clearly declared the inhabitants of New Hampshire, Massachusetts, Rhode Island, Connecticut, New York, New Jersey, Pennsylvania, Delaware, Maryland, Virginia, North Carolina, South Carolina and Georgia, were no longer colonial subjects to be exploited arbitrarily by servants of the King and Parliament of Great Britain, but now were free citizens of their own territories, and that free citizens should constitute the governments for those territories; and

WHEREAS, the Continental Congress provided that same day, by orders of their House, that their Declaration should be proclaimed aloud and published to the free citizens of the territories represented in their Congress; and

WHEREAS, the notification of the Declaration to responsible citizens was then done by sheriffs who proclaimed it at the courthouse steps, by clergymen who read it from their pulpits, and by printers who printed it in their gazettes; and

WHEREAS, the Continental Congress thus initiated a process that has created the Constitutions and state governments of our Union including the Constitution and government of the State of Wisconsin.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby requests Sheriff John Matz to read the Declaration of Independence from the steps of the Courthouse at 8:00 a.m. on the morning of July 4, 2012, as this was the custom in the early history of our country.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that we ask Sheriff Matz to read the document without further comment or speech. This event is intended for those present to hear the words of the Declaration as we begin to celebrate our Day of Independence.
