**APPROVAL OF JUNE 24, 2013 MINUTES:** June 24 minutes were distributed and reviewed by members. Motion by Jayne Tebon to approve minutes. Second by Karen Nash. Motion carried with no opposition.

**MOTION FOR CLOSED SESSION:** Motion by Karen Nash to move the meeting into closed session. Second by Stacey Davis. Motion carried with no opposition.

**MOTION TO RECONVENE TO OPEN SESSION:** Motion by Stacey Davis to reconvene to open session. Second by Heidi Wheaton. Motion carried with no opposition.

**SUICIDE PREVENTION SUB-COMMITTEE:** Mary Jo Turner presented the new Winnebago County CDRT letterhead and Suicide Prevention Recommendations including the suggested changes from last month's meeting. The changes were made under Recommendation #5, suggestion: Explore best practice in dealing with teens with suicidal ideation.

A discussion regarding adding a 6<sup>th</sup> recommendation concerning healthy relationships and resiliency was had. The group agreed to add a recommendation promoting healthy relationships and resiliency in relationships.

The Healthy Lifestyles Group which is part of the Re:Th!nk coalition has agreed to work on suicide prevention.

A discussion concerning memorializing death by students in the school setting including t-shirts etc was had. It was decided that a sub-committee will form including Stacey Davis, Jenny Wesner and one of the staff from Winnebago County Dept of Human Resources Behavioral Health to make recommendations about this issue.

Jenny Wesner would also like consideration of having QPR training more often to students in the school setting.

Gun locks will be distributed at local community events. It was suggested to ensure there is someone at the event to demonstrate proper use of the locks.

Group feels that all children that die from suicide should have toxicology done. Cheryl Brehmer will discuss it with Barry Busby.
