- I. <u>Winnebago County IS Report:</u> Recently received a TraCS 10/ LRMS interface proposal from Motorola. This will move the information from TraCs 10 to LRMS.

The CAD map update process has been designed and tested at the county level. An update process should be ready for all agencies soon.

There will be an update of CAD software in the near future correcting the problem with disorganized TIME system responses and unit status for multiple unit calls. This update will groups and organize the TIME responses as well as allowing units to clear from calls without requiring a disposition when others are still on the call.

There is also a full CAD version upgrade scheduled for August/September.

Discsussion of over the air programming. We are getting set up. Baycom will do the programming with the Sheriff's department pushing it out.

Radios are up for warranty soon. Different departments are looking into service and maintenance agreements. The Sheriff will look into savings we may see with the participation of all our subscribers.

VII. Radio Infrastructure Committee:

- 1. Nearing end of project itself. Let Sheriff know if there are any issues. Exercise scheduled for September
- 2. The Sherrif looked into Smart 911 where information is entered into a database that populates medical information into dispatch when a 911 call is made. This service would only apply to a small percentage of our population.
- VIII. <u>Linda Kollman AlertSense:</u> MyStateUSA has changed to AlertSense. IPAWS was added. This sends information out to cell phones in alert situations. The IPAWS alerts currently need to be made out of Linda's office.

 AlertSense will go out to land lines and any cell phones entered into the system. IPAWS will not go to land lines; only cell phones.
