Agenda Item #5:

County Cell phone usage and reimbursement policy

- Francour had collected some information that was requested at the last meeting. We have 220 county issued cell phones, 48 are Blackberries, 22 percent are issued to Sheriff's Dept, 20 percent are human services. In 2012, employees who use county owned phones for personal use reimbursed the county \$505.75, but \$475 of that was all one person.
- Discussion took place regarding how the county verifies that county issued phones are used for work purposes.
- Personally owned phones used by county employees who requested reimbursement for work related calls amounted to \$425.79 in 2012.

• Taking out the Sheriff's Dept phones, the average monthly cell phone bill per employee is \$28.

Agenda Item #6:

Report on IS Operations since last meeting

- The Kronos upgrade is live for Parkview and the Sheriff's Dept. The biggest headache is programming the various timecard rules for union employees.
- The TCM rewrite for Human Services is in progress, data is being cleaned up. This replaces a system they used to pay for.
- The Public Health application PHAL (Public Health Activity Log) has been programmed and went live February 1. PHAL replaced the licensed product "champ", which will save the county money in maintenance costs.
- County owned fiber networks across the street from Oshkosh City Hall is on slack poles until November due to construction at the parking lot.
- The Systems Analyst position has been reopened for search.
- The new voting system for the County Board has been installed.
- IS Replaced the email archiving system and is currently porting the old data to the new appliance.
