1. Call to Order

7. Sheriff's Report

John Matz passed out the Sheriff's Office current budget with the concerns being in the labor category with unexpected situations that have occurred where extra deputies are needed for guard duty or overtime. Some of the overtime is caused by vacant positions as well.

John Matz discussed the WILEAG Accreditation outcome from their visit December 8, 9 and 10. The Sheriff's Office passed with a few issues that were corrected the same day. In January, the results will be voted on in front of the WILEAG board and in February it will be brought before the Winnebago County Board. The accreditation requires us to have up to date polices, standards and procedures.

John Matz touched on the City of Neenah incident from December 5th. Winnebago County was one of the SWAT teams involved in the incident and maintained the perimeters of the building.

John Matz touched on the Town of Algoma shooting. He told the committee that interviews are being conducted with the Department of Criminal Investigations at this time. We are not allowed to release any other information at this point.
