- Mike S (Neenah-Menasha Fire Rescue). Also stressed the very dangerous situation that rail transportation of chemicals posed for Winnebago County. The City of Neenah has an upcoming tabletop exercise that focuses on rail transportation of crude oil through the city.
- Bill D. (Highway) New initiatives are always good and that he has implemented several new ideas within the highway department.
- Barti O. (DNR) All contaminates have been removed from the Buckstaff Building.
- Emily M. (Oshkosh Community Media) The new "Storm Spotters" video will be on the website soon. Her office is in the process of updating all emergency procedures and the new "Bulletin Board" is ready to go.
- Bernie S. (EM) and Janell (Fox River Valley Ethanol) A tabletop exercise was held at Fox River Valley Ethanol on March 27th that focused on "confined space rescue".
 Bernie is also coordinating a tabletop exercise next month at Galloway Co., Neenah (involving the Neenah School District) that will test a Hazmat incident.
- Linda K. (EM) IPAWS (Integrated Public Alert and Warning System) has been approved by FEMA and now we are just waiting for training on the program.
