#### **APPROVAL OF MINUTES:**

Motion made by Wingren/Christopherson to approve meeting minutes from December 14, 2012. Motion passed unanimously.

## **STATUS REPORTS:**

### DRUG COURT:

A grant award letter to expand the program is pending. Funds will be used for a part-time employee.

There is a new State Program Director and we will begin sharing reports and statistics of our program with them.

April 3, 2013 there will be training in Appleton for the Wisconsin Association of Treatment Court Professionals. We will have some representatives attending.

### SSTOP:

Participant numbers distributed. Referrals are down.

### 24/7 PROGRAM:

Currently are running about 90+ participants on the program, 75+ on SCRAM and 15+ on PBT testing. Those testing via PBT test twice a day. We will be changing equipment at the end of the month, going to a PBT-type unit that will report back real time results instead of SCRAM. Participant costs will stay the same.

## **DOMESTIC VIOLENCE DIVERSION PROGRAM:**

Program is in a transition period, moving from a pre-charge program instead of post-sentence. They are about a year away from meaningful data as changes are just beginning.

# MISDEMEANOR DRUG DIVERSION PROGRAM:

They received another grant which takes place of one that ended in December 2012. Statistics distributed.

### JUVENILE TREATMENT COURT:

Currently there are six participants in the program. Exploring possible expunge/dismissal of charges when program is successfully completed.

# **STEP UP PROGRAM:**

About 12 kids are regularly participating and the program works on mentoring and investing time into them by Oshkosh police officers.
