APPROVAL OF AGENDA:

Agenda approved.

PUBLIC COMMENTS:

GinaMarie Opalescent, ESTHER, announced a Spring Gathering to celebrate 10 years of interfaith justice work in the Fox Valley area. Tuesday, April 29, 2014 at 7:00pm at the Fox Valley Unitarian Universalist Fellowship, 2600 E. Philip Lane, Appleton, WI.

APPROVAL OF MINUTES:

Minutes from meeting on December 13, 2013 approved.

STATUS REPORTS:

DRUG COURT:

Members of the Drug Court team will be participating in the annual training in April 2014 to be held in La Crosse, WI. A graduation is planned for June.

There are currently 34 participants with 11 in Phase I, 12 in Phase II and 11 in Phase III. There have been a total of 76 graduates, 20 terminations and 54 withdrawals from the program.

SSTOP:

Statistics regarding the program were distributed prior to the meeting and are attached. The committee agreed to meet with the legislative members to propose a modification to the current penalty structure for OWI-2nd offenses. The proposal is to remove the maximum penalty of 7 days jail for OWI-2nd for those participating in the SSTOP program as outlined in Wisconsin Statute sec. 346.65(2j)(bm). The modification could allow the SSTOP program to be offered to offenders that are currently not offered the program because of a high blood alcohol content.

24/7 PROGRAM:

There are currently 82 participants with approximately 63 on the soberlink monitor and 19 reporting for a PBT twice a day.

The program has been expanded to include drug offenses with monitoring done through UAs at the jail. The program is designed to handle up to 5 participants at a time. No one is in the program at this time.

DOMESTIC VIOLENCE DIVERSION PROGRAM:

No update available.

DRUG DIVERSION PROGRAM:

The grant program has been in place for approximately one year. The program was offered to approximately 215 people who met the criteria following a risk assessment done by the District Attorney's office. 123 people participated in the program with 7 people completing the program thus far and 15 people being revoked from the program.

Participants are allowed a payment plan for the program fee. The program requires an AODA assessment and follow-through of treatment recommendations. A participant will complete the program upon proof of completion of the recommended treatment and 6 consecutive months of "clean time".

"Judge Woldt indicated that upon review of the minutes, the DA's office has been promising to provide the Committee with the programs rules, guidelines and procedures for all of their diversion programs for close to two years. This was last promised to be provided at the December 2013 meeting. Judge Woldt asked when this will be provided. ADA Paider indicated that there was no reason why this could not be done at the next Safe Streets meeting in June."

STEP UP PROGRAM:

The program continues with Law Enforcement matched as mentors with members of the Boys and Girls Club. The participants will be involved in a Spring Clean-Up program in the community.


NEW BUSINESS:

1. Motion to add Jon Bellows, District Court Administrator, to the committee was made by Judge Woldt. The motioned was seconded and passed.
2. Some members of the committee attended the NIC EBDM conference in Madison at the end of January. Following that conference a decision was made to look into starting a diversion program for 1st offense ordinance violations. The goal of the program will be to educate those that qualify for the program about the implications/consequences of an ordinance violation including the effect of an entry in CCAP. Sheriff Matz is working with other law enforcement chiefs in the county develop a screening tool to be used to determine who is eligible for the program.
