- 1. Call to Order: P. O'Brien called the meeting to order at 9:01 a.m.
- 2. <u>Approve Agenda:</u> Motion to approve the November 18, 2015 agenda, made by K. Robl and seconded by J. Finch. Motion carried 6-0.
- 3. Public Comments on Agenda Items: None.
- 4. <u>Announcements/Communications:</u> J. Rabe explained to the Solid Waste Management Board (SWMB) that J. Semrau presented a Single Stream Recycling Update to the Winnebago County (WC) Board on Tuesday, November 17, 2015. SWMB members in attendance of the WC Board meeting indicated that the presentation was informative and went very well.
- 5. <u>Approval of Minutes November 4, 2015 Open Session:</u> Motion to approve the November 4, 2015 open session minutes, made by K. Robl and seconded by G. Konrad. Motion carried 6-0.

6. <u>Discussion/Action – Consider Resolution for Naming of Snell Road Conservation Park:</u> J. Rabe explained to the SWMB that he worked with J. Bodnar, WC Corporation Counsel to develop a Resolution for Naming of Snell Road Conservation Park (Resolution). J. Rabe distributed draft copies of the Resolution to SWMB members. The Resolution will be submitted to the WC Board requesting consideration to name the future Snell Road Conservation Park after Ken Robl, a life long conservationist with over 35 years of service on the WC Board and SWMB.

Discussion ensued amongst the SWMB.

Motion to accept the SWMB Resolution for Naming the future Snell Road Landfill Conservation Park, with discussed changes, made by J. Finch and seconded by G. Konrad. Motion carried 6-0.

- WPS/Highway Revenues were \$279,298 for October 2015. 2015 total revenues are estimated at \$3.0 Million (budgeted revenues are \$2.8 Million).
- Odor continues to be an issue at the Sunnyview Sludge Site; mitigation efforts also continue. Staff will provide a more detailed update at a future SWMB meeting.

P. Eisen stated that he and D. Nelson toured the Sunnyview Landfill Sludge Site and the future End Use Plan areas of the site with J. Rabe on November 4, 2015. P. Eisen stated that he was overall impressed by the tour and felt that it was very informative.
