- 1. Call to Order: P. O'Brien called the meeting to order at 9:00 a.m.
- 2. <u>Approve Agenda:</u> Motion to approve the November 20, 2013 agenda, made by K. Robl and seconded by J. Finch. Motion carried 8-0.
- 3. Public Comments on Agenda Items: None.
- 4. Announcement/Communications: None.
- 5. <u>Approval of Minutes November 6, 2013 Open and Closed Sessions:</u> Motion to approve the November 6, 2013 open and closed session minutes made by D. Nelson and seconded by G. Konrad. Motion carried 8-0.

- 6. <u>Discussion Container Program Report:</u> J. Semrau presented the Container Program Report to the Solid Waste Management Board (SWMB) as follows:
 - The container program progress report includes data from January October 2013.
 - Container rental activity (placements, finals, resets and relocates) increased in 2013 and has already surpassed total container rental activity in 2012.
 - Container revenue collected by transfer station staff and through invoicing has also increased in 2013, already surpassing the total container revenue collected in 2012.
 - Container Program customer surveys reveal an overall positive experience, competitive pricing, and growing use of the internet for container rental research.

Discussion ensued amongst the SWMB members.

7. <u>Discussion/Action – Landfill Gas Operations Update:</u> J. Rabe updated the SWMB on the landfill gas operations, WPS revenues, Air Permit and projects as follows:

- Operations Summary Problem with Engine #3 (camshaft issue noted in cylinder 1 when making valve adjustments); waiting on costs/advise from Inland on recommended repairs; at 30,000 hours so a rebuild may be the best option.
- WPS/Highway Revenues \$266,758 for October 2013 (Revenue estimate ~\$3 Million for 2013, depending on Engine #3 repairs).
- Air Permit Wisconsin Department of Natural Resources (WDNR) air inspection on October 17, 2013 and inspection report issued on October 29, 2013 recommended no action be taken for exceeding Formaldehyde emissions standards. A phone call from Randy Matty, WDNR Air Management Engineer, on November 11, 2013 indicated that contrary to his inspection report recommendation, a Notice of Violation would be issued for exceeding Formaldehyde emissions standards (same as what was issued to Dane County). J. Rabe is still waiting for the official document.
- Q4 SEM scheduled for December 2, 2013 through December 6, 2013.

• BACT Analysis – still not complete based on latest WDNR comments. WDNR has set the p-BACT applicability at less than \$0.08/kwh so this will not work for SWMB (rough calculation shows SWMB is closer to \$0.085/kwh). SWMB Staff will need to prepare a site specific BACT by January 17, 2014 per WDNR air inspection report (90 day deadline).

Discussion ensued amongst the SWMB members.

8. <u>Discussion/Action – Pollution Liability Insurance Options:</u> J. Rabe reported that he had further information on the Pollution Liability Insurance Options last discussed at the November 6, 2013 SWMB meeting. J. Rabe presented the summary of revised quotes to the SWMB as follows:

- J.Rabe stated that he discussed the status of the WDNR's PCB Indemnification with Stuart Herro, Dewitt Ross & Stevens. S. Herro reported that State-issued indemnification of this kind was not possible because the Attorney General's opinion is that it was prohibited by the Constitution.
- J. Rabe reported that the Willis Insurance Broker policy recommendation for the \$20MM/\$20MM limits, \$500,000 deductible and a 5-year term was Chubb based on price, higher rating/financial strength and a better track record for handling environmental claims.
- M. Easker suggested that the SWMB consider the \$20MM/\$20MM policy with a \$250,000 deductible (5-year term). The additional \$25,000 premium price would offer the SWMB a large deductible savings (\$250,000) if a claim is necessary.
- J.Rabe stated that if the SWMB wanted to consider this option, then ACE has the lowest policy cost \$20MM/\$20MM limits, \$500,000 deductible (5-year term) with a premium of \$200,335.

Discussion ensued amongst the SWMB members.

Motion to authorize the purchase of ACE Pollution Liability Insurance Policy with limits of \$20MM/\$20MM and \$250,000 deductible for a 5 year term made by K. Robl and seconded by M. Easker. Motion carried 8-0.
