Old Business: Joe Aulik, new CVSO, gave brief background and touched on office philosophy and goals.

New Business: Veteran Service Commission guidelines will be reviewed next month. Copy of Chapter 45 of the state statutes distributed. The duties of the VSC is pointed out in 45.81. The VSC is required to present an annual report to the County Board each year. This has never been done as far as anyone can remember. Several handouts comparing counties in Wisconsin per capita Compensation & Pension dollars were distributed. Winnebago County is currently behind the state & national average in Compensation and Pension which Joe will work to get to the top in this area just as he did in Kewaunee County. The office as a TEAM will be slowly be implementing processes to achieve this visionary goal. Possible change in data base which will allow electronically transmittal of claims. This will greatly help the Benefit Specialists process claims quicker. WDVA added more requirements for the CVSO Grant. We are the only local outreach & delivery system for state and federal veterans benefits. Joe briefly spoke on the Neenah Office

space and eventual consolidation due to space requirements needed by the county and improve efficiencies within the office. If a veteran could not make it to Oshkosh, there will still be an opportunity to meet with veterans for appointments in Neenah or home visits.
