# ADJOURNED SESSION COUNTY BOARD MEETING TUESDAY, MARCH 16, 1999

Chairman Joseph Maehl called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Wagner.

Motion by Supervisor Albrecht and seconded to approve the agenda. CARRIED BY UNANIMOUS VOICE VOTE.

Motion by Supervisor Lauson and seconded to approve the minutes of the February 23,1999 County Board meeting. CARRIED BY UNANIMOUS VOICE VOTE.

#### **COMMITTEE REPORTS**

Supervisor Lauson told the members of the Legislative Committee that an agenda for their March 22 meeting has been placed on their desks.

Supervisor Hue asked that when the time comes to debate the size of the County Board, that members keep in mind that regardless of the size, the same amount of work will need to be done. Supervisor Hue also stated that he would not be running for re-election to the Board next spring.

Supervisor Brennand asked that the Board look over the Wisconsin County Mutual Insurance Corporation 1998/1999 Guide for County Officials. He also stated that on May 14<sup>th</sup> their board will be meeting in Winnebago County and he encouraged the supervisors to attend.

#### COUNTY EXECUTIVE'S REPORT

County Executive Van De Hey presented the Certificate of Achievement for Excellence in Financial Reporting award to Chuck Orenstein, Finance Director. She explained that Mr. Orenstein is receiving this award because the budget he designed is not only accurate, but it's also easy to use and understand.

Executive Van De Hey reported that plans to organize and establish a Human Services Department are progressing. She complimented the County Board for providing to the Social Services Department, through the budgeting processing, money for technology and staffing that is necessary to support such a transition. Executive Van De Hey also reported that the new Juvenile Division will be implemented on Thursday, March 18. This is a very significant portion of the Chinn Study and is a "monumental change" in how Winnebago County will be providing service. She told the Board that in the next couple of months they will be making more recommendations as to who should be included in the Human Services Department.

Executive Van De Hey asked for the Board's support of Resolution No. 192-399, "Authorize Execution of Lease with Citadel Trust and Jungbacker Children's Present Interest Trust and Authorize Transfer of \$176,667 to District Attorney's Budget (Beach Building Lease - Winnebago County District Attorney's Office)." She explained that moving the District Attorney's Office to larger quarters is necessary because the overcrowded conditions are causing high risk for personal injury, fire and safety. Executive Van De Hey told the Board that the Oshkosh Fire Department stated that if the District Attorney's Office wasn't a governmental office it would be cited and possibly closed because of the overcrowded conditions and the risk for fire and injury.

Executive Van De Hey told the Board that previous comprehensive plans on county buildings, facilities and future space needs lacked "continuity", but that they hope to have an effective comprehensive plan for the County Board to adopt in a few months. She further stated that any changes recommended in the comprehensive plan would take a number of years to complete because of budgetary restraints.

However, Executive Van De Hey explained that the District Attorney's Office was in "urgent" need of more space and steps were taken to find an appropriate location for them. The Ameritech Building and the Beach Building were determined to be the two best choices because of their close proximity to the safety building and courthouse. The Beach Building became the final choice because the Ameritech Building will never be available for purchase by the county and they were not willing to do any remodeling to accommodate the District Attorney's Office. The Beach Building already has a secured elevator and they are willing to remodel. Executive Van De Hey stated that they were also able to negotiate a lower rent rate for the Beach Building. She explained that at this time, Tom Bartz, Information Systems Director, has not been able to give a final cost for setting up computer and telephone lines, but that the \$110,000 included in the resolution is a "worst case scenario" figure.

Executive Van De Hey stated that the offices vacated by the District Attorney's Office could be used by any number of county departments. She said that all these departments' needs will be studied and whoever is in the greatest need will be moved to those offices. Executive Van De Hey further stated that because the suggestion to possibly rent the space to the Oshkosh Police Department was met with such opposition by a number of County Board Supervisors, that option is not now being considered.

### **COUNTY BOARD CHAIRMAN'S REPORT**

Chairman Maehl announced that Winnebago County 's application for a \$13,000 1999 County Veterans Service grant from the Wisconsin Department of Veterans Affairs has been approved. Chairman Maehl also shared with the Board that in 1919 President Wilson established the Bureau of Veterans Affairs. He also stated that Wisconsin was the first state to participate in these programs and Winnebago County was the first county to become involved.

Chairman Maehl commented on the newspaper article in which Professor Hintz talks about the size of the County Board and recommends that there only be six committees. Chairman Maehl stated that if the Board is reduced to 12 or 15 members, based on population, the City of Oshkosh would have approximately 10 or 12 representatives, the Cities of Neenah & Menasha would have 1 or 2 representatives and the townships would probably not have any representation.

Chairman Maehl also commented on the positive newspaper articles that reported on the home in Oshkosh where Kurdish refugees are residing and the Winnebago County Scholarship Awards Program for high school seniors.

Chairman Maehl told the Board that the opening ceremonies for the new racetrack will be on Tuesday, May 18<sup>th</sup>, which is also the date of the regularly scheduled County Board meeting. He recommended that the regular County Board meeting be held on Wednesday, May 19<sup>th</sup>. A motion was made by Supervisor Pech and seconded to reschedule the May 18<sup>th</sup> County Board meeting to May 19<sup>th</sup>. CARRIED BY UNANIMOUS VOICE VOTE.

Authorize Execution of Lease with Citadel Trust and Jungbacker Children's Present Interest Trust and Authorize Transfer of \$196,500 to District Attorney's Budget (Beach Building Lease - Winnebago County District Attorney's Office)

WHEREAS, the present space occupied by the Winnebago County District Attorney's Office in the Public Safety Building is inadequate for its staff and has been for a number of years; and

WHEREAS, space presently occupied by the District Attorney in the Public Safety Building could be utilized for other purposes; and

WHEREAS, a tentative agreement has been reached, subject to approval of the Winnebago County Board of Supervisors, to enter into a lease for 10,000 square feet of space in the Beach Building, 240 Algoma Boulevard, Oshkosh, Wisconsin at a rate of \$8.50 per square foot for an original term of three (3) years, with three one (1) year options to extend the lease at a total cost of \$95,000 per year for year four, \$105,000 per year for year five and \$115,000 per year for year six; and

WHEREAS, under the terms of said lease, the Winnebago County District Attorney would occupy all of the second floor of said building; and

WHEREAS, the cost of wiring said building for telephone service and computer system service is estimated not to exceed \$110,000; and

WHEREAS, your undersigned Committees believe that the leasing of said building is in the County's best interest in that the price of said lease is more than reasonable given the proximity of said building to the Winnebago County Courthouse; and

WHEREAS, your undersigned Committees believe that entering into said lease will provide Winnebago County with adequate time to acquire a permanent solution to its office space problem in the Courthouse area.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby approves the execution of a lease between Citadel Trust and the Jungbacker Children's Present Interest Trust and Winnebago County for the rental of the second floor of the Beach Building, 240 Algoma Boulevard, Oshkosh, Wisconsin for the purpose of housing the Winnebago County District Attorney's Office under those terms as provided in the attached lease, which is herewith attached and made a part of this resolution by reference.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the transfer of \$76,500 to the Building Rental Fund of the District Attorney's Budget; \$10,000 to the Other Expense – Moving Expense Fund of the District Attorney's Budget; and \$110,000 to the Other Improvements Fund of the Information Systems Budget, with all of said money to be transferred from the Winnebago County General Contingency Fund.

Supervisor Savas made a presentation and expressed her deep commitment to the prevention of child abuse. She stated how important it is that all children live in a safe and nurturing environment so they can, "grow to be healthy and productive members of society and reach their full potential as human beings."

Cheryl Cain of the Winnebago County Social Services Department addressed the Board and explained that the intent of this resolution is to focus on child abuse prevention efforts and programs in Winnebago County. Ms. Cain explained that her department, "has the responsibility to provide services once abuse as occurred, to try to prevent further incidents and to help more appropriate and positive parenting." In 1997 there were 1,120 reports of child abuse and in 1998, that number rose to 1,659.

A number of prevention efforts are ongoing in Winnebago County and include: Winnebagoland Focus and the Partnership Project who have co-sponsored a "Zero Tolerance for Violence" Campaign, in which they increase the awareness of violence against children and provide education to people on what can been done to stop it. Another program is the Exchange Club Center for the Prevention of Child Abuse. They also focus on making people aware of child abuse in Winnebago County and educating them on ways to prevent it. The Exchange Club provides home visits to high-risk parents of children under the age of six, as well as providing many parent education programs. The Alliance for Families provides the new parent program, which is home visits to new parents that are considered high risk to abuse.

Ms. Cain told the Board that the Exchange Club Center and Zero Tolerance Campaign are cosponsoring a Kids First Blue Ribbon Campaign. The buttons with blue ribbons attached can be purchased for \$1.00 and are to be worn during the month of April. All the proceeds from the sale of the buttons will go to fund these programs. Ms. Cain distributed buttons to the Board and invited them to attend the Blue Ribbon Luncheon on April 1 at noon at the Park Plaza Hotel and Convention Center. Tickets for the luncheon are \$10.00 and can be purchased at the Exchange Club Center or from Ms. Cain.

Ms. Cain thanked the Board for their support of this resolution and their efforts to prevent child abuse.

RESOLUTION NO. 196-399: Authorize Appropriation of Tobacco Litigation Settlement Dollars to Local Health Departments

WHEREAS, tobacco-related diseases account for 17% of all deaths in Wisconsin, claiming nearly 80,000 lives per year; and

WHEREAS, tobacco use is the single most preventable cause of premature death and disability in the state and is associated with significant public health problems, including asthma, heart disease and cancer; and

WHEREAS, youth smoking in Wisconsin is higher than the national average with nearly 40% of children between the ages of 14 and 17 currently smoking, 1/3 of whom will eventually die as a result of smoking-related illnesses; and

WHEREAS, Wisconsin residents spend close to 1.4 billion dollars a year for treatment of tobaccorelated diseases, according to statistics released by the National Centers for Disease Control and Prevention; and

WHEREAS, the Wisconsin Attorney General's class action tobacco litigation settlement reimburses Wisconsin for past smoking related costs borne by the state. The terms of the Wisconsin Attorney General's class action tobacco litigation settlement preclude the state and local governments from recovering future costs related to tabacco use; and

WHEREAS, Winnebago County bears significant costs attributable to the effects of tobacco use, including lost productivity, disability, and higher insurance premiums and health care costs. Tobacco use has similar adverse affects upon health organizations, businesses, local government, religious institutions and civic groups in Winnebago County; and

WHEREAS, Winnebago County and its taxpayers will continue to bear costs due to the health affects of tobacco use absent the state acting to reduce those costs.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby indicates its support for the appropriation by the Wisconsin State Legislature of tobacco litigation settlement dollars to local health departments for the development and implementation of innovative and effective programs to reduce and prevent tobacco use by children and to assist smokers who desire to quit tobacco use and for the treatment and alleviation of tobacco-related health problems.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that the Winnebago County Clerk is hereby authorized and directed to transmit a copy of this resolution to all Wisconsin state

NOW, THEREFORE, the County Board of Supervisors of the County of Winnebago does ordain as follows:

That Section 11.11(7)(a) of the General Code of Winnebago County shall be amended to read as follows:

(7) FEES. (A) Fees for the issuance of permits, the making of investigations, inspections, providing education, training and technical assistance to all establishments covered pursuant to this Ordinance, plus the costs required to be paid to the state for each permit issued, are herewith established pursuant to this Ordinance and may be amended from time to time upon the approval of the Winnebago County Board of Supervisors and the Winnebago County Executive. In addition, separate pre-inspection fees are hereby established with regard to new establishments or existing establishments which have been transferred to a new operator. Said fee schedule is also set forth in Appendix "A" and may be amended from time to time by the Winnebago County Board of Supervisors upon the approval of the Winnebago County Executive.

BE IT FURTHER ORDAINED by the County Board of Supervisors of the County of Winnebago that the attached fee schedule is hereby adopted pursuant to Section 11.11(7)(A) of the General Code of Winnebago County and is herewith ordained as a part of said Ordinance.
