## ADJOURNED SESSION COUNTY BOARD MEETING WEDNESDAY, MAY 19, 1999

Chairman Joseph Maehl called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Wagner.

Motion by Supervisor Lauson and seconded to approve the minutes of the April 20, 1999 County Board meeting. CARRIED BY UNANIMOUS VOICE VOTE.

## COMMUNICATIONS, PETITIONS, ETC.

Notice of Claim from Bachman, Cummings, McKenzie, McIntyre & Wilson, S.C. for Daniel & Cynthia Cuervo regarding an incident involving officers from the Winnebago County Sheriff's Department was referred to the Personnel & Finance Committee.

A letter was received from Mark Grapentine, Policy Advisor to Governor Thompson, acknowledging receipt of County Board Resolution No. 218-499 "Support Creation of a Seventh Circuit Court in Winnebago County." He assured the Board that their recommendations would be kept in mind as this issue is debated in Madison.

A letter was received from Rep. Gregg Underheim acknowledging receipt of the following County Board Resolutions: No. 196-399, "Authorize Appropriation of Tobacco Litigation Settlement Dollars to Local Health Departments"; No. 218-499, "Support Creation of a Seventh Circuit Court in Winnebago County"; No. 205-499, "Authorize Resolution Requesting Amendment to the Clean Water Act"; and No. 208-499, "Support Campaign Finance Legislation." He states that he will keep the Board's position "in mind as these issues are debated."

A letter was received from State Representative Tom Sykora regarding Movin' Out, Inc., a Madison-based organization that assists elderly & disabled people in obtaining affordable housing.

A copy of Oconto County's Resolution No. 39-1999, "1999-2001 State Budget Relating to a Soil Mapping and Digitization Initiative in Partnership with Natural Resources Conservation Services (NRCS)" was referred to the Legislative Committee.

Information was given on the WCA Educational Seminar entitled, "Round 2: W-2 Entering into New Contracts." This seminar will be held on May 24 in Wausau, WI. Supervisors interested in attending should contact the County Clerk's Office as soon as possible.

An announcement for the 1999-2000 Community Development Block Grant Small Cities Housing Application Information Training Sessions was received. There will be three sessions: June 15 in Rice Lake; June 16 in Shawano; and June 17 in Portage. The fee is \$10.00 and is paid upon arrival at the session.

Petition for Zoning Amendment from Jane Van De Hey, Town of Algoma, for change from R-1 to P-1 for airport purposes was referred to the Planning & Zoning Committee.

#### **COMMITTEE REPORTS**

Supervisor Payne reported that the grand opening of the Sunnyview Speed Zone was attended by over 5,000 people and was a success. He stated that the rainy weather earlier in the day did cause some problems in the pit area. He also told the Board that the sound system didn't operate properly, but that it is being corrected.

Supervisor Lauson agreed with Supervisor Payne and told the Board that he feels the racetrack will be a success. He reported positive comments from people attending the event.

Supervisor Lauson told the Legislative Committee members that a packet of information is on their desks for their next meeting.

Supervisor Lauson invited the Board to attend the ribbon cutting ceremony for the new covered horse arena, which will be held on Friday, May 28 at 10:00 a.m. When asked about the letter received from Doug & Diane Beyer expressing concerns about the new horse arena, Supervisor Lauson reported that these are mostly minor complaints and that they are being addressed by Rob Way. He further explained that this is a multiple use horse arena and will be used by various groups. The requests to use the facility have been tremendous and indications are that it will be a very successful facility.

Supervisor Wagner reported that the former District Attorney's Office in the Safety Building will be used by Family Court Counseling and the Court Commissioner's offices. Circuit Court Branch VI will then be able to expand into part of the Court Commissioner's current area. She also reported that on June 10, from 3:00 – 6:00 p.m., there will be an open house at the District Attorney's new office and everyone is invited to attend.

Supervisor Schwartz invited the Board to a Long-Term Care Redesign meeting, which will be held on Monday, May 24 at 6:00 p.m., at the Ramada Inn, Oshkosh. This meeting is being sponsored by the Winnebago County Association for Retarded Citizens and the state's Association for Retarded Citizens.

Supervisor Barker invited the Board to attend the City of Menasha's 125<sup>th</sup> birthday celebration on Saturday, May 22. Supervisor Barker has a schedule of events for anyone who is interested in attending.

Supervisor Koziczkowski told the Board that on May 27<sup>th</sup> they will be holding their last "information gathering session" on the Human Services Department study. In June, they will be prepare their proposal for the development of a Human Services Department. Charlene Lowe, Park View Health Center Administrator, will be making a presentation on this issue at the June 1 Special Orders Session of the County Board. He explained that existing programs and funding will not be adversely affected by establishing a Human Services Department. Supervisor Koziczkowski and Supervisor Schwartz are available to answer any questions the Board might have on this issue.

Supervisor Griesbach reported that William Fahrenkrug, Emergency Government Director, has resigned from his position. Supervisor Griesbach also stated that he will be withdrawing Ordinance No. 229-599, "Amend Chapter 6 General Code of Winnebago County (Emergency Government)."

Supervisor Rengstorf reported that they received five responses to their Request for Qualifications for the construction of the new Sheriff's facility. Of those five, three have been selected to present their proposals and cost information to the committee on June 9.

## **COUNTY EXECUTIVE'S REPORT**

Executive Van De Hey spoke in support of including a new airport hangar in the 5-year Capital improvements plan. She stated that the Aviation Committee and Duncan Henderson have worked hard at finding new "strategies to generate revenue" at Wittman Field and she hopes the Board will support them.

Executive Van De Hey explained that the petition for zoning amendment presented in her name at this meeting pertains to the former Sosnoski property. In order to use this property for airport purposes, it must be rezoned, so the county is petitioning for a zoning amendment.

Executive Van De Hey spoke to the Board regarding the Neenah weather radar station. She explained that Sheriff Brooks has been negotiating this purchase "very, very carefully", and that the GSA will not considered any other offer unless Winnebago County would decline to purchase the station. Executive Van De Hey stated that the high costs to remove asbestos and do other repairs affected the decision to put in the lower offer.

#### **COUNTY BOARD CHAIRMAN'S REPORT**

Chairman Maehl asked John Bodnar, Corporation Counsel, for an explanation of the County Executive's \$44,200.00 offer to the U.S. General Services Administration for the former Neenah weather radar station. Chairman Maehl questioned the offer, because in April the Board approved offering \$65,000 for that property. Mr. Bodnar explained that \$65,000 was the maximum amount the Board approved, but that it didn't preclude the County Executive from trying to purchase the property at a lower cost. Mr. Bodnar explained that the \$44,200 offer takes into account repairs that will need to be made to the station.

Chairman Maehl extended "happy birthday" wishes to Supervisor Kollath.

Chairman Maehl asked that the Board note the two articles in their packet regarding protecting the county's wetlands and commented on the importance of this issue.

Chairman Maehl told the Board that of the 72 counties in Wisconsin, only 6 have an annual county board tour and 8 have a tour every two years. He commented that this year's tour was very good and that it was very beneficial to those who participated. He stated that next year they are considering having the tour in two half-day sessions. He'd like the Board's input on that idea.

Chairman Maehl commented on the busy Sunnyview Expo Center's summer schedule that the Board received, stating that it is a good indicator of the success of that facility.

Chairman Maehl told the Board that on Memorial Day next year, they will be dedicating the World War II Memorial in Washington, D.C. He stated that each state has been requested to donate \$1.00 for each veteran in uniform during World War II for this memorial. Wisconsin has donated \$332,200 for the memorial.

In recognition of the upcoming Memorial Day, Chairman Maehl read the following article:

You know, some people still don't understand why military personnel do what they do for a living. This exchange between Senators John Glenn and Howard Metzenbaum is worth reading. Not only is it a pretty impressive impromptu speech, but it's also a good example of one man's explanation of why men and women in the Uniformed Services do what they do for a living. And an example of what those who have never served think of the Military.

Senator Metzenbaum to Senator Glenn: How can you run for Senate when you've never held a real job? Senator Glenn: I served 23 years in the United States Marine Corps. I served through two wars. I flew 149 missions. My plane was hit by anti-aircraft fire on 12 different occasions. I was in the space program. It wasn't my checkbook; it was my Life on the line. It was not a 9 to 5 job where I took time off to take daily cash receipts to the bank. I ask you to go with me...as I went the other day...to a Veterans Hospital and look at those men with their mangled bodies in the eye and tell them they didn't hold a real job. You go with me to the space program and go as I have gone to the widows and orphans of Ed White and Gus Grissom and Roger Chaffee and you look those kids in the eye and tell them that their dad didn't hold a real job. You go with me on Memorial Day coming up, and you stand in Arlington National Cemetery, where I have more friends that I'd like to remember, and you watch those waving flags, and you stand there, and you think about this nation, and you tell me that those people didn't have a real job. I'll tell you, Howard Metzenbaum, you should be on your knees every day of your life thanking God that there were some men-SOME MEN-who held a real job. And they required a dedication to purpose and a love of country and a dedication to duty that was more important than life itself. And their self-sacrifice is what made this country possible.

I HAVE HELD A REAL JOB, HOWARD! What about you?

WHEREAS, your undersigned Committee opposes passage of said Bills at this time as presently drafted. NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby expresses its opposition to the adoption of Senate Bill 44 and Assembly Bill 22.
