# ADJOURNED SESSION COUNTY BOARD MEETING JULY 21, 1999

Chairman Joseph Maehl called the meeting to order at 6:00 P.M. in the Supervisors' Room, Fourth Floor, Courthouse, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an Invocation by Supervisor Wagner.

Supervisor Robl moved and it was seconded to adopt the agenda. CARRIED BY UNANIMOUS VOICE VOTE.

## **COMMITTEE REPORTS**

Supervisor Lauson reported that the Country USA concert at the fairgrounds were a success. There was some damage done to the turf, but it's repairable. He also stated that the Life Promotions Christian Music Festival, also held at the fairgrounds, was well attended and very successful. He expressed his thanks to the Sheriff's Department, the Oshkosh Police Department and the reserve officers for their services.

Supervisor Barker commented on the Fox-Wolf Basin Link newsletter that was placed on their desks. The newsletter reports that Pete Van Airsdale, Director of the Land & Water Conservation Department, was the recipient of the Becky Wallace Memorial Award. Mr. Van Airsdale received the award because he has, "done notable work enhancing partnerships and fostering a watershed approach to water resource management."

Supervisor Robl reported that the Highway Committee toured the County Road CB and County Road K construction projects. The excessive rainfall has caused some problems for these projects.

Supervisor Rankin commented on the possibility that state funding for recycling programs may be discontinued. He stated that there is a great demand for recycling and that Winnebago County's program has been very successful.

Supervisor Schaidler called the Board's attention to the first issue of <u>Winnebago Community</u>, a newsletter compiled by Mike Koles, Winnebago County Community Development Educator at the UW-Extension. Supervisor Schaidler stated that the newsletter discusses various aspects of the land use issue. He asked that they keep this information for future reference.

Supervisor Sundquist called the Board's attention to the Quarterly Convention Calendar distributed by the Oshkosh Convention and Visitors Bureau.

Supervisor Hue reported that Christine Kniep, Office Chairman of the Winnebago County UW-Extension Department, has been made a full professor. He stated that Winnebago County is the only county that has two full professors on staff in their UW-Extension Office. Jim Barthel, 4H Youth Development Educator, is also a full professor.

Supervisor Leschke gave a "friendly reminder" to the committees, commissions and boards that they remember to record their votes in their minutes. County Board Rule 7.2 requires that any resolution coming from a committee, commission or board have that body's vote indicated on the resolution.

Supervisor Leschke also asked that the following correction be made to the previously approved proceedings for May 19: Page 34, Line 6, replace "on this issue" with "about Park View Health Center and its operations." Vote on correction – carried by voice vote.

Supervisor Footit spoke about the Parks & Recreation Committee's unrecorded vote regarding a Sunnyview Speed Zone Raceway issue. He stated that in an effort to correct those minutes, the Committee was uncertain of the actual vote, so they decided to indicate that a majority of the Supervisors present voted in favor of the issue.

Supervisor Footit also expressed his concern about misleading newspaper headlines regarding his water business dealings with Country USA. He explained that this incident was investigated by the District Attorney's Office and no chargers were filed.

Supervisor Footit spoke in support of Supervisor Payne's committee actions regarding the recent Sunnyview Speed Zone Raceway controversy. He also expressed his objections to Supervisor Payne being singled out for ethics violations.

Supervisor Albrecht told the Board that Mike Koles completed the first phase of an economic impact study of the airport. He encouraged the Board to review the study. Supervisor Albrecht said that the second phase of the study is in progress. When that is done, a complete report will be given to the Board.

Supervisor Albrecht also reported that the issue regarding a late payment by the Azco Group Limited because of an alleged postal service delay or error has been resolved.

Supervisor Troxell moved and it was seconded to accept the minutes of the June 1 & 15, 1999 meetings. CARRIED BY VOICE VOTE.

## **COUNTY EXECUTIVE REPORT**

Executive Van De Hey reported that she and other county officials participated in area parades over the 4<sup>th</sup> of July weekend.

Executive Van De Hey also told the Board that she has been serving as the Emergency Government Director and was at Country USA in that capacity. She thanked the Sheriff's Department, the Oshkosh Police Department and the reserve officers for their services at Country USA.

Executive Van De Hey reported that the Country USA promoters relaxed their "no water policy" and the county installed water coolers on the grounds.

Executive Van De Hey reported that the radio tower located in the Town of Clayton has been purchased for \$13,000 less than originally negotiated. She stated that this will improve emergency radio transmissions making the citizens of Winnebago County safer.

Executive Van De Hey told the Board that interviews for the construction of the jail have been completed, and that architect and construction manager RFP's are being completed. When the RFP's have been approved by the jail committee and John Bodnar and Mike Elder, recommendations will be brought to the Property Management & Maintenance and Judiciary & Public Safety Committees.

## **COUNTY BOARD CHAIRMAN'S REPORT**

Chairman Maehl reported to the Board that in 1899, the construction of an approved county jail and Sheriff's home was delayed because of an increase in cost--\$19,000 to \$26,000.

Chairman Maehl reported that the Fox River Locks in the City of Menasha saw a 49% increase in watercraft. He stated that this has a positive economic impact.

Chairman Maehl commented on the 7-page letter the Board received from Fred Umland, Juvenile Court Intake, and Judge Robert Hawley. He encouraged the Board to read the letter, as it gives a detailed look at their side of the issue regarding the transfer of Juvenile Court Intake to the Human Services Department.

Chairman Maehl read a note from Supervisor Kramer thanking the Board for the plant and their expressions of sympathy regarding the death of his daughter. Chairman Maehl also asked that the Board keep another of Supervisor Kramer's daughters in their prayers as she battles a serious illness.

# RESOLUTION NO. 247-799: Support Continued State Funding For Recycling Program

WHEREAS, the state recycling program is a mandate imposed on Wisconsin municipalities that is largely unfunded for the majority of those municipalities, as the temporary recycling surcharge has paid only a portion of the eligible costs of local recycling programs; and

WHEREAS, Winnebago County, Wisconsin invested 4.4 million dollars in a Material Recovery Facility with a current debt service of 2.6 million dollars remaining; and

WHEREAS, the responsible units of government in Winnebago County would loose \$800,000 in grant funding and have invested thousands of dollars for equipment to comply with the mandate; and

WHEREAS, due to inadequate markets, low cost virgin materials corporate subsidies for raw materials, the lack of corporate responsibility for products and packaging and the failure of the private sector in the development of infrastructure and markets adequate to meet the needs of local recycling programs, recycling has not met its goal of becoming financially self-sufficient by 1999; and

WHEREAS, under current laws, state revenues are unlikely to be sufficient to fund all current recycling programs through the 1999-2001 biennium at 1997 levels.

NOW, THEREFORE, BE IT RESOLVED that Winnebago County supports continued funding of the recycling mandate at least at the 1997 levels, financed by one or a combination of the following alternatives: tipping fees on all solid waste disposed of in Wisconsin landfills and a sales tax on all solid waste services.

NOW, THEREFORE, BE IT RESOLVED that Winnebago County urges the Legislature to provide funding for the recycling mandate not only to local governments, but also to those state agencies which provide technical and educational assistance to local recycling programs and which promote the continued development of markets for recycled materials..

BE IT FURTHER RESOLVED that Winnebago County urges the Legislature to reaffirm the State of Wisconsin's commitment to recycling with appropriate directives and adequate funding to all state agencies to foster compliance with all aspects of Wisconsin Act 335, its revisions and amendments, especially those related to enforcement, research, minimum recycled content, truth-in-advertising, etc.

BE IT FURTHER RESOLVED that copies of this resolution be sent to Governor Tommy G. Thompson, Wisconsin Counties Association and Winnebago County representatives in the 1999 Wisconsin State Legislature.

# RESOLUTION NO. 248-799: Authorize Execution of Amendment #3 of Lease Agreement Between Fox Valley Technical College and Winnebago County

WHEREAS, Winnebago County and Fox Valley Techical College entered into a Lease Agreement effective September 14, 1992 and subsequently amended on June 22, 1995 and October 1, 1998, with regard to rental of property at Wittman Regional Airport in relationship to an Avionics Center and Hangars at said facility; and

WHEREAS, Fox Valley Technical College wishes to deed to Winnebago County approximately 1.55 acres of land with a fair market value of \$15,500 which is adjacent to said property; and

WHEREAS, in exchange for said property, Winnebago County would lease said property to Fox Valley Technical College but would forgive rent upon said property in an amount equal to \$15,500 on a monthly basis beginning on the date where said agreement would take effect and after said credit is utilized, (approximately August 1, 2005) Fox Valley Technical College shall then pay Winnebago County the annual rent at the aviation and non-aviation related land rental rate upon the land utilized by that facility; and

WHEREAS, the attached agreement would affectuate said transaction.
NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it

hereby approves Amendment #3 to the Lease Agreement between Winnebago County and Fox Valley Technical College originally executed on September 14, 1992 and as amended on June 22, 1995 and October 1, 1998. A copy of said Amendment #3 is herewith attached and made a part of this Agreement by reference.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that Chapter 13 of the General Code of Winnebago County be amended to read as follows: A copy of the proposed ordinance is herewith attached.

# **LIVESTOCK WASTE MANAGEMENT - CHAPTER 13**

#### 13.01 AUTHORITY

(1) This Chapter of the Code is adopted pursuant to authority granted in Chapter 59, and sec. 92.11,

92.15 and 92.16, Wis. Stats.

- (2) This Chapter of the Code incorporates by reference the technical standards developed by the United States Department of Agriculture and the Natural Resources Conservation Service, hereinafter called the USDA-NRCS Technical Guide, adopted by the Winnebago County Land and Water Conservation Department for use in the design, construction, operation, and maintenance of livestock waste storage facilities and animal lots. Any such standards shall apply until amended and then shall apply as amended.
- (3) This chapter of the Code also incorporates by reference the Soil Survey of Winnebago County, 1980, USDA-Soil Conservation Service and Wis. Administrative Code 812.04 (the Wisconsin Well Code).

### 13.02 FINDINGS AND DECLARATION OF POLICY

- (1) The Winnebago County Board of Supervisors finds that storage of livestock wastes in facilities and animal lots and the land application of livestock waste may cause pollution of the surface waters and ground waters of Winnebago County, and may result in actual or potential harm to the health and safety of County residents and transients, to livestock, aquatic life and other animals and plants, and to the property tax base of Winnebago County.
- (2) The Winnebago County Board of Supervisors also finds that the USDA-NRCS Technical Guide, as adopted by the Winnebago County Land and Water Conservation Department, provides the basis for effective and environmentally safe methods of construction, operation, and maintenance of livestock waste storage facilities and animal lots.
- The County of Winnebago permits operation of properly conducted agricultural operations within the county. If property is located near agricultural lands of operation or included within an area zoned for agricultural purposes, it may be subject to conditions arising from such operations. These conditions may include, but are not limited to: noises, odors, lights, fumes, dust, operation of machinery, and the storage and disposal of manure. One or more of these conditions described may occur as a result of any agricultural operation, which is in conformance with existing laws and regulations and accepted customs and standards. Those residing near an agricultural area should be prepared to accept such outcomes as a normal and necessary aspect of living in a county with strong rural character and an active agricultural sector. Winnebago County has established the Land Conservation Committee to assist in the resolution of any animal waste management disputes, which might arise between residents of the county regarding agricultural operations.

### 13.03 PURPOSE

The purpose of this Chapter is to assure the safe handling and spreading of animal waste as well as to regulate the location, design, construction, alteration, operation, and maintenance of all animal lots and livestock waste storage facilities. Also to regulate the abandonment of livestock waste storage facilities in order to prevent water pollution, protect the health and safety of residents and transients, prevent the spread of disease, and promote the prosperity and general welfare of the citizens of Winnebago County.

#### 13.04 INTERPRETATION

The provisions of this Chapter of the Code shall be held to be minimum requirements and shall be liberally construed in favor of Winnebago County and shall not be deemed a limitation or repeal of any other power granted by Wisconsin Statutes.

#### 13.05 JURISDICTION

This Chapter shall apply to all unincorporated areas of Winnebago County.

### 13.06 EFFECTIVE DATE

This Chapter shall become effective upon the date following its County publication.

#### 13.07 DEFINITIONS

- (1) "Abandonment" means a livestock waste storage facility that is no longer being used for its intended purpose, and is no longer receiving animal wastes, has not received any animal wastes for a period of one year and, based on available evidence, is unlikely to receive animal wastes from an active livestock operation within the next six months.
- (2) "Animal" means domesticated and other types of animals together with fish and birds.
- (3) "Animal lot" means a lot or building or combination of lots and buildings intended for the confined feeding, breeding, raising, or holding of animals, specifically designed as a confinement area in which animal waste may accumulate, or where the concentration of animals is such that a vegetative cover cannot be maintained within the enclosure. For purposes of this ordinance, open lots used for the feeding and rearing of poultry (poultry ranges) shall be considered to be animal lots. Pastures shall not be considered animal lots under this ordinance.
- (4) "Applicant" means any person who applies for a permit under this chapter of the Code.
- (5) "Bedrock" means any naturally formed consolidated rock material and weathered in-place material with > 50%, by volume, larger than 2 mm in size. Bedrock includes, but is not limited to limestone (dolomite), sandstone, shale and igneous and metamorphic crystalline rock, including granite, rhyolite, quartzite, gabbro, basalt, gneiss, schist, diorite and greenstone.
- (6) "Department" means the Winnebago County Land and Water Conservation Department.
- (7) "Ground Water" means the water filling all the unblocked pores of underlying material below the water table.
- (8) **"Incorporation"** means to blend, mix or combine into the soil, which may include injection, discing, plowing, chisel plowing, roto-tilling, or other tillage methods.
- (9) **"Livestock Waste"** means livestock excreta, bedding material, rain or other water, soil, hair, feathers or other debris normally included in animal waste handling operations.
- (10) "Livestock Waste Management Permit" means the signed, typed statement issued by the Winnebago County Land and Water Conservation Department under this chapter of the Code authorizing the applicant to construct, reconstruct, enlarge, or substantially alter a livestock waste storage facility or animal lot.
- (11) "Livestock Waste Storage Facility" means an excavated or earthen impoundment or a fabricated structure of concrete, wood and/or steel used for temporary storage of animal waste or other organic waste.
- (12) "Non-cropped Wetland" means a wetland that has not been farmed within the last five years.
- (13) "Nutrient Management Plan (590)" means a plan that outlines the management and crediting of nutrients from all sources, including legumes, manure, and soil reserves for the application of manure and commercial fertilizers. Management includes the rate, method, and timing of the application of all sources of nutrients to minimize the amount of nutrients entering surface and groundwater. This practice includes manure nutrient testing, routine soil testing, and residual nitrogen soil testing.
- (14) "Pasture" means areas where grass or other growing plants are used for grazing and where the concentration of animals is such that a vegetation cover is maintained during the growing season excerpt in the immediate vicinity of temporary supplemental feeding or watering devices.
- (15) **"Person"** means any individual, corporation, partnership, joint venture, agency, unincorporated association, municipal corporation, county, or state agency within Wisconsin, the federal government, or any combination thereof.
- (16) "Sinkhole" means a depression or opening on the land surface, usually funnel-shaped, generally

formed by solution or collapse of limestone, dolomite or to a lesser extend sandstone bedrock occurring at or near the surface. Sinkholes may be partially or completely filled with unconsolidated material and solution enlargement of vertical passages, often extend to the water table. Collapse of mine workings in other consolidated formations are also considered sinkholes.

- (17) "Surface Water" means any lake, perennial, or intermittent stream as identified on USGS 1:24,000 Quadrangle maps or direct conduits to such waters as determined by the Land and Water Conservation Department.
- (18) **"Technical Standards"** means the current, written standards and specifications for animal lots and livestock waste storage facilities contained in the USDA-NRCS Technical Guide.
- (19) **"NRCS"** means the Natural Resource Conservation Service, an agency of the United States Department of Agriculture.
- (20) "Waters of the State" means those portions of Lake Michigan and Lake Superior within the boundaries of Wisconsin, and all lakes, bays, rivers, streams, springs, ponds, wells, impounding reservoirs, marshes, water courses, drainage systems and other surface water and groundwater, natural or artificial, public or private within the state or its jurisdiction as defined in Section 147.015(20) of the Wisconsin Statutes.
- **"Water Pollution"** means contaminating or rendering unclean or impure the ground or surface waters of the state, or making the same injurious to public health, harmful for commercial or recreational use, or deleterious to fish, bird, animal, or plant life.
- (22) "Water Quality Management Area" means any of the following:
   a) The area within 1,000 feet from the ordinary high-water mark of a flowage.

lake, pond or

- b) The area within 300 feet from the ordinary high-water mark of a stream or river.
- c) A site that is susceptible to groundwater contamination or that has the potential to be a direct conduit for contamination to reach groundwater.
- "Wetland" means an area that has a predominance of hydric soils and that is inundated or saturated by surface or ground water at a frequency and duration sufficient to support, and under normal circumstances does support a prevalence of hydrophytic vegetation typically adapted for life in saturated soil conditions.

#### 13.08 ACTIVITIES SUBJECT TO REGULATION

- (1) APPLICABILITY. Any person or their agent who acquires ownership of, leases, or constructs, reconstructs, enlarges, abandons or substantially alters any livestock waste storage facility or animal lot or applies livestock waste on land subject to this ordinance, shall be subject to the provisions of this chapter of the Code.
- (2) COMPLIANCE. A person is in compliance with this chapter of the Code if the procedures of this chapter have been followed, a permit from the Winnebago County Land and Water Conservation Department has been issued prior to commencing construction activities subject to regulation under this section, and there is full compliance with the requirements of the permit.

#### 13.09 STANDARDS AND SPECIFICATIONS

(1) ANIMAL LOTS. The standards and specifications for design, construction, operation and maintenance of animal lots are those identified in Standard 350 and 312, USDA-NRCS Technical Guide and the Wisconsin Administrative Code NR812.

- (2) ANIMAL LOT SETBACK REQUIREMENTS. All new animal lots shall be sited a minimum of 50 feet from wells, and 300 feet from any surface water. An Animal lot may be sited between 300 feet and 75 feet from surface water with an approved variance from the Winnebago County Land and Water Conservation Department.
- (3) LIVESTOCK WASTE STORAGE FACILITIES. The standards and specifications for design, construction, operation, and maintenance of livestock waste storage facilities are those identified in Standard 313, and 634, USDA-NRCS Technical Guide and the Wisconsin Administrative Code NR812
- (4) LIVESTOCK WASTE STORAGE FACILITIES SETBACK REQUIREMENTS. All new livestock waste storage facilities shall be sited a minimum of 75 feet from surface water.
- (5) LIVESTOCK WASTE MANAGEMENT AND UTILIZATION. Animal wastes for which storage permits are issued under this chapter of the Code and all wastes from existing livestock waste storage facilities shall be managed and utilized in accordance with Standard 590, USDA-NRCS Technical Guide. A current (590) Nutrient Management Plan shall be submitted by the operator of the livestock waste storage facility by June 1<sup>st</sup> annually to the Winnebago County Land and Water Conservation Department until the animal waste storage facility is no longer in use and it has been properly abandoned.
- (6) MANURE HANDLING AND SPREADING REQUIREMENTS. The following setbacks and separation distances are required for all sources of manure spread within the county.

Manure and organic byproducts shall not be applied to the following areas unless injected or incorporated within 72 hours:

- (a) Within 200 feet of surface water
- (b) Within 200 feet up-gradient of sinkholes, cracked bedrock, or wells.

Manure and organic by products shall not be applied on frozen or snow covered ground in the following areas:

- (a) Within 200 feet of surface water
- (b) Within 200 feet up-gradient of sinkholes, cracked bedrock and wells
- (c) On slopes greater than 9% (Exception: Up to 12% is allowed if contour stripped with sod, or contour farmed with all corn residue remaining.

Manure and organic by products shall not be spread in waterways, non-cropped wetlands, terrace channels, ditches or any other direct conveyance to surface water.

- (7) ANIMAL WASTE PROHIBITIONS. The following practices are prohibited pursuant of this ordinance.
  - (a) Overflow of livestock waste storage facilities.
  - (b) Unconfined manure stacking (piling) within a water quality management area.
  - (c) Direct runoff from animal lots or stored manure to waters of the state.
  - (d) Unlimited access by livestock to waters of the state in a location where high concentrations of animals prevent the maintenance of adequate sod cover.

#### 13.10 APPLICATION AND ISSUANCE OF PERMITS

- (1) PERMIT REQUIRED. Except as hereinafter provided, no person or their agent may construct, reconstruct, enlarge, or substantially alter any livestock waste storage facility or animal lot without first obtaining a **LIVESTOCK WASTE MANAGEMENT PERMIT** from the Winnebago County Land and Water Conservation Department.
- (2) EXCEPTION TO PERMIT REQUIREMENT. Emergency repairs for broken pipes or equipment, leaking dikes, or the removal of obstructions may be performed without a permit from the Land and

Water Conservation Department. If such repairs alter the original design and construction of the facility, the person who initiates such repairs shall make a report to the Land and Water Conservation Department within two business days of the emergency. The determination as to need for additional work and a permit shall be rendered by the Department within two business days of the aforementioned report.

- (3) LIVESTOCK WASTE STORAGE FACILITY PLAN REQUIREMENTS. Each application for a permit under this chapter of the Code shall include a **LIVESTOCK WASTE STORAGE FACILITY PLAN**. Such plans shall include the following:
  - (a) A plan map showing location of the facility, including buildings and homes within 300 feet of the proposed site. The sketch shall be drawn to scale, with a scale no smaller than 1 inch=100 feet.
  - (b) The location of any wells within 300 feet of the facility.
  - (c) The location of all soil test pits, including a detailed log of each pit to a depth of at least <u>5</u> feet below the planned bottom elevation of the facility. The soil test pit log shall include: the location and surface elevation, depth of the pit, description of the soil profile, and the USDA Uniform Soil Classification. The location of each test pit, prior to digging, and the log descriptions of each pit, as it is excavated, shall be determined and recorded by Winnebago County Land and Water Conservation Department or NRCS staff.
  - (d) Depth of high ground water, estimated or observed, in the soil profile and date determined.
  - (e) Depth to bedrock, estimated or observed.
  - (f) Ground contours (2-foot maximum intervals), with spot elevations, indicating land slope at and around the site for a minimum distance of 100 feet.
  - (g) Provisions for adequate drainage and control of runoff to prevent pollution of surface and ground water. The location of any navigable body of water within 500 feet of the proposed site must be shown. Lakes, ponds and flowages in Winnebago County shall be presumed navigable if they are listed in Wis. Dept. of Natural Resources publication "Surface Water Resources of Winnebago County" or are shown on U.S. Geological Survey (USGS) quadrangle maps for Winnebago County, revised 1980. Rivers and streams in Winnebago County shall be presumed to be navigable if they are designated as continuous waterways or intermittent waterways on the USGS maps.
  - (h) The number(s) and type(s) of animals for which storage is to be provided.
  - Planned duration of storage, expressed in days or months, and volume of storage, expressed in cubic feet.
  - (j) Description of the type(s) of materials the facility is to consist of; size, dimensions, and cross sections of the facility, and any other specific details including, but not limited to, concrete, concrete thickness in floors and walls, steel schedules, and fencing.
  - (k) A time schedule for construction of the facility.
  - Description of how waste will be transferred into and removed from the facility.
  - (m) A preliminary Nutrient Management Plan, verifying the ability of the landowner/operator to comply with USDA NRCS 590 Standard.
  - (n) Scale of the plan drawing(s) and north arrow.
  - (o) Description of bench mark(s) including elevation(s) expressed in feet and hundredths.
- (4) ANIMAL LOT FACILITY PLAN REQUIREMENTS. Each application for a permit under this chapter of the Code shall include an **ANIMAL LOT FACILITY PLAN**. Such plans shall include the following:

- (a) A plan map showing location of the facility, including buildings, homes, and wells within 300 feet of the proposed site. The sketch shall be drawn to scale, with a scale no smaller than 1 inch:100 feet.
- (b) The location of any wells within 300 feet of the facility.
- (c) The location of all soil test pits, including a detailed log of each pit to a depth of at least 3 feet below the planned bottom elevation of the facility. The soil test pit log shall include: the location and surface elevation, depth of the pit, description of the soil profile, and the USDA Uniform Soil Classification. The location of each test pit, prior to digging, and the log descriptions of each pit, as it is excavated, shall be determined and recorded by Winnebago County Land and Water Conservation Department or NRCS staff
- (d) Depth of high ground water, estimated or observed, in the soil profile and date determined.
- (e) Depth to bedrock, estimated or observed.
- (f) Ground contours (2-foot maximum intervals), with spot elevations, indicating land slope at and around the site for a minimum distance of 100 feet.
- (g) Provisions for adequate drainage and control of runoff to prevent pollution of surface and ground water. The location of any navigable body of water within 500 feet of the proposed site must be shown. Lakes, ponds and flowages in Winnebago County shall be presumed navigable if they are listed in Wis. Dept. of Natural Resources publication "Surface Water Resources of Winnebago County" or are shown on U.S. Geological Survey (USGS) quadrangle maps for Winnebago County, revised 1980. Rivers and streams in Winnebago County shall be presumed to be navigable if they are designated as continuous waterways or intermittent waterways on the USGS maps.
- (h) Description of the type(s) of materials the facility is to consist of; size, dimensions, and cross sections of the facility, and any other specific details including, but not limited to, concrete, concrete thickness in floors and walls, steel schedules, and fencing.
- A time schedule for construction of the facility.
- (j) Scale of the plan drawing(s) and north arrow.
- (k) Description of bench mark(s) including elevation(s) expressed in feet and hundredths.
- (5) REVIEW OF APPLICATION. The Land and Water Conservation Department shall receive and review all permit applications to determine if the proposed facility will comply with ordinance requirements. The procedure will generally be as follows:
  - (a) Prior to issuance of a permit, livestock waste storage facility and or animal lot plans shall be approved either by the NRCS Area Engineer, by a DATCP representative, by a registered professional civil engineer, or by a Land and Water Conservation Department staff person having the appropriate Engineering Job Approval authority.
  - (b) Within thirty days after an application has been submitted to the Department, the applicant shall be notified in writing whether the application has been approved or disapproved. Approval of such plans may be conditional based upon on-site specific requirements determined by the Department or NRCS.
- (6) PERMIT CONDITIONS. All permits issued under this chapter of the Code shall be issued subject to the following conditions and requirements:
  - (a) The livestock waste storage facility or animal lot design, construction, operation, and maintenance shall be carried out in accordance with the facility plan and standards specified

in Section 13.09 of this chapter of the Code.

- (b) Any modifications to an approved facility plan must be approved in writing by an authorized representative of the Land and Water Conservation Department. Written approval by the Department shall occur only after the NRCS Area Engineer has reviewed and verbally approved the proposed modifications.
- (c) All activities authorized by permit must be completed within two years from the date of issuance after which time such permit shall be void unless renewed prior to expiration.
- (7) RENEWALS. A permit may be renewed once. The landowner or his contractor responsible for installation of a livestock waste storage facility or animal lot may renew a permit prior to expiration date by submitting a renewal form and the appropriate fee to the Land and Water Conservation Department. Prior to any permit renewal a complete review of the project site conditions and design parameters shall be made by the Department to determine if any changes have occurred that would alter the permit criteria. The permit shall expire two years from the date of renewal. No additional renewals shall be granted.

#### 13.11 PERMIT FEE

- (1) The initial fee for a permit under this chapter shall be \$100.00.
- (2) The renewal fee for a permit under this chapter shall be \$50.00.

#### 13.12 PERMIT REVOCATION

The Land and Water Conservation Department may revoke any permit issued under this chapter if the person issued the permit has misrepresented any information in the permit application for the livestock waste storage facility or animal lot, or if the person violates any of the conditions of the permit.

### 13.13 ADMINISTRATION

- (1) ADMINISTRATIVE AUTHORITY. The Land and Water Conservation Department shall administer and enforce this chapter based upon technical review and advice from NRCS/DATCP Area Engineering staff.
- (2) ADMINISTRATIVE PROCEDURES. The administration and enforcement of this chapter by the Land and Water Conservation Department shall be carried out pursuant to established County and Department procedures and policies.
- (3) INSPECTION AUTHORITY. Staff or representatives of the Winnebago County Land and Water Conservation Department shall be authorized to enter upon any lands affected by this chapter to inspect the site prior to and after permit issuance to determine compliance with the ordinance.
- (4) ENFORCEMENT AUTHORITY. The Land and Water Conservation Department shall be authorized to issue a stop work order on livestock waste storage facilities or animal lot sites that have had permits revoked or where activity is in violation of this chapter. Issuance and retraction of stop work orders shall be carried out pursuant to established procedures and policies of the Department.
- (5) PENALTIES. Any person who violates any of the provisions of this chapter, upon conviction of such violation, shall be subject to a penalty as provided in Sec. 25.04 of the Code. Each day that a violation exists shall constitute a separate offense. The following schedule of cash deposits as provided in Sec. 25.04(4)(b)(7) of the code is hereby established.
  - (a) Failure to obtain a Permit \$500.00.
  - (b) All other violations of this chapter \$250.00.

#### 13.14 ABANDONMENT

The owner and/or operator of any existing animal waste storage facility in Winnebago County shall not abandon nor otherwise make said facility inoperative prior to preparing an Abandonment Plan. The plan must be prepared in accordance with USDA, NRCS Technical Standard 313 and approved by the Winnebago County Land & Water Conservation Department.

#### 13.15 APPEALS

Any person aggrieved by a decision of the Land and Water Conservation Department, concerning the enforcement of this chapter, may file a written appeal of the decision with the Winnebago County Land Conservation Committee within 30 days of the Departments decision. A hearing upon the appeal shall be commenced within 60 days of the date of the appeal. The decision of the Committee may be appealed to the Circuit Court pursuant to Chapter 68, Wisc. Stats.

  - (n) "Temporary Restaurant" or "Temporary Retail Food Establishment" shall mean a restaurant or temporary retail food establishment that operates at a fixed location in conjunction with a single event such as a fair, carnival, circus, public exhibition, anniversary sale, or occasional sales promotion.
