Supervisor Koziczkowski reported the Human Services budget is returning \$3.2 million to the General Fund because of diligent work.

COUNTY EXECUTIVE'S REPORT

County Executive Van De Hey commended the staff of Human Services for their diligence. It is

through their efforts that there has been a cost savings. Over \$3 million has been returned to the General Fund through costs savings found by the Human Service merger. Many grants are available that were not available prior to the merger as well as Medicaid payments that now can be made for services rendered. \$800,000 of the savings was from the efficient use of W-2 start-up money over a three-year period.

Executive Van De Hey had a meeting with one person from Odyssey. The conversations were cordial. She is hopeful to resolve the issues to benefit both the County and Odyssey.

Executive Van De Hey presented Chuck Orenstein with a certificate of achievement in excellence.

Executive Van De Hey asked for support of Resolution No. 36-62000 "Appropriate funds for Community Park Capital Project-Entryways off of CTH Y into Community Park and Expo Center/Fairgrounds" and Resolution No. 37-62000 "Appropriate funds for Outdoor Warning Siren System Upgrade Capital Project".

WHEREAS, at the present time, the Winnebago County Department of Human Services has estimated that approximately 44 children are in care for whom termination of parental rights is a potential option; and

WHEREAS, it is unlikely because of time constraints and scheduling problems that the Winnebago County Corporation Counsel's Office could file many more termination of parental rights actions then that office is averaging per year; and

WHEREAS, the Director of the Department of Human Services and the Winnebago County Corporation Counsel have agreed that a potential solution to this problem would be to retain outside counsel to represent the County in some of these matters in addition to those cases which are being handled by the Corporation Counsel; and

WHEREAS, the Corporation Counsel has indicated that it would be possible to contract with an attorney to represent the County in 10 additional termination of parental rights actions per year for the sum of \$25,000; and

WHEREAS, the average cost per month of placing a child in foster care is \$876.00 per month and said cost is eliminated once the child's parental rights are terminated in that said costs are assumed by the State of Wisconsin until the child is adopted; and

WHEREAS, the speeding up of the termination of parental rights process would result in savings to Winnebago County.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the transfer of \$25,000 from the Winnebago County Department of Human Services Foster Care Placement Fund to the Winnebago County Corporation Counsel's Office Legal Services Fund for the purpose of retaining counsel to assist the Corporation Counsel in termination of parental rights matters.
