ADJOURNED SESSION COUNTY BOARD MEETING TUESDAY, SEPTEMBER 26, 2000

Chairman Joseph Maehl called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Rankin. The following 31 Supervisors were present: Kollath, Barker, Savas, Maehl, Koziczkowski, Klitzke, Widener, Lauson, Pech, Leschke, Green, Madison, Reilly, Sundquist, Wingren, King, Norton, Hert, Nielsen, Robl, Eichman, Kline, Spanbauer, Sievert, Arne, Diakoff, Brennand, Albrecht, Schaidler, O'Brien and Metzig. Excused: 6 – Rengstorf, Griesbach, Finch, Egan, Kramer and Rankin, Absent: 1 – Crowley.

Motion by Supervisor Robl and seconded to act on Resolution No. 84-92000 before Resolution No. 74-92000 and to adopt the agenda as amended. CARRIED BY VOICE VOTE.

COMMITTEE REPORTS

Supervisor Schaidler reported that the first of two informational meetings on the proposed Comprehensive Land Use Plan was held on Thursday, September 21 at the Coughlin Center. He stated that It was well attended and he encouraged the Board to attend the second meeting, which will be held at the Coughlin Center on Wednesday, October 4, 6:30 to 9:00 p.m. Supervisor Schaidler stated that the concerns expressed by the Towns of Nepeuskun and Winneconne, as well as others, will be addressed at that meeting.

Supervisor Madison reported that he attended the Wisconsin Bicycling Federation conference in Neenah. He stated that even though he did not attend the conference as a Winnebago County Supervisor, he still acted as an advocate for Winnebago County and was surprised to see that Oshkosh was not included in the Federation's Fox Cities map. Supervisor Madison stated that he would like to be involved in getting Winnebago County included in such activities and wondered how to go about it. Supervisor Lauson encouraged Supervisor Madison to attend the Parks & Recreation Committee's meetings to discuss various

trail and bicycling issues.

Supervisor Robl reported that a public hearing was held on August 29th regarding the replacement of bridges on County Trunk D in the Town of Poygan and on County Trunk E in the Town of Rushford. These bridges will be replaced in 2002.

Supervisor Spanbauer reported that the Fox Cities Green Ways has developed a system of bike trails in the north end of Winnebago County that connects with Outagamie County. He also reported that the Town of Neenah has a bike trail committee that has helped to develop a trail along County Road CB. Supervisor Spanbauer has suggested to the Parks & Recreation Committee that Winnebago County consider forming a citizen-involved trail sub-committee to study this issue.

Supervisor Sievert reminded the Board that the WIOUWASH Trail is also available to bicyclists. She stated that the Town of Clayton is trying to locate a source for grant money to fund a tunnel under the intersection of State Highways 10 & 45 for the trail. The Department of Transportation will pay 75% of the estimated \$300,000 cost for the tunnel, but the Town of Clayton is looking for a source for the remainder of that cost. Supervisor Sievert asked that anyone with grant information contact her. Chairman Maehl suggested that the Town of Clayton contact the Wisconsin Counties Association.

Supervisor Barker stated that Linda Stoll, Executive Director of the Fox Wolf Basin 2000, would be an excellent contact person regarding bicycle and recreation trails.

Supervisor Barker asked that anyone with items for the Legislative Committee contact her so it can be put on the next agenda.

Motion by Lauson and seconded to approve the proceedings from the August 15, 2000 County Board meeting. CARRIED BY VOICE VOTE.

COUNTY EXECUTIVE'S REPORT

Executive Van De Hey reported that the budget books have been distributed to the Board. She commended and thanked everyone involved in the budgeting process for their cooperation.

Executive Van De Hey stated that the budget shows the areas where the county is effected by the problem of unfunded mandates. These areas are primarily in the court system, juvenile aids and Park View Health Center.

Executive Van De Hey explained that borrowing is down to approximately \$1,000,000. And, because

there has been a 5.3% increase in property values, the tax rate has stayed the same with an additional \$1.9 Million in expenses.

Executive Van De Hey reported that unfunded mandates will be discussed at greater length during the budget session in October.

Executive Van De Hey stated that the Kettl Commission should be completed in November and making their final recommendations.

Executive Van De Hey reported that new contracts with Odyssey and Country USA will be presented to the Board in October.

Executive Van De Hey asked that the Board support the following resolutions: No. 74-92000, "Authorize Transfer of \$17,549 from Winnebago County General Fund Balance to Expo Building – Roof Repair Account: Parks Department"; No. 87-92000, "Request Winnebago County Elderly and Disabled Transportation Coordinating committee be Renamed as Winnebago County Specialized Transportation Council"; and No. 90-92000, "Authorize Lease Between Winnebago County and Beechwood Plaza Hotel of Oshkosh, L.L.C."

CHAIRMAN'S REPORT

Chairman Maehl welcomed Supervisor Savas back after her illness-related absence. Supervisor Savas thanked the Board for all their cards, thoughts and prayers and stated how happy she was to be back.

Chairman Maehl reported that Supervisor Kramer is still hospitalized and suffering from major complications. He asked that the Board keep Supervisor Kramer in their thoughts and prayers.

Chairman Maehl asked that the Board read the letter that was placed on their desks from Karen Ordinans, Milwaukee County Board Chairperson, regarding Winnebago County's WCA Intergovernmental Transfer Program fee arrearage. In her letter, Ms. Ordinans states that this arrearage could cause the 2001 WCA Convention to be held in another county. Chairman Maehl urged the Board to reconsider their position on paying this fee to the WCA.

Chairman Maehl reported that the Wisconsin Tourism Bureau presented the Lake Winnebago WITBC with a \$20,000 grant to promote tourism in Winnebago County.

Chairman Maehl read a letter from scholarship recipient Tara Shea thanking the Board for presenting her with a \$1,000 scholarship. She stated what a wonderful scholarship program it is and how it helped her to gain more understanding about county government.

NOW, THEREFORE, BE IT RESOLVED, by the Winnebago County Board of Supervisors, that the 1998-2000 collective bargaining agreement between Winnebago County and the Winnebago County Highway Department Employees Union, Local 1903, AFSCME, AFL-CIO be, and hereby is modified to incorporate the terms of settlement, set forth as follows:

- 1. The contractual language regarding group health insurance be modified to recognize the Winnebago County PPO as the standard plan.
- 2. Benefit reductions in the standard plan will not be implemented without the written consent of the Union.
- 3. The parties agree that Unity HMO will not be continued beyond September 30, 2000.
- 4. The County will increase the pay of all positions across-the-board by \$0.50 per hour effective October 1, 2000.
- 5. The County will make long term disability insurance available for all represented employees at no cost, effective December 1, 2000.
- 6. The Union accepts the terms of settlement, outlined above, as full and final settlement of all grievances filed on behalf of employees represented by AFSCME, Local 1903 and also accepts the terms of insurance plan renewal and premium cost sharing offered by Winnebago County for the renewal period commencing October 1, 2000.

ORDINANCE NO. 83-92000: Amend Chapter 13, sec. 13.14 of the General Code of Winnebago County Animal Waste Management

WHEREAS, it is well documented and widely recognized that nutrients and organic matter from mismanaged or misapplied livestock waste are major contributors to the water quality degradation in the rivers, lakes and streams throughout Wisconsin, including those in Winnebago County; and

WHEREAS, the degradation of the water resources in Winnebago County imposes a threat to the environment, health and economic welfare of the citizens of the county; and

WHEREAS, the Winnebago County Land Conservation Committee, in an effort to further protect the water resources of Winnebago County while limiting the financial exposure to Winnebago County.

NOW, THEREFORE, BE IT ORDAINED by the County Board of Supervisors of the County of Winnebago that Chapter 13, Sec. 13.14 of the General Code of Winnebago County be amended to read as follows:

13.14 ABANDONMENT

- (1) The owner and/or operator of any existing animal waste storage facility in Winnebago County shall not abandon nor otherwise make said facility inoperative prior to preparing an Abandonment Plan. The plan must be prepared in accordance with USDA, NRCS Technical Standard 313 and approved by the Winnebago County Land & Water Conservation Department.
- (2) Should the local Health Officer determine that any animal waste storage facility constitutes a human health hazard pursuant to Section 254.59, Wisconsin Statutes, Winnebago County reserves the right to abate said human health hazard and to assess costs pursuant to Section 254.59, Wisconsin Statutes.

BE IT FURTHER ORDAINED by the County Board of Supervisors of the County of Winnebago that this ordinance shall become effective the date following the date of publication.

WHEREAS, the Coroner has requested that your undersigned Committee amend Section 5.04 of the General Code of Winnebago County so as to create a \$30.00 fee for the signing of death certificates by the Coroner and a \$50.00 fee for applications for disinternments; and

WHEREAS, your undersigned Committee believes that said fees are reflective of the actual necessary costs of providing said services and are in line with those fees charged by other counties within the State of Wisconsin.

NOW, THEREFORE, the County Board of Supervisors of the County of Winnebago does ordain as follows:

That Section 5.04 of the General Code of Winnebago County be amended to read as follows:

- 5.04 (1) AUTHORITY. This ordinance is adopted pursuant to the authority provided under Section 59.36 and 69.18(2)(d)(3), Wisconsin Statutes.
- (2) CORONER'S FEES
 - (a) CREMATION PERMIT FEE. A fee of \$60.00 is hereby established for the viewing of a body by a coroner and the issuance of a permit as a precedence to cremation, pursuant to that procedure outlined in Section 979.10, Wisconsin Statutes. The estate of the deceased shall be liable for payment of said fee, unless another party agrees in advance, in writing, to be responsible for the payment of said fee.
 - (b) A fee of \$30.00 is hereby established for the signing of a Certificate of Death by the Coroner. The estate of the deceased shall be liable for payment of such fee, unless another party agrees in advance, in writing, to be responsible for the payment of said fee. Pursuant to Section 69.18(2)(d)(3), Statutes, said fee shall not be charged if the deceased is indigent. Indigency shall be established pursuant to standards adopted by the State Public Defender's Office.
 - (c) DISINTERNMENT FEE. A fee of \$50.00 is hereby established for the application of disinternment of a decedent's corpse. Said fee shall be paid at the time of application by the applicant. Said fee shall not be applicable when a valid court order for disinternment has been

issued.

(3) PAYMENT OF FEES. All fees paid pursuant to this ordinance shall be paid to the office of the Winnebago County Treasurer.

BE IT FURTHER ORDAINED by the County Board of Supervisors of the County of Winnebago that this ordinance shall take effect as of November 1, 2000.

RESOLUTION NO. 90-92000: Authorize Lease Between Winnebago County and Beechwood Plaza Hotel of Oshkosh, LLC

WHEREAS, Beechwood Plaza Hotel of Oshkosh, LLC has made a proposal to lease the site of approximately 205,000 square feet from Wittman Regional Airport at a cost of \$.32 per square foot or initially \$65,600 per year for the purpose of constructing a commercial hotel, meeting and conference area, banquet hall, restaurant, garden and lounge upon said premises; and

WHEREAS, Winnebago County has entered into a tentative agreement, subject to approval by the Winnebago County Board of Supervisors and the Winnebago County Executive for a twenty-five (25) year lease with said entity with three five-year options for extension; and

WHEREAS, rent would be ajusted every three years, to the average of consumer price index over the three year period plus 1%; and

WHEREAS, final execution of said lease shall be subject to rezoning by the City of Oshkosh of the property from industrial to commercial and any storm water run off requirements that may be placed upon the property; and

WHEREAS, your undersigned Committee recommends the approval of said lease and its execution by Winnebago County.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the execution of a lease between Beechwood Plaza Hotel of Oshkosh, LLC and Winnebago County for 205,000 square feet of property at Wittman Regional Airport at an initial rate of \$.32 per square foot for an initial twenty-five (25) year term with an option for three five-year additional terms. (A copy of said lease may be obtained upon request from the Winnebago County Corporation Counsel or the Winnebago County Airport Director.).
