# COMMUNICATIONS, PETITIONS, ETC.

Notice of Claim from Victoria M. Frank for compensation for injuries sustained in a fall at Wittman Regional Airport was referred to the Personnel & Finance Committee.

A note was received from Mike Elder & his family thanking the Board for their remembrance at the passing of his mother.

#### COUNTY EXECUTIVE'S REPORT

Executive Van De Hey reported on the recent Intra-Governmental Agreement for recycling between Winnebago, Brown and Outagamie Counties. In the agreement, Brown County will close their facility; Outagamie County will process paper from Outagamie and Winnebago County; and Winnebago County will process containers for all three counties. Executive Van De Hey hopes this can be a prototype for other counties to follow.

Supervisor Norton asked Executive Van De Hey when she thought the space needs study would be finished. She said it was about one month away. Supervisor Norton heard Winnebago County was interested in City Hall. Executive Van De Hey said City of Oshkosh had done a space needs study that should also be out in about a month. She hopes the two can collaboratively plan their needs. Supervisor Sundquist said the Public Safety Building Board had an appraisal done on the Public Safety building. This should be available later this week.

Motion by Supervisor O'Brien and seconded to approve. CARRIED BY VOICE VOTE.

#### COUNTY BOARD CHAIRMAN'S REPORT

Chairman Maehl extended congratulations to Len Leverence, Director of Solid Waste and to the Solid Waste Management Board for their part in the Intra Governmental Agreement for recycling.

Chairman Maehl referred the supervisors to an invitation they had received in their packet entitled "Getting It Together With Stormwater-Tools, Rules & Smart Growth" to be held February 27-28, 2001 at the Green Bay Radisson. He encouraged any interested supervisors to attend. Chairman Maehl also referred the supervisors to a variety of information they received in their packet and hoped they would share it with their constituents. He hoped everyone exercised their privilege to vote today.

Chairman Maehl reported there have been 10 supervisors appointed to a variety of NACo committees including Administration and Organization, Human Services, Personnel and Labor, Environmental, Taxation, Public Safety, Public Works and Transportation.

Chairman Maehl referred to a letter that was received from one of the scholarship recipients thanking them for the financial assistance. Of the recipients of the scholarships, one had a 4.0, two had 3.56, one had 3.0, one had 2.65 and one had 2.6 grade point averages.

Chairman Maehl reported he had attended both of the funerals for the Park View Health Center nurses who had been killed in the recent car accident.

Chairman Maehl reported Supervisor Crowley had been doing fine until she fell this last week and cracked her ribs.

Chairman Maehl extended birthday wishes to Supervisor Nielsen and County Clerk, Sue Ertmer, who is down stairs counting ballots. He also extended anniversary wishes to Pat Rabe, Deputy Clerk, for her 22 years with the County.

Chairman Maehl asked Supervisor Egan to give a little background on the Park View roof issue. Supervisor Egan said the roof had been in the 5 year 1998-2002 Capital Plan. The County Board at that time had approved unanimously \$500,000 for the roof work. The work was to be done in April, 2000. Approximately 1 ½ years ago an outside consultant had been hired to look at roofs and get qualified bidders. Supervisor Egan said last spring he was told Park View really needed a roof. The go ahead was given. Last fall, September or October, the committee said to get the roof done any way possible. About one month ago the bids were received, but there was a problem with the RFP's and they had to be thrown out. He feels the Board should have no blame in the delayed process.

## FAIR ASSOCIATION PRESENTATION

Tom Egan, Fair Association President, gave a brief presentation on the Winnebago County Fair. Over the last two to three years, at least half of the membership of the Fair Association has changed. Members of the Fair Association who were in attendance tonight were Roman Bauer, Secretary; Jim Cross; Paul Jandrin; Eric Kolb and Don O'Connell.

On March 8, 2001 the Fair Association will be holding a Media Day to let everyone know what will be taking place at the Fair this year. On April 25, 2001, the District Meeting will be held at the fairgrounds.

Mr. Egan reported there were 1303 junior exhibitors with 3951 entries that paid out \$10,644.75. The open class had 173 exhibitors with 619 entries that paid out \$1154.50. Over \$28,000 could have been paid out. He also stated there would be a different carnival, Murphy Brothers, coming directly from the State Fair.

Mr. Egan referred to a booklet that had been given to each supervisor. The booklet was prepared by Phillips Tax & Accounting, Inc. of Oshkosh, the Fair Associations' new accountant. He referred the supervisors to Exhibit 1, which was the balance sheet for the Fair Association. A major change that occurred was the deletion of a manager/president and was replaced with a president and separate treasurer.

Mr. Egan brought membership cards, which are \$20, and will give admission to the fair, grandstand and parking. Tuesday night will be stock car racing, Wednesday will be local tractor pull, Thursday will be a rodeo, Friday will be country night, Saturday afternoon will be Christian, Saturday will be rock night, Sunday afternoon will be tractor pull and Sunday night will be demolition derby.

Supervisor Eichman asked if this document was an audit of the Fair Association books. Mr. Egan said this was a report, not an audit. Supervisor Rengstorf wanted a hand given to the Fair Association for a job well done.

# **COMMITTEE REPORTS**

Supervisor Kline reported the Oshkosh Chamber of Commerce and University of Wisconsin-Oshkosh are sponsoring a special event. This is a public forum with Don Kettl and Representative Gregg Underheim that will be held, Tuesday, March 27, 2001 from 11:30 – 1:30.

Supervisor Rengstorf reported on a workshop that he attended with Sheriff Brooks and Venture Architects. He was very impressed with the way the two worked together.

Supervisor Barker requested all supervisors on the Legislative Committee look at the letter that had been placed on their desks. The February meeting that had been rescheduled, has now been cancelled. The March meeting will be Monday, March 26<sup>th</sup>. Anyone having agenda items should get them to her by Thursday, March 15<sup>th</sup>. Supervisor Barker suggested the use of a calendar that would have dates of upcoming meetings. This would enable those looking to schedule meetings a better idea of what dates and times are available. She asked each supervisor to see if they had any ideas regarding this.

Supervisor Eichman reported attending a conference in New Mexico on preventing overcrowding in jails. He stated Winnebago County is not alone with overcrowding problems.

#### **DUNCAN HENDERSON, AIRPORT DIRECTOR, CAPITAL PROJECTS**

Duncan Henderson, Airport Director, spoke on two potential capital projects. The first is a replacement of a fire-fighting vehicle and the second is construction of a traffic control tower.

Winnebago County has its own fire department at the Airport. It has three fire trucks:

- The small truck 114 is a 1995 truck;
- The medium size truck 214 is a 1975 Oshkosh M1000. This is the one to be replaced;
- The larger truck 314 is a 1985 Oshkosh DA 1500

Mr. Henderson said the 1975 Oshkosh M1000 is obsolete and does not fit into any of the Federal Aviation Administration categories. Mr. Henderson said they have available to them a 1985 Oshkosh T50 for \$125,000. This would be purchased from Crash Rescue Equipment Service who handles sales for all used rescue equipment. The request for the replacement of this truck had been put into the Capitol Improvement Plan. The truck became available from a neighboring airport. A new truck of this type would cost \$350,000. Crash Rescue Equipment Service is picking up the truck next month. If the County lets them know Winnebago County wants to purchase this vehicle, they will put it ahead in the refurbishing line and it will be ready for EAA this year.

The second project is construction of a traffic control tower. Wittman Airport owns and operates the structure of the tower. The tower was built in the 1950's, then moved in the 1960's. It was determined the location was not high enough and was placed on a hill. It now has a basement under it. As a result of numerous problems, a study was commissioned in 1997 and was done by Omni Associates which found the tower was safe; however, it has a number of deficiencies. Moving the building caused corrosion to the slab as well as the steel beams that were holding up the slab. One of the beams is sagging and there is cracking in the foundation. The air-conditioning units are deficient, as well as the water system, which prompts the need to purchase drinking water. The holding tank is inadequate in its size as is the electric system. Although the heating system is operational, if it would become inoperable, it would need to be replaced for it is obsolete and there are no replacement parts available. The tower is too short, too small and in an inconvenient location. It is a 65-foot structure without an elevator.

There are three alternatives:

- 1. Do nothing;
- 2. Repair the tower gradually;
- 3. Replace it.

The normal process for building a new tower is for the local community to totally fund the construction including equipment. Through a series of events, Winnebago County has the opportunity to get State and Federal funding for this project. About three years ago the lease was up with the Federal Aviation Administration. Rather than entering into another five-year lease, Mr. Henderson felt it better to do a one- year lease so if anything catastrophic occurred, there would not be large dollars to be spent for repairs. The one-year lease is no longer acceptable. Last year the Federal Aviation Administration and the Wisconsin Bureau of Aeronautics agreed to participate in the funding for a new air traffic control tower.

Winnebago County s' share would be 20% of the structure. The estimate for the construction is about \$2 million. The Federal Aviation Administrations' participation would be the installation of computers, radios and equipment inside or approximately \$1.5 million. Six months ago a phase one feasibility study was commissioned to determine the exact location and cost of the tower. Three months ago the Wisconsin Bureau of Aeronautics announced it wanted to have a ribbon cutting for the construction of the new control tower at this years EAA Convention. Mr. Henderson stopped the progress of the project until appropriation for Winnebago County's portion could be approved. This project is in the Capital Improvements Plan and had been scheduled for 2002, but because of funds being available, is being requested in 2001.

# RESOLUTION NO. 154-22001: Transfer \$15,000 from General Fund balance to the County Road Maintenance Department "Snow Removal" account to cover overage related to severe weather in November and December 2000.

WHEREAS, Winnebago County has experienced extreme winter weather conditions during the months of November and December of 2000 and,

WHEREAS, the unusual weather conditions forced the Winnebago County Highway Department to expend its entire winter maintenance budget of \$515,000 and,

WHEREAS, the winter maintenance budget was exceeded by approximately \$145,700 and,

WHEREAS, the amount of \$130,000 from general maintenance was used by the department to offset the deficit and,

WHEREAS, an additional \$15,000 is needed to fund the remaining deficit,
