## PUBLIC HEARING

Dee Durkee, Oshkosh, stated that the U.S. government may need to exercise some tolerance and restraint in dealing with the countries involved in the September 11 terrorist attacks.

Charles Farrey, Town of Vinland Supervisors, spoke in support of Amendatory Ordinance No. 12, which would amend the Town of Vinland Zoning Ordinance.

## COMMITTEE REPORTS

Supervisor Barker reported that the September Legislative Committee meeting has been cancelled. Their next meeting will be on October 22. If anyone has an agenda item for that meeting, they should get it to Supervisor Barker by October 11.

Supervisor Rankin reported that he was happy to see a bike trail being constructed all along old Highway 21.

Supervisor Rankin reported that one of this year's Winnebago County scholarship recipients, Cole Ruby, was selected by the U.S. Elks Foundation as their top student. As their top student, Cole will receive an annual $\$ 15,000$ scholarship for four years. Cole is a political science major at the University of Wisconsin-Oshkosh, and he plans to study law and go into politics.

Supervisor Pech congratulated Supervisor Mark Nielsen and his wife, Siegried, on the birth of their daughter.

## CHAIRMAN'S REPORT

Chairman Maehl reported that the WCA Convention that was held in Winnebago County last week was very successful. He stated that on Tuesday, September 11, following the terrorist attacks, it was decided to continue with the convention and officers' installation banquet, even though a number of the attendees needed to go back to the respective counties.

Supervisors Barker and Rengstorf reported that very successful spouse tours were conducted in the Neenah/Menasha and Winneconne areas.

Supervisor Sundquist thanked Chairman Maehl for leading the convention in singing "America the Beautiful" at the banquet.

Chairman Maehl extended "happy birthday" wishes to Supervisors Sundquist, Kline, Madison and

Savas. He also thanked Supervisor Savas for her contribution to the county scholarship fund.

## BOB WURTZ, PRESIDENT OF AEGIS CORPORATION

Bob Wurtz, President of AEGIS Corporation presented Winnebago County with a dividend check in the amount of $\$ 149,474.00$. Mr. Wurtz reported that this is the largest single dividend check that has ever been presented.

Mr. Wurtz recognized Supervisor Brennand, who represents Winnebago County on the Wisconsin County Mutual Insurance Corporation Board of Directors and serves on their underwriting committee. He commended Supervisor Brennand on his service on the Board of the Directors.

## COUNTY EXECUTIVE'S REPORT AND EXECUTIVE CAPITAL IMPROVEMENTS PROGRAM

Executive Van De Hey reported that appropriate actions were taken at the county on September 11 following the terrorist attacks. She reported that a joint command post was established in the emergency operations center and the courthouse and safety building were secured with single points of entry/exit.

Executive Van De Hey reported that Winnebago County is financially sound and has retained its Aa2 Moody's rating.

Executive Van De Hey asked that the Board review the packet of information that was placed on their desks regarding mandates. She stated that unfunded mandates have been a problem for Winnebago County for a very long time. She would appreciate suggestions from the supervisors on how to address this issue.

Executive Van De Hey then read an introductory letter and went through her Executive Capital Improvements Program 2001-2005. In her introductory letter, Executive Van De Hey explains that items listed in the capital improvements program must still come before the Board for final approval and appropriation of funds.

Executive Van De Hey went over a number of the annually suggested projects, as well as, the "required borrowing for Levy Supported Projects" for each year. The borrowing totals and some of the larger projects for each year are as follows:

## ELLEN SHUTE, DEPARTMENT OF HUMAN SERVICES PRESENTATION OF FUNDING SOURCES

Supervisor Koziczkowski introduced Ellen Shute, Financial Support Division Manager of the Human Services Department, who gave a power point presentation on the Human Services Department to the Board.

Ms. Shute's presentation explained that the Human Services Department was established in 2000, after the County Board approved the merging of the Social Services and Community Programs Departments, the Commission on Aging and Juvenile Court Intake.

Ms. Shute explained that the Human Services Department's mission is, "to provide quality services that focus education, prevention, protection and personal empowerment through respect for, and in partnership with individuals, families and the community."

Ms Shute described the five main service divisions of the Human Services Department. Those divisions are:

- Administration Services
- Behavioral Health Services
- Child Welfare Services
- Financial Assistance Services
- Long Term Support Services

The State of Wisconsin defines the people who receive services from the Human Services Department divisions as "consumer groups" and breaks them down as follows:

- Abused and Neglected Children
- Adults \& Elderly
- Alcohol and Other Drug Abusers
- Children and Families
- Delinquent \& Status Offenders
- Developmental Disabilities
- Mental Health
- Physical and Sensory Disabled
- Persons Transitional from Public Financial Assistance to the Workforce

Ms. Shute explained that the Human Services Budget for the year 2001 is $\$ 49$ Million and is divided as follows: $65 \%$ - contractual services; $26 \%$ county labor; and operating expenses \& interfund services $-9 \%$. Ms. Shute also provided the Board with detailed information on divisional expenses, program services and revenue sources.

## FARMLAND PRESERVATION PROGRAM - SUPERVISOR JOHN SCHAIDLER; JERRY BOUGIE, COUNTY PLANNING DEPARTMENT; \& KEITH FOYE, DATCP

Supervisor Schaidler introduced Jerry Bougie, who presented a power point presentation on rescinding the Farmland Preservation Program in Winnebago County.

Mr. Bougie explained that at the direction of the Planning \& Zoning Committee, the Planning \& Zoning Departments have studied the idea of dropping the Farmland Preservation Program in Winnebago County. Mr. Bougie explained that this option is being explored because of a number of program "shortcomings". Those shortcomings include:

- The Farmland Preservation Plan has not been followed or updated since it was adopted in 1982
- Farmland is not recognized as a "natural resource that provides economic and employment benefits"
- Landowners have little incentive to stay in the program
- Some of the state's Farmland Preservation Program laws are not being followed
- If a landowner gets out of the program, statutory provisions requiring a payback of tax credits are not enforced
- County Board does not support the Planning \& Zoning Committee's recommendations to deny zoning requests to remove $\mathrm{A}-1$ zoning

Mr. Bougie stated that the main purpose of the Farmland Preservation Program is to identify agricultural land in Winnebago County and to find ways to preserve it. Also discussed in Mr. Bougie's presentation was the county and state's program adoption and certification timeline, acres in A-1 zoning (Farmland Preservation) by township; property tax credit history report; and the tentative processes and timetable to rescind the program.

Potential long-term impacts of rescinding the program are:

- More land is available for development
- Landowners have more options on the use of their land
- Market will determine whether development in rural areas will increase or decrease
- Landowners will lose tax credits
- Lose ability to enforce soil conservation plans

Mr. Bougie, Supervisor Schaidler, Mr. Foye and David Schmidt answered questions from the Board.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it supports the

President of the United States, as he works with his national security team to defend against additional attacks, and find the perpetrators to bring them to justice.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it recommends to its citizens to support relief efforts by giving blood at the nearest available blood donation center.

## ORDINANCE NO. 302-92001:

## Amend Section 2.01 of the General Code of Winnebago County: Supervisory Districts Created

WHEREAS, the Winnebago County Board of Supervisors previously adopted a tentative plan and submitted tentative plan to the cities, towns and villages of Winnebago County; and

WHEREAS, the cities, towns and villages of Winnebago County have adopted and created Ward Maps and have returned those Ward Maps to Winnebago County; and

WHEREAS, your undersigned Committee has reviewed said Ward Maps and the tentative plan of Winnebago County and hereby recommends the following final Supervisory District Plan for Winnebago County

NOW, THEREFORE, the County Board of Supervisors of the County of Winnebago does ordain as follows:

That Section 2.01 of the General Code of Winnebago County be amended to read as follows:

## THE GOVERNING BODY - CHAPTER 2

### 2.01 SUPERVISORY DISTRICTS CREATED

(1) Pursuant to Sec. 59.03 , Wisconsin Statutes, there is hereby created a total of 38 Supervisory Districts for Winnebago County wherein 38 County Supervisors shall be elected.
(2) The numbering of each Supervisory District and the boundaries thereof are as follows: (See Exhibit A attached)
(3) This section of the Code shall take effect and be in force upon passage and publication to cover the election of Winnebago County Board Supervisors to be elected in the Spring of 2002 and thereafter until further action of this County Board.
(4) The Chairperson of the county Board shall file a certified copy of this Ordinance with the Secretary of State to satisfy the requirements of law and the same shall constitute the final districting plan of Winnebago County.
(5) The terms "boundaries", "boundary limits", "boundary line limits", and "boundary lines" as used in "Exhibit A" of this Ordinance shall be defined as the boundaries of towns, villages and cities within Winnebago County as in existence on August 1, 2001.
(6) References to streets, roads, avenues, highways, railroad tracks and other fixtures referred to as district boundaries in this Ordinance are defined as the location of such fixtures as of August 1, 2001.

## SUPERVISORY DISTRICTS

## (1) DISTRICT 1:

Those parts of the City of Menasha and the Town of Menasha which lie within the following area: Commencing at the intersection of the centerline of Frederick Street and Little Lake Butte des Morts.
