Supervisor Eichman thanked the Board for their well wishes as he recovered from his recent heart attack. He also commended the excellent staff at Mercy Medical Center.

Supervisor Widener reported that Park View Health Center has passed both state and federal inspections without any violations. This is an outstanding accomplishment and he commended Marge Rankin and her staff at Park View Health Center.

Supervisor Schaidler reminded the Board about the November 12 public meeting on the comprehensive land use plan. It will be held from 5:00 to 9:00 p.m. at the Village Pub in Winneconne. He urged the Board to attend this very important meeting.

JAIL PROJECT PRESENTATION - LT. CHERYL MICHLER & SHERIFF BROOKS

Chairman Maehl introduced Lt. Cheryl Mischler and Sheriff Michael Brooks who presented a video presentation on the progress of the new jail/Sheriff's Department project. The presentation included information on the transition team, their mission statement and their personal goals. Members of the transition team are: Lt. Cheryl Michelle Anthes, Becky Borowitz, Jesse Jensen, Chris Schlichting, Carla Schreiber, Kim Thomson and Dennis Zarling. The transition team has also worked with and relied on: the Judiciary & Public Safety Committee, the Facilities and Property Management Committee, Sheriff Brooks and other agencies from around the U.S.

Lt. Mischler explained that on Mondays, each team member receives a weekly work plan. Some of the major activities that they have undertaken are the identification of task forces, HONI training, scenario development, a monthly newsletter, a master facility schedule and policies and procedures.

Photos of the construction site and structure were also included in the presentation.

Sheriff Brooks reported that he believes this project will be coming in at approximately \$2.5 Million under budget. He commended Lt. Michler and the transition team on their hard work and efforts to keep costs down.

Jean Conover, 4710 Bay View Lane, Oshkosh, expressed her concerns regarding "the interpretation and administration of the Children In Need Of Protective Services (CHIPS) law" in relationship to the Hmong population in Winnebago County. She would also like to see better use of language interpreters when members of the Hmong population need to deal with the police and Human Services employees. 2003 ANNUAL BUDGET PRESENTATION

Executive Van De Hey began the presentation of her 2003 annual budget. In the Power Point presentation, Executive Van De Hey noted:

- Winnebago County's valuation growth for 2002 was 6.21%
- Resulting in \$2,797,000 of additional revenue at the 2002 tax rate
- This additional revenue was used up by the debt service, a decrease in projected investment income, significant increases in costs associated with child welfare and long-term support, and dramatic increases in employees' health insurance costs

Executive Van De Hey explained that these significant changes made it difficult to maintain a "flat total tax rate." However, the proposed 2003 operating rate was reduced by \$.10 per \$1,000 from \$4.48 in 2002 to \$4.38 in 2003.

Other areas discussed in Executive Van De Hey's presentation were:

- Nine-year recap of the county's operating levy and debt service levy
- Nine-year comparison of General Fund balances
- Information on labor costs
- Cost analysis of new and replacement employee positions
- Employee positions budgeted in 2002 and eliminated in 2003
- Tax levy by governmental division--administration, planning & environment, education, culture and recreation, non-divisional and public safety
