She also reported that the county will have a booth at this year's county fair. She asked that individual Supervisors consider spending time at the booth to help inform the public about Winnebago County.

WHEREAS, the preferred alternatives were developed and selected within the context of a public involvement process, with input and review from numerous stakeholders at informational meetings and briefings; and

WHEREAS, the preferred alternatives developed as part of the USH 41 corridor study were deemed to provide the most benefit for the traveling public and the state's transportation system, best meeting the needs of the growing urbanized areas and increasing traffic volumes.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby expresses its support for the findings and recommendations from the USH 41 Corridor Study from Neenah to Oshkosh, as presented by the Wisconsin Department of Transportation.

WHEREAS, the Wisconsin Department of Agriculture, Trade and Consumer Protection has contracted with the USDA Farm Services Agency to administer the Wisconsin Conservation Reserve Enhancement Program (CREP); and

WHEREAS, this program offers \$240 million dollars in federal and state payments to landowners, in 51 eligible counties throughout Wisconsin, who agree to take land out of crop production and to install water quality protection practices, such as streamside-vegetative buffers, grassed waterways and wetland restorations; and WHEREAS, of an estimated \$3.5 million in landowner incentive payments expected to be available in

Winnebago County, \$600,000 comes from the state in bonded funds that can only be administered by the County; and

WHEREAS, pending County participation in the program, your Personnel & Finance Committee has approved, a budget transfer of \$50,000 in unbudgeted state CREP funds into the Land & Water Conservation Dept. 2002 budget to account for landowner payments projected to be made during the remainder of the year; and

WHEREAS, the Conservation Reserve Enhancement Program is only available to landowners in those Counties that, by signed contract, agree to assist the Wis. Dept. of Agriculture, Trade and Consumer Protection in the administration of the state portion of the program.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that the Land Conservation Committee is hereby authorized to carry out its statutory powers, as defined in Chapter 92.07, Wis. Stats., for the purpose of providing administrative services in the Conservation Reserve Enhancement Program according to the contract, now authorized by this Board, with the Wisconsin Department of Agriculture, Trade and Consumer Protection.

BE IT FURTHER RESOLVED that the Land & Water Conservation Department, under jurisdiction of the Land Conservation Committee, shall provide administrative services to the Conservation Reserve Enhancement Program within existing and future budget limits, as established by the County Board of Supervisors.

BE IT FURTHER RESOLVED that to help offset costs the County may incur in this program, service fees be charged to program participants according to the fee schedule in Attachment 1.

BE IT FURTHER RESOVED by the Winnebago County Board of Supervisors that it hereby authorizes that the sum of \$50,000 be transferred from the CREP operating Grant Fund to the CREP Operating Payment Fund of the Land and Water Conservation Department for the provision of the foregoing services.

ORDINANCE NO. 26-52002:

Amend Section 3.01(4) and 3.07 of the General Code of Winnebago County (Procedures for Competitive Purchasing and Procedures Regarding Capital Outlay)

WHEREAS, Section 3.07 of the General Code of Winnebago County: Procedure for Competitive Purchasing by Winnebago County Departments, et al, ordains a procedure for the competitive purchase of goods by Winnebago County Departments; and

WHEREAS, said ordinance ordains procedures which are far in excess of what is required by statute with regard to the purchase of goods and services by Winnebago County; and

WHEREAS, the present ordinance presently results in Winnebago County unnecessarily taking formal bids with regard for the purchase of various goods and services, despite the fact that such formal bidding is not required by Wisconsin Statute, thus resulting in unnecessary expenses to Winnebago County in formal bid preparation costs and publishing costs each year; and

WHEREAS, in the opinion of your Finance Director and Purchasing Agent, the present ordinance, because of the formal restrictions within it, fails to guarantee Winnebago County the lowest price or the best goods and

services in many instances; and

WHEREAS, the attached proposed amendment of Section 3.01(4), General Code of Winnebago County, and as a consequence, the amendment of Section 3.07, General Code of Winnebago County, would provide a more streamlined purchasing procedure which would remove unnecessary bureaucratic requirements and would be more likely to ensure that taxpayers receive the best price for those goods and services purchased by Winnebago County.

NOW, THEREFORE, BE IT ORDAINED by the County Board of Supervisors of the County of Winnebago that it hereby does amend Section 3.01(4) of the General Code of Winnebago County and Section 3.07 to read as follows:

FINANCE AND TAXATION - CHAPTER 3

3.01 ADMINISTRATION AND COUNTY BUDGET....

- 3.01(4) CAPITAL OUTLAY. (a) Capital outlay **expenditures related to Public Works Projects**, shall be subject to the Statement of Policy No. 74-1 as adopted by the Winnebago County Board of Supervisors on March 19, 1974.
- 1. The approval of this budget does not grant authority for the purchase of the requested individual items. It is only an indication of various departmental requests. Each request will be reviewed during the year.
- 2. All requests for capital purchases shall be made to the County Executive. If purchase is approved, County Executive will determine the method of purchase and the purchaser (Purchasing Agent or Department Head).
- 3. The total cost of all combined Capital Outlay items purchased by a County department during the budget year may not exceed the total budget for Capital Outlays for that department absent prior approval of the Winnebago County Board of Supervisors, pursuant to the procedure which is provided in Section 65.90, Wisconsin Statutes. Purchases by a department in excess of the estimated costs of an individual item budgeted for a Capital Outlay shall be approved, in advance, by the Winnebago County Executive and the Committee of the Winnebago County Board of Supervisors having jurisdiction over that department. That Department shall report to the County Board at budget time. Any additions, deletions, or substitutions of Capital Outlay items to a department's budget during the course of a budget year must be approved, in advance, by the Winnebago County Executive and the Committee of the Winnebago County Board of Supervisors having jurisdiction over that department.

3.07 PROCEDURE FOR COMPETITIVE PURCHASING BY WINNEBAGO COUNTY DEPARTMENTS; DOCUMENTATION REQUIREMENTS: EXEMPTIONS.

- (1) PURPOSE. The purpose of this Ordinance is to establish a procedure whereby the purchase of goods and services by Winnebago County operating units costing in excess of \$1,000 shall be procured **using competitive means.**
- (2) COMPETITIVE PURCHASING. The Finance Department shall establish written purchasing procedures in relation to this ordinance and all departments of Winnebago County, both elected and appointed, are required to comply with such procedures.
- (3) REVIEW OF PROCEDURES. The Personnel and Finance Committee shall review the procedures on an annual basis and make recommendations for amendments. Amendments shall be approved by both the Committee and County Executive. When necessary, such amendments shall be brought before the County Board for review.
- (4) EXEMPTIONS. The following procurements may be made without compliance with the competitive purchasing requirements of this section of the Code:
 - (a) Purchases of natural gas, electricity, water and sewage connections from public utilities.
 - (b) Real estate transactions.
 - (c) Brand name, patented equipment, service or supplies available from only one as determined by the Finance Director or his designee.
 - (d) Emergency purchases due to breakdown in machinery or as essential service; or when unforeseen circumstances arise, including delays by contractors, delays in transportation and unanticipated volume of work.
 - (e) Services of a nature requiring both professional education and professional experience are exempt from the above requirements, except procurements relative to initial contracts of this nature where total amounts paid to a provider are reasonably expected to exceed \$25,000.
 - (f) Telephone Services and Paging Services.
 - (g) The purchase of used equipment at auctions or from vendors when, in the discretion of that department's respective head, the purchase of said used equipment will result in considerable savings to Winnebago County, subject to review and approval of the Finance Director or his designee.

- (h) Set-up and programming of election software and printing of election ballots.
- (i) Purchases made from Federal or State group purchase contracts or contracts previously bid by other municipalities.
- (j) Purchases made from another unit of government, including the state and federal government may be made without the intervention of bids.
- (k) Any other purchase may be exempted by the Finance Director or his designee with the consent of the County Executive.
- (5) OTHER PURCHASING PROCEDURES. This section of the Code shall not supersede other purchasing procedures established by the General Code of Winnebago County or required by Wisconsin Statutes.
- (6) Road construction materials, supplies and services are governed by Chapter 82 and the Public Works Sections of the Wisconsin Statutes, therefore this ordinance shall not be applicable to such purchases.
 - (7) EFFECTIVE DATE. This section of the Code shall take effect June 1, 1984.

BE IT FURTHER ORDAINED by the County Board of Supervisors of the County of Winnebago that said amendments shall become effective on the date following the date of publication.

WHEREAS, those counties desire to consolidate their emergency communications equipment and data to avoid duplication of services, personnel, facilities and equipment and to advance the public safety in those four counties by sharing pertinent information about criminal perpetrators; and

WHEREAS, said system contains two elements: a Computer Aided Dispatch System and a Records Management System, with the Computer Aided Dispatch System to be shared by all counties and with each County maintaining its own Record Management System separately; and

WHEREAS, said agreement, which is herewith attached, spells out the rsponsibilities of each County under this agreement and the fiscal responsibilities of each County and the responsibilities of each County should they withdraw from the agreement or fail to fund the system pursuant to the terms of the agreement; and

WHEREAS, said agreement has been reviewed by the Information Systems Directors and the Corporation Counsels of each County: and

WHEREAS, your undersigned Committees recommend that said agreement be approved for execution by the Winnebago County Executive and Winnebago County Clerk.; and

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby approves the Intergovernmental Agreement regarding the FOXCOMM System which is herewith attached and made a part of this resolution by reference and authorizes the Winnebago County Executive and Winnebago County Clerk to execute said agreement on behalf of Winnebago County.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby requests the State Legislature and the Governor of the State of Wisconsin to increase the base level funding for the Wisconsin Tobacco Control Board in State Fiscal Year 2002-2003 to the amount specified in Budget Act 16. This amount shall include the appropriation of \$10 million dollars in monies from tobacco settlement revenue to the tobacco control fund.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby requests the State Legislature and the Governor of the State of Wisconsin to commit to provide future funding for ongoing efforts of the Wisconsin Tobacco Control Board in the amount specified in Budget Act 16.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby directs the Winnebago County Clerk to transmit a copy of this resolution to all members of the State Legislature representing constituents within Winnebago County; to the Wisconsin Counties Association; and to the Office of Governor Scott McCallum.
