Chairman Maehl called the meeting to order at 6:00 P.M. in the Supervisors' Room, Fourth Floor, Courthouse, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an Invocation by Supervisor Rankin.

PRESENTATION OF PLAQUE - EAA 50TH ANNIVERSARY

In commemoration of the EAA's 50th anniversary, Chairman Maehl presented Tom Poberezny with a plaque from the Winnebago County Board of Supervisors. The plaque recognizes the EAA's contributions to Winnebago County, the State of Wisconsin and the United States.

COMMUNICATIONS, PETITIONS, ETC.

Sue Ertmer, County Clerk, announced that the 2003 Proposed Department of Human Services Budget Book is on file in the County Clerk's Office and is available for public viewing.

Stats., dealing with public employees."
- Petition for Zoning Amendment from Oshkosh Realty Company, Town of Nekimi, for zoning change from A-1/R-1 to R-1/A-1 for a residential lawn was referred to the Planning & Zoning Committee.

Petition for Zoning Amendment from Evelyn Steinacker, Town of Winchester, for zoning change from A-2 to R-1 for residential homes was referred to the Planning & Zoning Committee.

COMMITTEE REPORTS

Supervisor Kline thanked all the people who participated in Team Oshkosh at this year's EAA Airventure. Team Oshkosh is a group of 35 people representing the Oshkosh Chamber, Chamco, Oshkosh Commercial Development Corporation, Winnebago County's Industrial Development Board, Wisconsin Public Service and Wittman Airport, as well as, staff members from the Cities of Oshkosh and Omro, Town of Menasha and the Winnebago County Planning Department. Team Oshkosh focuses on business development in Winnebago County and Wittman Airport.

Supervisor Barker distributed the latest edition of the UW-Extension's <u>Info Source</u> brochure. If anyone would like additional copies, they can contact the UW-Extension Department at the James P. Coughlin Center.

Supervisor Norton distributed a report on his attendance at the NACo Convention in New Orleans, LA. He stated the exhibits that each of Louisiana's parishes had at the convention were very informative and recommended Wisconsin do the same when the NACo convention is in Milwaukee in 2003.

Chairman Maehl reminded everyone that the September WCA Convention will be held in Milwaukee. If anyone is interested in attending, they should contact the County Clerk's Office.

Supervisor Rengstorf reported that the construction of the new Sheriff's Department/jail is on schedule for a May 3, 2003, opening. They are 40% completed and are under budget. He also reported that the number of

inmates housed out in July went down from 70 to 45 by the end of the month.

Supervisor Widener reported that last week all the Medicare beds at Park View Health Center were filled, which is financially beneficial to Winnebago County. He commended Janet Vroman, the new Admissions Coordinator at Park View Health Center, for her efforts in increasing Medicare patients at Park View Health Center.

Supervisor Widener reported that at the Wisconsin caucus during the NACo Convention in New Orleans, an interesting point was made by Jean Jacobson, Racine County Executive, regarding the current budget situation in Madison. She expressed concern that if counties cut back their budgets in 2003 too far, will the state come back in subsequent years and say counties don't need shared revenue from the state. He encouraged Winnebago County to take this in to consideration at budget time.

Supervisor Widener asked that when the Board debates Resolution No. 52-72002, "Amend Minimum Standard Requirements for Operators at Wittman Regional Airport," they consider the issue and not the people involved with the resolution.

Supervisor Griesbach reported that he will be withdrawing Resolution No. 48-72002, "Authority to Execute a Three-year Employment Agreement with Donald W. Wilmot, Director of Emergency Management."

Supervisors Barker and Rankin gave a presentation on 4-H and the upcoming Winnebago County Fair. The fair will be held from Tuesday, August 13 through Sunday, August 18. They reported that this year is 4-H's 100th Anniversary and they encouraged the Board to make plans to visit the fair and check out the 4-H exhibits and projects.

COUNTY EXECUTIVE'S REPORT

Executive Van De Hey reported that the Country USA and Lifest concerts that were held at the county's fairgrounds and the EAA's Airventure 2002 were very successful, well run events.

Executive Van De Hey reported that plans are being made for a September 11 memorial ceremony. The ceremony will be a joint effort with Brown, Outagamie, Calumet and Fond du Lac Counties and WPKR Radio. Included in the ceremony will be area police & fire chiefs and color guards. She encouraged everyone to plan on attending this event.

Executive Van De Hey congratulated Supervisor Pat O'Brien, who is also the City of Menasha's Fire Chief, on his selection as Wisconsin's Fire Chief of the Year. The Board recognized Supervisor O'Brien's award with a round of applause.

Executive Van De Hey introduced Duncan Henderson, Wittman Regional Airport Manager, who spoke on Resolution No. 52-72002, "Amend Minimum Standard Requirements for Operators at Wittman Regional Airport." Mr. Henderson explained that this resolution would change all the airport's minimum standard requirement categories. With these changes, in the event Winnebago County does not have any hangar or building space available to rent, an operator who has plans to rent or build appropriate space within the next 12 months, could conduct business at the airport before that space is available. If that business fails during that 12-month period, they will not be able to come back at a later date and conduct business at Wittman Airport.

ORDINANCE NO. 58-72002:

Amend Section 19.07(2)(b) of the Winnebago County General Code Relating to Recognition of the Coughlin Community Natural Area as a Property Placed under the Control of the County Parks and Recreation Committee

WHEREAS, the Coughlin Community Natural Area is a 35 acre parcel of county-owned land adjacent to the James P. Coughlin Center that presents Winnebago County with an outstanding opportunity to demonstrate ways in which our natural resources can be conserved, managed and sustained; and

WHEREAS, in March of 2000 the County Board did approve Resolution #415-32000 establishing the Coughlin Community Natural Area and directing that the property henceforth be managed as a natural area in perpetuity; and

WHEREAS, various government agencies, including the Winnebago County Parks Department, the Winnebago County Land and Water Conservation Department, the Wisconsin Department of Natural Resources Oshkosh Service Center, and the University of Wisconsin Extension Service Offices, continue to share various responsibilities in the delivery of programs and services aimed at the conservation and planned use of the resources located within the Coughlin Community Natural Area; and

WHEREAS, it is necessary to amend Section 19.07(2)(b) of the Winnebago County General Code so as to allow the Winnebago County Parks Department to establish an hours of use ordinance for that facility.

NOW, THEREFORE the County Board of Supervisors of the County of Winnebago does ordain as follows: That Section 19.07(2)(b) of the General Code of Winnebago County be amended to read as follows:

19.07 OPERATING POLICY.

(2) HOURS. The following hours of operation shall apply: (a) Boat Landings and Public Access Points including Boom Bay, Black Wolf, Osh-O-Nee, Eureka, Lake Poygan Boat Landings, Lake Butte Des Morts and Asylum Point Park.

1. Summer Season – 4 a.m. to 11 p.m.

2. Winter Season – 6 a.m. to 11 p.m.

(b) Nature Areas including Waukau Creek Nature Preserve, Coughlin Community Natural Area, Lasley Point Archaeological site, and the Winnebago County Recreation Trails during the non-snowmobiling season.

- 1. Summer Season 6 a.m. to 10:30 p.m.
- 2. Winter Season -7 a.m. to 3:00 p.m.
- (c) Campgrounds (See Sec. 19.21(2)-(4) of this Chapter.)
- (d) Park Areas including Community Park, Grundman Park and Asylum Point Park:
- 1. Summer Season 7 a.m. to 11:00 p.m.
- 2. Winter Season 7 a.m. to 3:00 p.m.

BE IT FURTHER ORDAINED by the County Board of Supervisors of the County of Winnebago that this ordinance amendment shall be effective as of the date following the date of its publication.
