NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes a budget transfer of \$25,000 from the Contracted Services-County Executive Budget Fund and \$7,500 from the Per Diem-Elected Officials Fund to the Professional Fees Fund for the purpose of making a one-time payment to the Wisconsin Counties Association for lobbying services provided in relationship to the Intergovernmental Transfer Program Funding for county nursing homes.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that said payment shall not act as an authorization for further payment to the Wisconsin Counties Association nor for further services from the Wisconsin Counties Association in relationship to said program in the future.
