ADJOURNED SESSION COUNTY BOARD MEETING TUESDAY, JANUARY 21, 2003

Chairman Joseph Maehl called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

Supervisor Rankin reported that Outagamie, Calumet and Winnebago Counties are working together to establish a dental clinic that will serve people who can't afford dental care. It will be located near the UW Fox Valley Campus and will be staffed by volunteer doctors, nurses and other staff members.

Supervisor Pech announced that on February 8 at the Pioneer Inn on Lake Winnebago, he will be taking part in this year's Polar Plunge for Special Olympics. Anyone who would like to make a donation or join him in the plunge is welcome. Donations can be sent to him directly or dropped off in the County Clerk's Office.

Supervisor Norton announced that he is also participating in this year's Polar Plunge and would appreciate donations to this worthy cause.

Supervisor Schaidler announced that on Thursday, January 30 @ 7:00 p.m. there will be another meeting on the county's comprehensive land use plan. It will be held at the James P. Coughlin Center and everyone is encouraged to attend.

COUNTY EXECUTIVE'S REPORT

Executive Van De Hey commended Supervisors Pech and Norton on their participation in the Special Olympics Polar Plunge.

Executive Van De Hey stated that the January 3rd inauguration for the county's constitutional officers went very well. Attendees at the ceremony included family members, circuit court judges, department heads and board supervisors. Supreme Court Justice Diane Sykes attended the ceremony and swore in the officers.

Executive Van De Hey reported that she attended the Governor's swearing-in ceremony in Madison on January 6. She stated that it was a very "positive day" with the Governor and the legislature hoping for a fresh start.

Executive Van De Hey presented Chuck Orenstein, Finance Director, with an "Excellence in Financial Reporting" award and commended him for the hard work that he puts in each year on the budget and in keeping Winnebago County in excellent financial standing. Mr. Orenstein accepted the award and commended his staff.

Executive Van De Hey announced that the nationwide <u>City/County</u> magazine has named Winnebago, Outagamie and Brown Counties as one of seven "crown communities" in the United States because of our multicounty recycling and landfill project. She commended the Winnebago County Solid Waste Management Board for their initiative and efforts in this project.

Executive Van De Hey asked for the Board's support of the following resolutions:

- No. 135-12003, "Transfer \$25,000 from General Fund Undesignated Fund Balance to Human Services Department to Cover Projected 2002 Budget Shortfall."
- No. 140-12003, "Adopt 2003 Revisions to the Winnebago County Administrative Salary Schedule."

CHAIRMAN'S REPORT

Chairman Maehl extended "happy birthday" wishes to Supervisors Jacobson, Rankin, Eichman, Diakoff and Arne. He also thanked Supervisor Jacobson for his donation to the county's scholarship fund. He then reminded the Board to inform their constituents about the Winnebago County Scholarship Fund and to encourage those that are eligible to apply for the scholarships.

Chairman Maehl read a letter of thanks from Ellen Hanson, one of the 2002 Winnebago County Scholarship recipients.

Chairman Maehl announced that in 2003, Winnebago County will be receiving a total of \$2,708,136.98 in General Transportation Aids from the Wisconsin Department of Transportation. This will be paid in four quarterly payments of \$677,034.24 each.

Chairman Maehl asked that the Board review the Winnebago County Fair Association Report for 2002 that was included in their packet. He also complimented the Fair Association on the success of this year's fair.

Chairman Maehl asked that the Board review the J.P. Coughlin Center Meeting Room Usage 2002 report that was included in their packets.

As a point of interest, Chairman Maehl told the Board that the county associations for the states of Kansas, lowa and Missouri are suing their respective legislatures because of those states' unfunded mandates that are imposed on their counties.

PUBLIC HEARING

No one addressed the Board.

BRADLEY VIEGUT, ROBERT W. BAIRD & CO., INC. - NEGOTIATED SALE BOND ISSUES

Bradley Viegut of Robert W. Baird & Co., Inc., presented the "Current Status, Opportunity and Flexibility" report for the unfunded pension liability payoff. He explained that this process originally started in November 2002 when the Board authorized the borrowing of \$5 million from the State Trust Fund Loan Program to pay off part of the county's unfunded pension liability balance.

Note Anticipation Notes (NAN) were used to pay off the other part of the unfunded pension liability. The NANs were used as a bridge-financing device because the State Trust Loan Program could not lend out more that \$5 million per year to any single entity. The NANs need to be refinanced when they mature between February and May. Originally, Winnebago County was going to use another State Trust Fund loan to refinance the NANs, but because the interest rate market is so favorable right now Winnebago County will be better off using General Obligation debt to refinance.

Mr. Viegut explained that it would be to our advantage to use a negotiated sale rather than a public sale to refinance the NAN's, if we were to use General Obligation Debt instead of the Trust Fund loan for the refinancing. He then explained the benefits of using the negotiated sale technique in this particular instance.

After his presentation, the Board agreed that if interest rates are lower using the General Obligation Debt instead of the State Trust Fund Ioan, Winnebago County should use a negotiated sale.

A copy of Mr. Viegut's report is on file in the County Clerk's Office with the original proceedings from this meeting.

RON MONTGOMERY - HEALTH INSURANCE PORTABILITY & ACCOUNTABILITY ACT (HIPAA)

Ron Montgomery explained that although the U.S. Congress passed the Health Insurance Portability & Accountability Act (HIPAA) in 1996, it is just now being implemented because the rules and regulations for the Act are just being completed.

HIPAA mandates health care transactions (sharing of medical information) be done electronically. This will streamline the process and improve the security of the information. The privacy and security of an individual's medical information is the main purpose of HIPAA.

Mr. Montgomery provided the Board with a handout and a slide presentation on the details of HIPAA. He explained its rules and regulations and how it will impact Winnebago County and the way we handle the medical information of our employees and clients. A copy of his presentation is on file in the County Clerk's Office with the original proceedings from this meeting.

RESOLUTION NO. 134-12003:

Amend State Statutes So As To Allow Municipal Entities to Use Design-Build Concept In Construction Projects

WHEREAS, Wisconsin's Public Construction Law requires bids to be let for construction of all projects in excess of \$25,000; and

WHEREAS, said law practically precludes municipalities from using a traditional design-build concept in relationship to public works construction; and

WHEREAS, the failure of present law to accommodate a traditional design-build concept in relationship to public construction prohibits municipalities from realizing the cost savings that such a concept provides; and

WHEREAS, the amendment of present law to accommodate design-build construction would allow municipal entities to speed up their construction process.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby urges the Wisconsin Legislature to amend present Public Works Construction Law so as to allow municipalities to use traditional design-build construction concepts in relationship to public works projects.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby directs the Winnebago County Clerk to transmit a copy of this resolution to all legislators representing Winnebago County constituents in the State Legislature; to the Wisconsin Counties Association and to the Office of Governor Scott McCallum.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby transfers \$250,000 from the General Fund Undesignated Fund Balance to the Human Services Department Fund to cover the projected overage.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that knowing that this deficit is only a projection at this time, if any funds remain after the 2002 Budget Year accounting is complete, such funds shall be transferred back to the Undesignated Fund Balance of the Winnebago County General Fund.
