ADJOURNED SESSION COUNTY BOARD MEETING Tuesday, August 19, 2003

Chairman Joseph Maehl called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Rankin.

Motion by Supervisor Robl and seconded to amend the agenda by acting on Resolution No. 256-82003 before Resolution No. 252-82003 and approving agenda as amended. CARRIED BY VOICE VOTE.

Petition for Zoning Amendment from Lewis and Karen Niemuth, Town of Wolf River, for zoning change from A-2 to R-1 for erecting single-family homes was referred to the Planning & Zoning Committee.

Supervisor Barker stated that the Legislative Committee will be meeting on Monday, August 25. Senator Michael Ellis will be at this meeting to speak about creating a task force to study overlapping government services.

Supervisor Rankin reported that he and Supervisors Barker and Farrey presented Key awards to a select number of 4-H participants at this year's county fair. In addition, he and Supervisor Barker served as judges for various 4-H projects. Supervisor Rankin was impressed with the wonderful fairgrounds and the young people that participated in 4-H projects at this year's fair.

Supervisor Sievert reminded the Board that this Saturday is the Town of Clayton's golf outing to raise funds for the recreation trail. There is still room left for people to sign up and play a round of golf.

Supervisor Schaidler reported that the colored zoning maps that were included in tonight's packet cost an additional \$219.00 in printing costs. He explained that this additional cost was not included in the Planning & Zoning Department's budget, but if the Board wants to continue with colored maps, an amendment could be brought in at budget time to cover these additional costs. Supervisor Schaidler also stated that there may be alternative ways to present colored maps to the Board. Supervisor Pech stated that the Information Systems Committee will put this on their next meeting agenda and will come back to the Board with suggestions on alternative ways to present colored maps to the Board.

Supervisor Pech reported that Team Oshkosh was very active at this year's Air Venture. They visited more than 40 vendors and presented them with packets of information promoting the Oshkosh area. Supervisor Pech stated that a steering committee will be following up with their contacts.

Supervisor Pech also reported and he and Supervisor Hert will be participating in the "Men Who Cook" fundraiser for the Christine Ann Center. It will be held on Saturday, August 24 at the Sunnyview Center. He encouraged everyone to buy a ticket and attend this very worthwhile event.

Motion by Supervisor Lauson and seconded to approve the July 1 & 22, 2003 County Board proceedings. CARRIED BY VOICE VOTE.

COUNTY EXECUTIVE'S REPORT

Executive Van De Hey commented on how nice the county fair was this year. She was very encouraged by the number of young people who are involved in 4-H. Executive Van De Hey explained that statistics show that it is highly unlikely that young people who participate in 4-H programs will get involve in criminal activities and become juvenile offenders.

Executive Van De Hey explained that in light of the problems that Brown County was having with their 911 center and Fox Communications, she decided to spend some time in Winnebago County's 911 center. She stated that she was there on a day when they encountered a number of difficult situations and she was very impressed with the way the dispatchers handled them. She stated that the new computer system and equipment also worked very well. Executive Van De Hey commended the 911 dispatchers and stated how proud she is of them and the way they carry out their duties.

Executive Van De Hey recommended passage of Resolution No. 258-82003, "Authorize Participation in Multi-County Exploration Committee." She explained that our inter-county solid waste agreement with Outagamie and Brown Counties has saved all three counties significant amounts of money. Resolution No. 258-82003 will look into additional ways that Outagamie, Calumet and Winnebago Counties can combine services and projects to make them more efficient and cost-effective.

Executive Van De Hey recommended passage of Resolution No. 256-82003, "Appropriate \$110,000 to the 2003 Phase of the Courthouse Security Project for the Purpose of Upgrading the Security System."

Executive Van De Hey noted that Duncan Henderson has submitted his resignation as Director of Wittman Regional Airport. Mr. Henderson has accepted the position of Executive Director for the Waukegan Port District in Waukegan, Illinois. Executive Van De Hey commended him on his work at Wittman Airport. She noted how much the airport has expanded and grown since Mr. Henderson took the position in December 1995. She wished him well and thanked him for all that he has helped the county accomplish.

COUNTY EXECUTIVE'S APPOINTMENT - OSHKOSH LIBRARY BOARD - CORRECTION

Executive Van De Hey asked for the Board's approval of her corrected appointment of Supervisor Patrick Brennand to the Oshkosh Library Board. The previous appointment listed the term as expiring on June 30, 2005 and it should be corrected to June 30, 2006.

Motion by Supervisor Lauson and seconded to approve. CARRIED BY VOICE VOTE.

CHAIRMAN'S REPORT

Chairman Maehl shared a "thank you" letter from Leah Shea, a 2002 scholarship winner from Winneconne High School. Ms. Shea reported that after her first year at UW-LaCrosse, she has a 3.85 GPA. In her letter, Leah thanked the Board for the scholarship and the opportunity it afforded her.

Chairman Maehl thanked Supervisor Robl for his check for the Scholarship fund.

At approximately 7:00 p.m., Chairman Maehl called for a brief recess. The Board reconvened at 7:15 p.m.

Supervisor Nielsen gave a brief report on his experiences with his Marine unit in Iraq during the war. He stated that being in a leadership position requires you to keep focused and take care of the soldiers who serve under your command, but that sometimes conditions make that a challenge. He explained that the sand and sandstorms made living conditions horrible, but that they persevered.

Supervisor Nielsen explained that his unit provided various types of support (general construction work) to the 1st Marine Division of the 5th Corp. He was in numerous Iraqi communities, including Baghdad.

Supervisor Nielsen stated how much he appreciated all communications from his family & friends. He explained how important it is for soldiers to receive letters and packages from home. He is thrilled to be back home, but realizes there is a chance that he could be deployed again.

BE IT FURTHER RESOLVED that proceeding with this project is contingent on the Wisconsin Governors veto of the tax freeze not being overridden.

BE IT FURTHER RESOLVED that so long as the override attempt of the Governors veto of the tax freeze fails, funds to pay for said improvements be transferred from the General Fund of Winnebago County to the Courthouse Security Capital Project fund with the General Fund being reimbursed from a subsequent bond issue.
