ORDINANCE NO. 17-42004: Amend Section 7.02, General Code of Winnebago County: Speed Limit Regulations

WHEREAS, Section 7.02 of the General Code of Winnebago County establishes speed limits on various County Trunk Highways within Winnebago County; and

WHEREAS, due to numerous jurisdictional changes and name changes with regard to various highways within Winnebago County, there is a need to amend and update Section 7.02 of the General Code of Winnebago County.

NOW, THEREFORE, the County Board of Supervisors of the County of Winnebago does ordain as follows:

That Section 7.02 of the General Code of Winnebago County shall be amended to read as follows:

7.02 SPEED LIMIT REGULATIONS. A traffic and engineering investigation having been made on the following described highways, the maximum permissible speed at which vehicles may be operated on such highways, which speed is herewith established as reasonable and safe pursuant to s.349.11, Wisconsin Statues, shall be as set forth herein, subject to approval of the Department of Transportation and upon erection of standard signs giving notice thereof:

(1) COUNTY TRUNK HIGHWAY "A"

(a) Towns of Neenah, Vinland and Oshkosh:

- 1. 35 miles per hour from the city limits of the City of Neenah southerly to its intersection with Muttart Road.
- 2. 45 miles per hour from its intersection with Muttart Road southerly to the city limits of the City of Oshkosh.

(2) COUNTY TRUNK HIGHWAY "AP"

- (a) Town of Menasha:
- 1. 35 miles per hour from its intersection with County Trunk Highway "P" easterly to its intersection with USH 10.

(3) COUNTY TRUNK HIGHWAY "BB"

- (a) Town of Menasha:
- 1. 45 miles per hour from its intersection with Irish Road easterly to its intersection with Cold Spring Road.

(4) COUNTY TRUNK HIGHWAY "E"

- (a) Town of Algoma:
- 1. 35 miles per hour from the city limits of the City of Oshkosh westerly to its intersection with Overland Trail.
- 2. 45 miles per hour from its intersection with Overland Trail to a point 0.45 of a mile west of its intersection with Horseshoe Road.
- (b) Town of Rushford:
- 1. 25 miles per hour from a point 0.50 of a mile southwesterly of its intersection with County Trunk Highway "K", thence easterly for a distance of 0.40 of a mile from its intersection with County Trunk Highway "K".
- (c) Town of Nepeuskun:
- 1. 45 miles per hour from a point 0.30 of a mile south of its intersection with County Trunk Highway "V" northerly to a point 0.50 of a mile north of its intersection with County Trunk Highway "V".

(5) COUNTY TRUNK HIGHWAY "FF"

- (a) Town of Utica:
- 1. 45 miles per hour from its intersection with STH 44 northerly to its intersection with Fisk Avenue.
- 2. 35 miles per hour from its intersection with Fisk Avenue northerly for a distance of 0.50 of a mile.

(6) COUNTY TRUNK HIGHWAY "G"

- (a) Town of Neenah:
- 1. 45 miles per hour from its intersection with Woodenshoe Road easterly to its intersection with County Trunk Highway "A".
- (b) Town of Vinland:
- 1. 45 miles per hour from a point 0.08 of a mile east of its intersection with Hilltop Road westerly for a distance of 0.52 of a mile.
- 2. 45 miles per hour from its intersection with USH 45 westerly for a distance of 1.0 miles.

(7) COUNTY TRUNK HIGHWAY "H"

- (a) Town of Wolf River:
- 1. 35 miles per hour from the Waushara County line easterly for a distance of 0.55 of a mile.

(8) COUNTY TRUNK HIGHWAY "I"

- 1. 35 miles per hour from its intersection with STH 44 southeasterly for a distance of 0.35 of a mile.
- 2. 25 miles per hour from its intersection with STH 44 northerly for a distance of 0.19 of a mile.

- 3. 45 miles per hour from a point 0.19 of a mile north of STH 44 to its intersection with Mountain Road.
- (b) Town of Winneconne:
- 1. 45 miles per hour from its intersection with STH 116 northerly to its intersection with County Trunk Highway "G".

13. COUNTY TRUNK HIGHWAY "O"

- (a) Towns of Neenah and Menasha:
- 1. 35 miles per hour from its intersection with USH 41 westerly to its intersection with County Trunk Highway "II".

RESOLUTION NO. 28-52004: Transfer \$15,000 from Highway Department Fund Balance to the County Road Maintenance Budget to Perform Additional Testing on CTH AP Prior to Starting the Project

WHEREAS, The Winnebago County Executive has included the CTH AP project in the Executive 5-Year Capital Improvements Plan (Plan), and

WHEREAS, the Plan schedules the reconstruction for the year 2006, and

WHEREAS, the roadway has many severely distressed areas, and

WHEREAS, more in depth testing needs to be done at this time to insure the project will actually repair and extend the life of the roadway, and

WHEREAS, additional funds of \$15,000 are needed to do this additional testing.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the transfer of \$15,000 from the Highway Department fund balance to the County Road Maintenance budget for the purpose of covering the additional testing costs as indicated above.

RESOLUTION NO. 29-52004: Designating the Winnebago County Public Safety Communication Center as Winnebago County's Wireless Public Safety Answering Point

WHEREAS, 2003 Wisconsin Act 48 creates an implementation funding source for enhanced cellular 911 location; and

WHEREAS, that same Act requires that the County Board pass a resolution designating a single public safety answering point within the County to be eligible for future grants; and

WHEREAS, approximately 60% of the incoming 911 calls to the Winnebago County Public Safety Communication Center are placed on cellular phones; and

WHEREAS, unlike land-based 911 calls, cellular 911 calls are not accompanied by vital caller information. Such information aids the prompt dispatch of public safety personnel; and

WHEREAS, 2003 Wisconsin Act 48 creates a funding mechanism that meets the Federal Communication Commission's mandate for a cost recovery system to pay for the implementation of an enhanced 911 system for identifying and locating calls originating from cellular phones; and

WHEREAS, said funding mechanism is a 3-year grant program administered by the Wisconsin Public Service Commission to reimburse local governments and wireless telephone service providers for certain costs related to providing enhanced wireless 911 service; and

WHEREAS, 2003 Wisconsin Act 48 allows only one (1) grant per county to a local government. That Act

further states that to qualify for such a grant, the local government must provide 911 wireless service to the entire county; and

WHEREAS, Section 146.70(3)(m), Wisconsin Statutes, as created by 2003 Wisconsin Act 48, requires adoption of a resolution by a county board to designate a single public safety answering point to act as the wireless public safety answering point for the purpose of implementing the federal wireless orders and to be eligible for a grant for the wireless 911 fund.
