ADJOURNED SESSION WINNEBAGO COUNTY BOARD MEETING TUESDAY, DECEMBER 19, 2006

Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Lennon.

The following Supervisors were present: Weber, Barker, Griesbach, Hotynski, Ramos, Maehl, Koziczkowski, Pollnow, Widener, Lauson, Albrecht, Anderson, Thompson, Lohry, Lennon, Farrell, Hall, Wingren, Jacobson, Norton, Warnke, Drexler, Robl, Schmuhl, Kline, Locke, Eisen, Schaidler, Finch, Farrey, Sievert, Diakoff, Brennand, Egan, Ellis, Rengstorf and O'Brien. Excused: Arne.

Motion by Supervisor Robl and seconded to amend tonight's agenda so that Resolution Nos. 132-122006 and 133-122006 are acted on before Resolution No. 125-122006 and to approve the agenda as amended. CARRIED BY VOICE VOTE.

COMMUNICATIONS, PETITIONS, ETC.

Copies of two letters received from Senator Michael Ellis were distributed to the Board.

REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Barker reported that there will not be a Legislative Committee meeting in December. Their next meeting will be on January 22, 2007. If anyone has an agenda item for that meeting, they should let her know.

Supervisor Eisen gave a report on the WCA Regional Legislative Meeting that he attended on December 6 in Manitowoc. Items discussed at that meeting included high deductible medical insurance and health savings accounts; court fees; the Family Care pilot program; county board downsizing.

Supervisor Maehl expressed his support of Winnebago County Clerk Sue Ertmer and Corporation Counsel John Bodnar and rejected the claim of some people that their rights had been violated when Ms. Ertmer did not accept the petitions circulated by the group, "Citizens United to Transform the Winnebago County Board (CUT)". Supervisor Maehl also discussed Yakima County, Washington and the makeup and of their county board.

Supervisor Sievert extended her thanks to Tom LaFuze for his many years of service on the county's Board of Health. She also congratulated Mr. LaFuze on his upcoming retirement as principal of H.B. Patch School in Omro.

Motion by Supervisor Lauson and seconded to approve the October 30 & 31 and November 1 & 2, 2006 County Board Budget Session proceedings and the November 14, 2006 Adjourned Session proceedings. Supervisor Eisen asked that the vote on Amendment (9) on Page 120 be corrected to show the amendment "LOST". Supervisor Widener asked that Page 123 be corrected to list him as "excused" instead of "present" when the Board reconvened after lunch. Vote on proceedings as corrected - CARRIED BY VOICE VOTE.

COUNTY EXECUTIVE'S REPORT

Executive Harris spoke on the following resolutions:

- No. 126-122006: "Support Revision or Repeal of Section 70.11(21), Stats." Executive Harris explained that this section of the statutes was originally designed to provide property tax exemptions for treatment plants and pollution abatement equipment, but because of recent litigation, it has gotten broader interpretation and paper mills are claiming that their processes qualify them as treatment facilities and exempts them from paying property taxes. If this were allowed, it would have a substantial financial impact on Winnebago County's tax base.
- Ordinance No. 136-122006: "Amend Section 2.01 of the General Code of Winnebago County". Executive Harris explained that if passed, this ordinance creates the new 36 county supervisory districts. He asked that the Board not vote on this ordinance at tonight's meeting, but wait until the C.U.T. group's lawsuit goes through the courts.

Executive Harris also asked that the Board listen carefully to Dean Jim Perry's presentation on UW-Fox Valley's Communication Art Center Project. Mr. Harris stated that a lot of misinformation on this project has been distributed and he feels it's very important that the public and the Board hear what Dean Perry has to say. Executive Harris explained that the UW-Fox Valley campus has been noted as one of many reasons why new businesses may want to locate in this area, so he feels it's important that the Communication Art Center Project be considered and approved by the Winnebago County Board.

COUNTY BOARD CHAIRMAN'S APPOINTMENT

Personnel Function Review Committee

Chairman Albrecht asked for approval of his appointment of Supervisors John Schaidler, Bernie Egan, Patrick O'Brien, Joanne Sievert, Stan Kline, Patrick Brennand and David Albrecht to the Personnel Function Review Committee.

Motion by Supervisor Hall and seconded to add one more person to this committee. Corporation Counsel John Bodnar explained that the county board amended their rules to form this committee, and at that time, it was specified that there would be seven members on the committee. If the Board wants to increase the membership to any other number, it will have to be done by resolution to amend that section of the Board's rules. Supervisor Hall's motion was withdrawn.

Motion by Supervisor Lauson and seconded to approve the appointments. Ayes: 23. Nays: 13 - Weber, Barker, Ramos, Thompson, Lohry, Hall, Jacobson, Norton, Locke, Eisen, Finch, Farrey and Ellis. Abstain: 1 - Farrell. Excused: 1 - Arne. CARRIED.

COUNTY REDISTRICTING - JERRY BOUGIE, COUNTY PLANNER; AND DIANE CULVER, GIS DEPARTMENT

Jerry Bougie and Diane Culver explained the process that was used to develop the county's 36 supervisory district maps. Mr. Bougie explained that a change in Wisconsin law allows for the size of county boards to be reduced one time between decennial redistricting either by referendum or county board action. Because the Winnebago County Board voted in September to reduce their size to 36 members, his department has developed the map that is being presented to the Board tonight.

Mr. Bougie explained that, according to state law, this map had to be presented to the Board within 90 days of September 26, 2006, which is the day the Board voted to reduce their membership to 36 members. The map was presented to and approved by the Judiciary & Public Safety Committee on November 28, 2006.

Mr. Bougie stated that Wisconsin law requires that the new supervisory districts be developed from contiguous whole wards that existed at the time the redistricting plan was adopted. Normally, the maps developed during redistricting are based on census blocks, which are much smaller than existing wards and gives more flexibility when developing district maps.

Mr. Bougie explained that the districts also need to be "substantially equal in population" based on the 2000 census figures. This means the district maps had to be drawn based on old population data, but current ward boundaries. The map as presented has a population deviation range of 13%. This means the population in one district is 5.4% above the average population in all the districts, and the population in another district is 7.6% below the average population in all the districts. The average population in the 36 districts is 4355, so the highest population in a district is 4,590 and the lowest is 4,024. Mr. Bougie explained that this was the lowest deviation rate that Ms. Culver was able to achieve as she drew this proposed map.

Mr. Bougie also explained that as they drew this map, they needed to keep in mind that state law also requires that the new districts be as compact as possible and that you do your best to keep whole municipalities together.

Mr. Bougie and Ms. Culver took questions from the Board.

As the discussion on this issued continued, a motion was made by Supervisor Hall and seconded to suspend rule 6.4, which requires that the public hearing portion of the Board's meeting begin no later than 60 minutes after the meeting is called to order, so the Board's discussion can continue and the public has an opportunity to speak on this issue as well. Ayes: 31. Nays: 6 - Griesbach, Maehl, Albrecht, Schaidler, Egan and Rengstorf. Excused: 1 - Arne. CARRIED.

UW-FOX VALLEY COMMUNICATION ART CENTER PROJECT - DEAN JAMES PERRY

Dean James Perry presented the engineering study for UW-Fox Valley's Communication Art Center Project as prepared by Short, Elliot, Hendrickson, Inc. of Appleton. Dean Perry also gave a Powerpoint presentation that described the mission of UW-Fox Valley and explained the history and scope of the Communication Art Center Project.

Dean Perry explained that the mission of UW-Fox Valley is to prepare students for baccalaureate level education. UW-Fox Valley provides the first two years of a liberal arts education which allows the student to continue their education at another university and receive their bachelors degree.

Dean Perry explained that both Outagamie and Winnebago Counties provide the university with funding for

their operating budget. In 2006, that amount was \$139,000 per county. The State of Wisconsin provides the university with funding for personnel and equipment. In 2006, that amount was \$7.9 Million.

According to a 1959 agreement, the costs of building projects on the campus are the responsibility of the municipalities--Outagamie & Winnebago Counties. The state pays for the "moveable equipment" needed for the project.

Dean Perry explained that although UW-Fox Valley is a small campus, they have an economic impact on Outagamie & Winnebago Counties of approximately \$50 Million annually. They enroll 1,731 students each year and are the second largest of the UW colleges' campuses.

Dean Perry stated that even though they are the second largest campus, their 220-seat auditorium is the smallest auditorium of all the campuses. Over the past three years, the average use of the auditorium has been for 169 campus events or 81% of the academic year.

Dean Perry explained the history of the auditorium and this project:

- Built in 1962, it has been used as a multipurpose room for communication arts, music and physical education
- In 1977, the facilities deficiencies are determined
- In 1982, lighting equipment was upgraded and replaced
- During a large construction project on a different part of the campus in 1989, consultants identify additional deficiencies in the auditorium and recommend solutions, but funding is not available.
- Results of a 2002 engineering study of the auditorium is determined by Winnebago County to be too large and costly.
- 2006 This is the third engineering study on the project. The scope of the project has been reduced.

Dean Perry explained that there are significant safety and code problems in the auditorium. The restrooms, risers, second floor, stage control booth and workshop are not ADA compliant. There is asbestos present and there are problems with the plumbing, fire protection and risers.

Dean Perry explained that the proposed new auditorium would eliminate these problems and provide seating for 361 people, a multipurpose classroom, a lobby, offices, restrooms and additional work space areas to support the auditorium.

Estimated total costs for the project are \$13,891,781. Winnebago County would be responsible for \$5,273,390. This would cost the property taxpayers of Winnebago County approximately \$6.22 per \$100,000 of accessed value of their property for ten years.

Dean Perry explained that because they believe so strongly in this project, the UW-Fox Valley Foundation has pledged to raise \$2 Million for this project. He explained that this is the first time that the foundation has ever been involved in a capital project.

Dean Perry outlined what the new "multipurpose, multiuse auditorium" will be used for:

- an academic facility for teaching
- scholars series--public lectures
- parent-student Preview Days
- new student orientation & registration
- international film series
- large group instruction
- convocation and commencement
- theatrical performances

Dean Perry then introduced Chancellor Rick Wells of UW-Oshkosh who expressed his support of the Communication Arts Center project.

Dean Perry took questions from the Board.

RESOLUTIONS & ORDINANCES

RESOLUTION NO. 125-122006: Support Increased State Support to Counties for Circuit Court Operation

WHEREAS, § 753.19, Wisconsin Statutes, mandates that, "The cost of the operation of the circuit court for each county, except for the salaries of judges and court reporters provided to be paid by the state, and except for the cost assumed by the state under this chapter and chapters 40 and 230, and except as otherwise provided, shall be paid by the county;" and

WHEREAS, in the 1993-95 state biennial budget, the circuit court support and guardian ad litem payment programs were created to offset county costs related to circuit court operations; and

WHEREAS, a court support services surcharge was created to fund these payments to county government; and

WHEREAS, in state fiscal year 2005-2006, \$47.1 million was raised in court support services surcharge revenue; and

WHEREAS, in 2005, counties reported allowable court costs under the circuit court support payment program of \$13.2 million; and

WHEREAS, in 2005, counties received \$18,739,600 in payments under the circuit court support payment program; and

WHEREAS, in 2005, counties reported \$9.3 million in guardian ad litem costs; and

WHEREAS, counties received \$4,738,500 in guardian ad litem payments, the same payment level since the program began in 1994; and

WHEREAS, it is the desire of county governments across the state to maintain a working partnership with the state to ensure the court system operates fairly and efficiently; and

WHEREAS, the focus of the Supreme Court's 2007-09 budget submission to the Governor is "partnerships with counties and other justice stakeholders;" and

WHEREAS, the Supreme Court's budget proposal contains the following elements:

- The consolidation and formula revision of the circuit court support and guardian ad litem payment programs into a new payment program called the "Circuit Court Services Support Program;" support increased funding for the new program by requiring that 75% of the court support services surcharge revenues collected by counties in the previous calendar year be appropriated for payments under the new program in the next full fiscal year.
- A statutory change to allow for auditing of county court financial information; support the creation of an auditor
 position to institute a standardized program for the recording, reporting, and auditing of county circuit court costs
 and revenues.
- A statutory change and accompanying county reimbursement funding to require that interpreters be appointed in all cases regardless of indigency; support additional funds to cover increased interpreter costs under current law related to projected increased use of interpreters and additional certified interpreters.
- Funding to implement an ongoing court safety training program for judges, court commissioners, court reporters, clerks of circuit court staff, and other court and non-court employees located in county courthouses.
- That \$1 of the justice information system surcharge revenues currently deposited to the general fund be deposited to the Circuit Courts Automation Program (CCAP) to provide funding for the development of an e-filing system for all circuit court case types.
- The creation of a justice initiatives coordinator position and associated funding to implement and sustain the numerous recommendations made by the PPAC; and

WHEREAS, the Supreme Court's budget proposal will increase funding to counties by over \$12.5 million annually; and

WHEREAS, the Supreme Court's proposal shifts a portion of the funding for the State Court System from the

property tax fund to state funding;

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that Winnebago County fully offers its support for the budget submission of the Supreme Court for the 2007-09 biennium; and

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that Winnebago County requests Governor Jim Doyle offer this funding proposal in his budget submitted to the Wisconsin State Legislature; and

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that a copy of this Resolution be sent to Governor James Doyle, DOA Secretary Stephen Bablitch, Chief Justice Shirley Abrahamson, all area legislators, and the Wisconsin Counties Association.

RESOLUTION NO. 126-122006: Support Revision or Repeal of Section 70.11(21), Stats.

WHEREAS, Section 70.11(21) of the Wisconsin Statutes provides for an exemption from property tax for certain property used in treating waste or abating pollution; and
