Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Lennon.

Motion by Supervisor Robl and seconded to adopt tonight's agenda. CARRIED BY VOICE VOTE.

PUBLIC HEARING

Tom Egan, 3017 State Road 116, Omro expressed his concerns about Resolution No. 321-112007, "Authorize the Finance Department to Facilitate an Audit of Winnebago County Fair Association's Financial Records with Regard to 2007 Winnebago County Fair." He feels this is a duplication of the annual financial report that the Fair Association already presents to the Winnebago County Board.

COMMUNICATIONS, PETITIONS, ETC.

REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Egan reported that everyone has a CD on their desks containing the Personnel Function Review Committee's information. There will also be a hard copy of this information in the County Clerk's Office and the UW-Extension's Office for those who prefer to view a hard copy.

Supervisor Barker reported that a forum was held at the Coughlin Center last week where people voiced their opinions on what issues the UW-Extension system should be addressing in the next four years. Approximately 100 people were in attendance. Issues that people felt should be addressed included health care, farming, urban sprawl, job loss, elderly, global warming, taxes, teenage issues, etc.

Supervisor Eisen spoke on the Sustainable Fox Valley Workshop--Building Communities Through the Natural Step Approach. This workshop detailed the work of Swedish designers that uses a scientific method to achieve sustainable growth and development. This means minimizing the impact of chemicals that nature can't naturally recycle. Various municipalities in Winnebago County are or are considering these ideas.

Supervisor Lohry reported on her attendance at the November 6, Wisconsin Way meeting in Oshkosh.

Supervisor Maehl commended the Neenah High School soccer team for winning the state tournament for the second year in a row.

Supervisor Jacobson reported on the residents' holiday season events that will be held at Park View Health Center: December 3 & 4 – courtyard lights; December 12 – residents' Christmas shopping day—they are looking for people to donate new or gently used items for this event; Adopt a resident for Christmas by donating a gift or money. All donations should be given to Park View Health Center by December 16.

Motion by Supervisor Hotynski and seconded to approve the October 11 and October 16, 2007 proceedings. Supervisor Widener asked that his vote on Resolution No. 306-102007 (page 157) be changed to "nay.". Proceedings were approved as corrected - CARRIED BY VOICE VOTE.

COUNTY EXECUTIVE'S REPORT

Executive Harris asked for the Board's approval of Resolution No. 322-112007, "Appropriate Additional \$250,000 to the Park View Health Center Capital Project Fund to Cover Additional Construction Costs." This money will mainly come from the interest that has accumulated on the money in the account for this project. A substantial rebate of the Workman's Compensation Insurance may also be realized from this project if the current trend continues. Executive Harris explained that an agreement has been reached with Miron Construction and has almost been reached with Horty Elving Architects on the gable-related issues at Park View Health Center, but that compensation may not come until after the project is completed. He stressed the importance of getting this money now so the project can continue.

Executive Harris asked for the Board's approval of Resolution No. 315-112007, "Amend Section 1.12(7)(a) of the General Code of Winnebago County (Per Diem, Mileage Expense Requirements: County Board of Supervisors)." He stated that the Board is entitled to this increase. He also feels if the Board doesn't increase their compensation, it may discourage people from running for these positions in the future.

Executive Harris asked that the Board approve Resolution No. 323-112007, "Adopt Revisions to the Winnebago County Administrative Salary Schedule." He explained that in 2005 these non-represented employees had their sick leave payouts frozen at the December 31, 2005 levels and their step raises were also frozen. Pay for performance increases were also discontinued on December 31, 2005. Executive Harris feels that it is time for these employees to receive pay increases that are commensurate with the raises that union employees have received.

Executive Harris reported that he has looked into the Personnel Function Review Committee's recommendation that Winnebago County and Outagamie County consider combining their Veterans Service Office. He discovered that combining the Veterans Service Office with another county, would cause the annual federal grant to each county to be substantially reduced, so any savings that would have been realized by combining the two offices would be offset by that reduction in the grant.

COUNTY EXECUTIVE'S APPOINTMENT

Director of Veterans Services

Executive Harris asked for the Board's approval of his appointment of Robert P. Stone as the Winnebago County Director of Veterans Services Officer. Mr. Stone comes from Rusk County, where he has served as their Veterans Service Officer.

CHAIRMAN'S REPORT

Chairman Albrecht announced that the annual County Board Christmas party will be held on Thursday, December 13 at the Fin & Feather in Winneconne.

INFORMATION SYSTEMS DEPARTMENT REPORT – PATTY FRANCOUR, INFORMATION SYSTEMS DEPARTMENT DIRECTOR

Patty Francour, Information Systems Department (IS Department) Director, presented her Personnel Function Review Report to the Board. Ms. Francour explained that the functions and responsibilities of her department.

- There are 16 employees in the department.
- There are eight programs (areas of service) that the IS Department provides. These programs are not mandated, but they support the programs in other departments that are mandated.
- A centralized IS Department allows control over the county's technology-related costs.
- Set standards help her support team and reduces the duplication of services/work.

- Network resources availability and the uptime of the network is an excellent measure of customer service.
- The IS Department is a 24/7 department.
- Departmental mission statement: To work with each customer to provide the needs they define for their department while balancing the requirements for security and functionality across a very complex network.
- Staff has been reduced by 1.5 positions.

Ms. Francour then presented information on the various program categories in the IS Department. They are ranked in order of importance:

- 1. Network Infrastructure: Maintain the connectivity systems and fiber optic network supporting the county's business application systems.
- 2. Telecommunication: Determine county needs and maintain installed systems.
- 3. Public Safety: Maintain and support the Public Safety Systems within Winnebago County.
- 4. User Support: Operate and maintain computer and telecommunications systems and supply help desk support on related devices and software.
- 5. Training: Provide in-house training to our customers in the use of a wide variety of office automation systems
- 6. Budget: Determine needs/requirements for computer and telecommunication requests as part of the annual budget process.
- 7. System Design & Development: Provide user support in the design and development of custom applications.
- 8. Inventory: Maintain detail records of all county mainframe and microcomputer hardware, software, and telecommunications equipment.
- 9. Project Management: Provide management and support in the acquisition of purchased software and applications for County departments.

WHEREAS, it is in the best interest of Winnebago County that the salaries of non-represented employees keep pace with that of unionized employees in order to attract and maintain qualified managerial and supervisory employees throughout Winnebago County departments;

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Winnebago County Administrative Salary Schedule to be amended so as to increase the wages of covered employees having continuing satisfactory job performance by 3%, across-the-board, effective January 1, 2008.
