### WINNEBAGO COUNTY BOARD MEETING TUESDAY, JANUARY 15, 2008

Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Locke.

#### **PUBLIC HEARINGS**

Ann Frisch, 3565 Bambi Lane, Oshkosh; thanked the County Clerk's Office for their assistance on reviewing touch screen voting data from the November 2006 election. Dr. Frisch expressed concern about the AT&T contract being addressed in Resolution No. 343-12008 and her request to obtain a copy of that contract.

Michael Vanvonderen, 330 West Wilson Street, Appleton, President of the UW-Fox Valley Student Association, expressed his support of Resolution No. 340-12008, "Authorize Purchase of Property Located at 1655 University Drive, City of Menasha (UW Fox Valley)".

Dean James Perry, UW Fox Valley, spoke in support of Resolution No. 340-12008, "Authorize Purchase of Property Located at 1655 University Drive, City of Menasha (UW Fox Valley)".

Leigh Ann Kohls, President of the Winnebago County Courthouse Association, spoke in opposition to Resolution No. 338-12008, "Reclassification of Secretarial Position in the Parks Office".

### COMMUNICATION, PETITIONS, ETC.

Petition for zoning amendment from Algoma Sanitary District #1, for zoning change for tax parcel no. 002-0212-05 from A-2 to R-1 for a water treatment facility, administrative building and garage was referred to the Planning & Zoning Committee.

### REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Hall addressed Dr. Frisch's concern about the AT&T contract and its approval by a county committee. Supervisor Hall stated that the IS Committee did not approve the contract, but forwarded it to the County Board without recommendation.

Supervisor Barker stated that at this point she does not have any agenda items for the January Legislative Committee meeting. If anyone has an item for the agenda, they should get that information to her.

Supervisor Rengstorf asked that the Supervisors look at the "Transportation Programs and Services for Elderly or Disabled Persons in Winnebago County" brochure that was placed on their desks. This is updated annually and contains important information. Additional copies are available from the County Clerk's Office.

#### COUNTY EXECUTIVE'S REPORT

County Executive Harris expressed his support of Resolution No. 340-12008, "Authorize Purchase of Property Located at 1655 University Drive, City of Menasha (UW Fox Valley)". Executive Harris explained that because this property is adjacent to the UW-Fox Valley campus, purchasing it will immediately alleviate parking problems at the campus. Executive Harris stated that it is priced reasonably. The cost for Winnebago and Outagamie Counties will be just under \$450,000 each.

Executive Harris discussed the upcoming Spring Election and the impact it could have on the Winnebago County Board. He explained that six supervisors are retiring, in four districts incumbents are running against each other, and six other incumbents are facing challengers. Because of these three situations, there will be ten and potentially sixteen new supervisors on the County Board. Executive Harris expressed his concern about losing a number of experienced committee chairmen. He asked that area news media realize the importance of this upcoming election and the impact of these changes.

On the lighter side, Executive Harris spoke to the Board about the movie that is being made about the life of John Dillinger, starring Johnny Depp. There is a chance that scenes for that movie will be shot at various banks in Oshkosh and possibly at the courthouse. Executive Harris stated that it would be a nice opportunity for

# DOUG GIERYN, WINNEBAGO COUNTY HEALTH DEPARTMENT DIRECTOR PERSONNEL FUNCTION REVIEW COMMITTEE PRESENTATION

Doug Gieryn, Winnebago County Health Department Director, presented the report he gave to the Personnel Function Review Committee outlining the programs/functions of his department. They are, in priority order:

- 1. General Public Health Services provided to clients of all age groups in the following areas:
  - General Public Health General consultation including home visitation on health issues especially to those with chronic diseases and disability, health education, injury prevention, wellness promotion, health prevention programming, community monitoring and referral.
  - Communicable Disease Communicable disease surveillance, epidemiologi follow-up, disease containment, education, outbreak investigation, case referral and report. Tuberculosis skin testing for general public, county employees and contracted agencies.
  - Immunizations Provision and monitoring of required immunizations to prevent vaccine preventable diseases in children. Vaccines for adults on a fee for service basis.
  - Seasonal Influenza Monitoring of disease, public education and provisions of flu vaccine to homebound elderly and contracted agencies.
  - Jail Services Hepatitis A vaccination of food service worker and HIV counseling and testing.
  - ❖ HIV Partner Referral/Counseling & Testing HIV partner referral for HIV positive clients.
  - 1. Women, Infants and Children (WIC) A food supplement and nutrition education program offered to eligible pregnant women, breast-feeding women, women who have had a baby in the last six months, infants and children up to age five.
  - 2. Public Health Nursing Provides public health nurse based services in the following program areas and other related services:
    - MCH Provides coordinated health care services to women during and after pregnancy and to infants and children by providing assessment, planning, monitoring, education and referral.
    - PNCC Prenatal Care Coordination is a Medicaid program providing case management services for low income or high risk pregnant women and their families to improve birth outcomes by early identification, psychosocial support, cares, education and access to medical and other services.
    - ❖ Daycare Health education and monitoring of immunization, communicable disease, food safety and injury prevention for daycare children, staff and parents.
    - Personal Care Provides care to clients who need assistance to enable them to stay in their homes.
    - Housing Authority Nursing services including assessment, referral, medication set-up, health monitoring and service coordination provided to Housing Authority residents.
    - Long Term Assessments Nursing assessment for health as a part of a screening.
    - ❖ Health Check-Well Child Provides health screening and education for ages birth to 2.
  - 3. Environmental Health Ensures an environment that protects and promotes health by assessing, correcting, controlling and preventing those factors in the environment that can potentially affect adversely the health of individuals and the community.
    - ❖ Sanitarian Inspections, consultation, code enforcement and licensure of food service establishments, campgrounds, temporary restaurants, swimming pools, hotel/motels, bed & breakfasts, mobile home parks, transient non-community wells and tattoo parlors.
    - Environmental Health Inspection, consultations and education to prevent and minimize adverse environmental exposures from air, water, housing, occupation, toxic materials, human health hazards and nuisances.
    - Tobacco Free Coalition Promotion of smoke free policies and tobacco use cessation, education, youth advocacy, tobacco retailer compliance checks and coordination of the Tobacco Free Coalition.
  - 4. Administration Provides departmental leadership, supervision, programmatic oversight, support staffing, supplies, billing, accounting and budget. Responsible for health assessment, policies, enforcement, data management, community partnership, planning, fund seeking and workforce development.

5. Public Health Preparedness – Community preparedness planning and exercises to respond to crisis or disaster including pandemic influenza, mass clinic operation, nuclear/biological/chemical accident or terrorism, participation in regional consortium activities and overall 24/7/365 availability of health department staff.

WHEREAS, Advance Tooling Equities, Incorporated, the owner of property located at 1655 University Drive in the City of Menasha, has listed said property for sale; and

WHEREAS, said property is contiguous to the University of Wisconsin Fox Valley campus; and

WHEREAS, said property is located on 1.975 acres and includes a building which was formerly used for light industrial purposes with an office, shop and warehouse area containing 19,476 square feet, 35% of which is available as office space; and

WHEREAS, presently, the University of Wisconsin Fox Valley is renting office space at another site as well as utilizing outside property for parking; and

WHEREAS, should the University of Wisconsin Fox Valley acquire the property at 1655 University Drive, it will allow for offices in existing buildings to be moved to the newly acquired building thus creating two or more classrooms for academic needs; and

WHEREAS, the owner of the building and Winnebago and Outagamie County have jointly agreed to have a neutral appraisal of the property performed by McClone Appraisal, Incorporated and McClone Appraisal has appraised said property at \$895,000; and

WHEREAS, the property at issue also contains a cellular phone tower whose rental income would be returned to Winnebago County and Outagamie County; and

WHEREAS, the UW Fox Valley campus is presently landlocked, thus making purchase of a parcel contiguous to that campus judicious; and

WHEREAS, the East Central Wisconsin Regional Planning Commission is presently predicting a population growth of approximately 28% in the population of Outagamie and Winnebago Counties in the next 20 years, thus increasing the demand for affordable education in this area; and

WHEREAS, your undersigned Committee recommends purchase of the above property at the appraised price.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the purchase of property located at 1655 University Drive in the City of Menasha for use by the University of Wisconsin Fox Valley Campus.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that said purchase shall be contingent upon passage of a similar resolution by Outagamie County wherein Outagamie County agrees to purchase said property and pay for half the cost of said property.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the transfer of a sum not to exceed \$450,000 from the Capital Reserve Fund of the Winnebago County Budget for the purchase of said property, with said funds to be used for the purchase of said property and for any closing costs or other costs which may be associated with said purchase.

# RESOLUTION NO. 342-12008: Appropriate Additional \$1,863,000 of Un-anticipated Revenue to Additional Expenditures in the Human Services 2007 budget.

WHEREAS, the Human Services Department received \$1,863,000 of un-anticipated general grant revenue during 2007; and

WHEREAS, there were additional expenditures incurred during 2007 as a result of the higher mileage reimbursement rate than was originally budgeted; additional specialty hospital costs; and community residential care services; and

WHEREAS, the additional revenues were more specifically the result of additional long term support relocation funding, medical assistance, client cost share fees and collection agency recoveries; and

WHEREAS, all of the additional expenditures are covered by the additional revenue so that there is no funding being requested from the General Fund.
