Supervisor Koziczkowski reported that the following public hearings on the Human Services Department budget have been scheduled: June 25 – Neenah Human Services Department; June 26 – Oshkosh Human Services Department.

Supervisor Kline reported that there will not be a Legislative Committee meeting in June. Their next meeting will be July 28 @ 8:30 a.m.

Supervisor Barker reported that she has distributed a packet of information from the UW Extension Education Department to each supervisor on food safety in an emergency. Supervisor Barker also stated that on September 6 there will be an event commemorating the 75th anniversary of Winnebago County's UW-Extension Department. Supervisor Barker will be conducting a class on the history of the UW-Extension Department that day and she is in need of information for her class. She asked that if anyone has any information she could use for the history class, that they get that information to her. Supervisor Barker also reported on the National Shoreline Exposition that was held at the Sunnyview Exposition Center on May 31. It was sponsored by the Land & Water Conservation Department and over 200 people attended the event. On June 16, a training session was held for the new county supervisors who serve on the Land & Water Conservation Committee. The training session was conducted by the Wisconsin Association of Land Conservation, the Wisconsin Department of Agriculture, the DNR, the Natural Resources Conservation Service, USDA Farm Service Agency and the county Land & Water Conservation Department.

Supervisor Widener reported that he and Supervisor Eisen attended at the Wisconsin Association of County Extension Committees (WACEC) Conference today in Stevens Point. They will be returning tomorrow because former County Board Chairman and Supervisor Joe Maehl will be honored for his many years of service to the UW-Extension system. Supervisor Widener also expressed his opinion on the resolutions on tonight's agenda that change the titles of county positions in various county departments. He recommends passage of these resolutions, because he feels they are smart administrative decisions made by these department heads. Supervisor Widener also expressed his support of Chuck Orenstein, Winnebago County Finance Director's, suggestion that departments bring their monthly income statements to their committee of jurisdiction's meeting for review and comparison to their budgets. This would keep the committees and county board informed of the departments' budget status and eliminate any budgetary surprises at the end of the year.

Supervisor Finch reported on the Parks & Recreation Committee's annual tour of the county's boat landings. It was very educational and everyone in attendance enjoyed the opportunity to view the facilities.

Supervisor Eisen reported that the listening sessions he held on June 16 was very successful. They were attended by four citizens. He looks forward to doing this again and encouraged his colleagues to do the same.

COUNTY EXECUTIVE'S REPORT

Executive Harris congratulated the students who were awarded the county's scholarships this evening. Executive Harris commended Linda Kollmann, Winnebago County Emergency Management Director, her staff –Sue Verwey and Bill Curtis—for the excellent job they are doing as they work with various agencies to help the citizens of Winnebago County recover from the recent round of floods. Mr. Harris expressed is concern for all the people that suffered damage as a result of these floods. Many people have suffered tremendous loss and damage—some people have even lost their homes.

Mr. Harris stated that Ms. Kollmann will be making a presentation to the county board sometime in the next few months on the floods and her department's role in this disaster.

RESOLUTION NO. 39-62008:

Request Governor and State Legislators to Enact Legislation to Reemphasize the Transportation User Fee Concept Thus Segregating Fuel Tax Revenues and Vehicle Registration Fees Specifically for the Transportation Fund

WHEREAS, an amount equal to about one-third of the state's 30.9 cent per gallon fuel tax is being used this year for non-transportation purposes; and

WHEREAS, the previous state budget trransferred \$675 million from the Transportation Fund to help address the General Fund's \$3.2 billion deficit; and

WHEREAS, \$524 million was restored, not with fuel tax revenues, but through bonding adding to Wisconsin's "negative" AA3 Moody's rating; and

WHEREAS, the 2005-2007 State's Biennium Budget also calls for transferring over \$600 million from the Transportation Fund to the General Fund and replacing a portion of those funds again through bonding; and

WHEREAS, the budget is "balanced" with over \$1 billion on one-time monies, fund transfers and accounting shifts to the next biennium; and

WHEREAS, Wisconsin's Transportation Fund has traditionally been "segregated" from the General Fund because of the user fee concept; and

WHEREAS, maintaining and rebuilding the State's highway infrastructure and bridges is vital to the State, counties, and all municipalities to support commerce and tourist; and

WHEREAS, we must maintain the quality of roads to provide safe transportation of not only goods and services, but for the citizens of the State.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby requests that the Governor and State Legislators enact legislation to re-emphasize the transportation user fee concept, thus segregating fuel tax revenues and vehicle registration fees specifically for the Transportation Fund.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that a copy of this resolution be forwarded to the Governor, Legislators representing Winnebago County and to all other counties in the State of Wisconsin.

RESOLUTION NO. 40-62008:

Authorize Execution of Ground Lease Between Winnebago County and Daniel McElroy (Lease Construction: Wittman Regional Airport)

WHEREAS, Daniel J. McElroy has approached Winnebago County in relationship to entering into a ground lease so as to allow the construction of a 55 foot by 55 foot hangar on approximately 4,225 square feet of property; and

WHEREAS, the term of the lease would be for a twenty (20) year period commencing on June 1, 2008; and WHEREAS, said property would be leased at a rate of \$.13 per square foot per year or \$550, whichever is greater; and

WHEREAS, said lease would be adjusted annually pursuant to the rate of increase in the Consumer Price Index for urban consumers for the previous three (3) years; and

WHEREAS, the Aviation Committee believes that the execution of such a lease by Winnebago County would be in the best interest of Winnebago County and its citizens; and

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Winnebago County Executive and Winnebago County Clerk to execute a ground lease between Winnebago County and Daniel J. McElroy for property owned by Winnebago County which is located at Wittman Regional Airport which is approximately 4,225 square feet in size, and as is described in the proposed lease agreement, which is herewith incorporated by reference, for a term of twenty (20) years at an initial rate of \$.13 per square foot or \$550 per year, whichever is greater. A copy of the complete lease agreement may be obtained upon request from the Airport Director or the Office of Corporation Counsel. The lease shall commence on June 1, 2008 and shall run through May 31, 2028.

(k)	428 Aviation Road	\$ 120.75/month

As the purpose of T-hangars is the storage of aircraft owned by the LESSEE of the hangar, persons who have signed T-hangar leases, and do not have an aircraft registered to them, shall pay a monthly surcharge of \$100.00 in addition to the monthly hangar rental rate. Any LESSEE of a hangar who stores an aircraft not registered to them in a hangar for which they have a signed lease, shall first obtain written permission from the Airport Director.

BE IT FURTHER ORDAINED by the County Board of Supervisors of the County of Winnebago that said amendment to said ordinance shall be effective as of July 1, 2008 and shall be applicable to all new leases commencing subsequent to said date or to any lease extensions executed subsequent to said date.
