# COUNTY SCHOLARSHIP SURVEY RESULTS – COUNTY BOARD SUPERVISOR TOM WIDENER & CHRIS KNIEP, UW-EXTENSION FAMILY LIVING COORDINATOR

Supervisor Widener explained that in an attempt to determine how the County Board wanted the UW Education, Extension and Agriculture Committee to handle the county's scholarship program, a survey was conducted.

Chris Kniep stated that the survey was sent out to all 36 County Board Supervisors and 29 supervisors responded, however not all 29 supervisors answered every question.

Ms. Kniep then explained the questions asked in the survey and the results of those questions.

- Degree of agreement with the statement, "Winnebago County should have a scholarship program": 39% strongly agree; 23% somewhat agree; 15% somewhat disagree; 19% strongly disagree; 4% have no opinion
- Select their choice of the fairest way to ensure all high school seniors have an opportunity to receive a scholarship:
  - Select recipient on an "at-large" basis 12 supervisors
  - Top applicants 3 supervisors
  - One scholarship per school 3 supervisors
  - Only residents should receive scholarship 4 supervisors
  - Simplify the process 4 supervisors
  - More advertising 4 supervisors
- Rank the following three options:
  - o 61% Award scholarship on an at-large basis
  - 18% keep the program the same
  - 17% other
  - 4% 1 scholarship for each of the larger schools and 1 for a group of smaller schools
- Appropriate dollar amount for each scholarship:
  - o<sup>60%</sup> \$1,000
  - o 10% \$2,000
  - o **20% \$3,000**
  - o 10% greater than \$3,000
- Maximum total amount of money spent on scholarships: ranged between \$5,000 to \$16,000—average being \$10,045.45

• Additional comments were also included on the survey by some supervisors.
