Supervisor Barker reported that she attended the Land and Water Convention in Appleton. She explained that all of Wisconsin's counties are working hard to make their budgets "stretch", which includes eliminating wage increases and increasing the employees' contributions to their health insurance. Supervisor Barker reported that she gave a speech on how water ties the communities between Oshkosh and Green Bay together and the impact water has had on this areas industries and farms.

Supervisor Kline reported that there will not be a Legislative Committee meeting in December.

Supervisor Koziczkowski reported that proposed Lakeland Long Term Care District that Winnebago County is considering with Manitowoc and Fond du Lac Counties has been put on hold until they know for sure that money for such a district will be included in Wisconsin's budget. Supervisor Koziczkowski will keep the Board informed on the progress of this district.

Supervisor Farrey reported that he also attended the Land & Water Convention in Appleton and attended two seminars:

- Outagamie County's agricultural inventory applications, which is a GIS program used for identifying agricultural lands
- Milk Source LCC—explained the steps they need to go through to establish their large (7,000 cows) dairy farms.

Supervisor Hall reported that there will be an Information Systems Committee meeting on Wednesday, December 17. One of the agenda items that will be discussed is county e-mail accounts for county board supervisors.

COUNTY EXECUTIVE'S REPORT

Executive Harris recommended approval of Resolution No. 122-122008, "Appropriate \$1,643,000 of Additional State and Federal Funds to the Human Services Department That Have Been made Available to Serve Additional Clients and Provide for Additional Client Placements During 2008." He explained that the money in this resolution is not additional revenue for the Human Services Department, but rather it is money that is available because the Human Services Department provided services to more people than they budgeted for in 2008.

Executive Harris stated that he wanted to update the Board on single stream recycling since it has been mentioned numerous times in the media. He explained that single stream recycling does not require the City of Oshkosh to make any changes to their garbage collection practices. He stated that there may be a discontinuation of the use of blue bags for recyclables at some point in the future.

Executive Harris stated that he has some copies available of two reports for those supervisors who are interested in them. One of the reports is Wisconsin Way's <u>Blue Print for Change</u> and the other is a catalog of tax reform options from the Institute for Wisconsin's Future and Wisconsin's Counsel on Children and Families.

Chairman Albrecht stated that last night's Christmas party was well attended and everyone had a very nice time.

JOHN DIRKSE, EXECUTIVE VICE PRESIDENT OF AEGIS CORPORATION – PRESENTATION OF WORKERS COMPENSATION INSURANCE DIVIDEND CHECK

John Dirkse, Executive Vice President of Aegis Corporation, explained that in 2001 Wisconsin County Mutual Insurance Corporation began working with member counties involved in building projects by removing the contractors' share of premium for worker's compensation insurance coverage and then returning the savings to the counties. Mr. Dirkse stated that they have participated in fourteen building projects in the last seven years and they have returned approximately \$2.5 Million to the counties.

Mr. Dirkse stated that tonight is the second time Winnebago County has received this type of dividend check from Aegis Corporation. He then informed the Board that Winnebago County will be receiving a workers compensation dividend check in the amount of \$175,287.00 for the completed Park View Health Center project.

Mr. Dirkse thanked Winnebago County for their continued support and participation with Aegis Corporation and Wisconsin County Mutual Insurance Corporation.

RESOLUTION NO. 112-122008:

Transfer \$134,563 from the Highway Department Undesignated Fund Balance to the Wage and Benefit Accounts of the Highway Department to Cover a Potential Budget Overrun for 2008.

WHEREAS, a review and projection of the Highway Department labor accounts at the end of November appear that they will run over budget by the end of 2008; and

WHEREAS, as of the end of November, the Highway Department is not yet over budget; and

WHEREAS, most of the projected overrun is the result of additional overtime that was incurred during the beginning of 2008 due to the harsh 2007/08 winter; and

WHEREAS, it was originally believed that there might be sufficient funds at that time to make it through to the end of the year; and

WHEREAS, it is now apparent that there will not be sufficient funds to carry the department through the end of 2008.
