ORGANIZATIONAL/ORIENTATION SESSION WINNEBAGO COUNTY BOARD OF SUPERVISORS TUESDAY, APRIL 15, 2008

County Clerk Sue Ertmer called the meeting to order at 6:00 P.M. in the Supervisors' Room, Fourth Floor, Courthouse, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an Invocation by Supervisor Lennon.

COUNTY EXECUTIVE REPORT

Executive Harris congratulated the supervisors on their election to the Board. He invited the new supervisors to come to his office to meet with him and discuss issues facing the county.

OATH OF OFFICE

Judges Barbara Key and Scott Woldt administered the oath of office to the supervisors.

PUBLIC HEARING

Paul Eisen, 1807 Brighton Beach Road, Menasha, informed the Board that the Town of Menasha passed a resolution to place a referendum question on the November 2008 ballot asking if the Town of Menasha should withdraw from county zoning. In light of this action, Mr. Eisen asked that the County Board Chairman consider having Town of Menasha representation on the county's Planning & Zoning Committee.

ELECTION OF COUNTY BOARD CHAIRMAN

Motion by Supervisor Norton and seconded to nominate Supervisor Jef Hall as Chairman.

Motion by Supervisor Koziczkowski and seconded to nominate Supervisor David Albrecht as Chairman. County Clerk Sue Ertmer asked three times if there were any more nominations for Chairman. Hearing none, the nominations were closed.

Blank ballots were distributed to the Board. After voting, the Supervisors' ballots were collected and counted. Supervisor Hall received 6 votes and Supervisor Albrecht received 30 votes. Supervisor Albrecht was then seated as Winnebago County Board Chairman.

Chairman Albrecht thanked the Board for re-electing him as their Chairman.

ELECTION OF COUNTY BOARD VICE CHAIRMAN

Chairman Albrecht called for nominations for Vice Chairman.

Motion by Supervisor Diakoff and seconded to nominate Supervisor Patrick Brennand as Vice Chairman.

Motion by Supervisor Schmuhl and seconded to nominate Supervisor Stan Kline as Vice Chairman.

Motion by Supervisor Farrey and seconded to nominate Supervisor Shiloh Ramos as Vice Chairman.

Chairman Albrecht asked three times if there were any more nominations for Vice Chairman. Hearing none, the nominations were closed.

Blank ballots were distributed to the Board. After voting, the Supervisors' ballots were collected and counted. Supervisor Brennand received 15 votes, Supervisor Kline received 10 votes and Supervisor Ramos received 10 votes. The intent of the voter for one ballot could not be determined.

Because none of the candidates received a majority of the votes, the Board received a second ballot for the election of the Vice Chairman. On this ballot, Supervisor Brennand received 17 votes, Supervisor Ramos received 10 votes and Supervisor Kline received 9 votes.

Because none of the candidates received a majority of the votes, the Board received a second ballot for the election of the Vice Chairman. Supervisor Kline was eliminated from this ballot. On this ballot, Supervisor Brennand received 24 votes and Supervisor Ramos received 11 votes. The intent of the voter for one ballot could not be determined.

Supervisor Brennand was seated as the Winnebago County Board Vice Chairman. Vice Chairman Brennand thanked the Board for electing him as their Vice Chairman.

ORIENTATION SESSION

Sue Ertmer, Winnebago County Clerk, explained how supervisors indicate their presence at meetings, request to speak during a meeting and cast their votes on the County Board voting system.

John Bodnar, Winnebago County Corporation Counsel, discussed his role as the attorney for Winnebago County in all civil matters. Mr. Bodnar told the Board that if they have any legal questions about their role as a county board supervisor they should contact him.

Mr. Bodnar also went over provisions of the open meeting and open records laws. Under the open meetings law, he explained that county meetings must be posted no less than 24 hours before their start time and that the only things that can be discussed and acted on at those meetings is what is listed on the agenda.

Mr. Bodnar also explained that e-mails regarding county business that a supervisor either sends or receives on his personal computer is subject to the open records law and must be retained. If an open records request is made for those e-mails, they would need to be made available to the requestor.

Mr. Bodnar distributed copies of the Winnebago County Board of Supervisors Ethics Handbook and went over some of the more common situations that county supervisors should be aware of and avoid. These situations included bribery, personal business dealings with the county, when not to vote on a resolution or ordinance, and what the restrictions are on accepting gifts or "tokens of appreciation" from people or organizations that the supervisors may find themselves working with.

Karon Kraft, Winnebago County Human Resources Director, and Mary Polishinski, Payroll and Benefits Manager, addressed the Board. Ms. Kraft explained that Winnebago County employees 1200+ people and has seven unions/associations and those employees not represented by a union or an association are classified as non-represented employees.

Mary Polishinski explained what forms and paperwork the newly elected supervisors needed to file in the Payroll Department before they can receive their per diem checks. Ms. Polishinski also explained the proper way to fill out the per diem sheets. She stated that per diem checks are processed on the 15th of each month, so the supervisors need to submit their per diem sheets for processing by the end of the previous month. She asked that the supervisors fill out the forms legibly so that they can be properly processed.

At this point in the meeting, Chairman Albrecht called for a brief recess.

- 24.1 UNIVERSITY OF WISCONSIN EDUCATION, EXTENSION & AGRICULTURE COMMITTEE

This committee shall be composed of five County Board supervisors and shall act as the "Committee on Agriculture

and Extension Education" as referred to in Section 59.56(3), Wis. Statutes. The Committee shall review policy issues relating to the County University Extension Program, County Library Services and the Winnebago County Fair and shall revise and recommend appropriate policy goals and legislative actions to be taken by the County Board.

At least two members of this Committee shall be members of the Land and Water Conservation Committee. Two members of the committee shall function as Winnebago County members of the Board of Trustees of the University of Wisconsin-Fox Valley Campus.

This Committee shall establish procedure and make recommendations to the County Board of Supervisors as to the award of college scholarships from the College Scholarship Fund to students who are residents of Winnebago County and who are attending high schools located within Winnebago County.
