#### WINNEBAGO COUNTY BOARD MEETING TUESDAY, JUNE 21, 2011

Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

The meeting was opened with the Pledge of Allegiance and an invocation by Supervisor Lennon.

Supervisor Kline reported that there will be a Legislative Committee meeting on Monday, June 27 at 8:30 a.m.

#### **COUNTY EXECUTIVE'S REPORT**

Executive Harris discussed Resolution No. 254-62011, "Adopt Revisions to the Winnebago County Administrative Salary Schedule", which is the proposal for a 2012 pay increase for non-represented employees. Executive Harris explained that the county employees will see a net decrease of \$2 Million in their pay as a result of their contributions to the state retirement program. Most of the county's bargaining units have reached agreements with the county that include participation in the state retirement system starting January 1, 2012.

Executive Harris stated that he believes these "nominal" raises for non-represented employees is appropriate considering that this group has made significant concessions. They have given up accumulation of sick time for payouts, pay for performance increases and step increases. In addition, the non-represented employees have not received pay increases equivalent to the county's other bargaining units.

Executive Harris explained that Resolution No. 254-62011 will give all non-represented employees a 1.5% pay increase as of January 1, 2012. In addition, as a substitute for the step raises they have not received, all non-represented employees who are below the mid-point for their job description will receive an additional 1%. Executive Harris stated that this will be done on a year-by-year basis to create a parallel between the non-represented and the union employees in the county

Executive Harris took questions from the Board.

### **COUNTY EXECUTIVE APPOINTMENTS**

#### **Local Emergency Planning Commission**

Executive Harris asked for approval of his appointment of Gordon Ledioyt of the Winnebago County Sheriff's Office to the Local Emergency Planning Commission. Mr. Ledioyt will replace John Zimmerman on the commission. His term will expire on December 31, 2012.

Motion by Supervisor Robl and seconded to approve. CARRIED BY VOICE VOTE.

#### **Winnebago County Housing Authority**

Executive Harris asked for approval of his reappointment of Scott Waterworth to the Winnebago County Housing Authority. Mr. Waterworth will replace Patty Maehl, whose term has expired. Mr. Waterworth's term is for five years and will expire on April 19, 2016. Motion by Supervisor Robl and seconded to approve. CARRIED BY VOICE VOTE.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby appropriates \$24,391 to the various accounts outlined in the attached budget transfer to cover additional costs of The Wisconsin Supreme Court race recount.

# RESOLUTION NO. 248-62011: Request Sheriff to Read Declaration of Independence on Courthouse Steps on July 4, 2011

WHEREAS, the Continental Congress, by a Declaration of Independence, dated July 4, 1776, clearly declared the inhabitants of New Hampshire, Massachusetts, Rhode Island, Connecticut, New York, New Jersey, Pennsylvania, Delaware, Maryland, Virginia, North Carolina, South Carolina and Georgia, were no longer colonial subjects to be exploited arbitrarily by servants of the King and Parliament of Great Britain, but now were free citizens of their own territories, and that free citizens should constitute the governments for those territories; and

WHEREAS, the Continental Congress provided that same day, by orders of their House, that their Declaration should be proclaimed aloud and published to the free citizens of the territories represented in their Congress; and

WHEREAS, the notification of the Declaration to responsible citizens was then done by sheriffs, who proclaimed it at the courthouse steps, by clergymen, who read it from their pulpits, and by printers, who printed it in their gazettes; and

WHEREAS, the Continental Congress thus initiated a process that has created the Constitutions and state governments of our Union including the Constitution and government of the State of Wisconsin.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby requests Sheriff John Matz to read the Declaration of Independence from the steps of the Courthouse at 8:00 a.m. on the morning of July 4, 2011, as this was the custom in the early history of our country.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that we ask Sheriff Matz to read the document without further comment or speech. This event is intended for those present to hear the words of the Declaration as we begin to celebrate our Day of Independence.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Winnebago County Administrative Salary Schedule to be amended to increase the wages of covered employees having continuing satisfactory job performances by 1.5% across-the-board, effective January 1, 2012.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Winnebago County Administrative Salary Schedule to be amended to increase the wages of covered employees having continuing satisfactory job performances by an additional 1.0% (for a combined total increase of 2.5%), effective January 1, 2012, if: they have not reached their control point as a salaried employee; or reached Step E in Pay Ranges H-1, H-2, H-3, H-4, H-5, H-6, H-7, and H-8 positions; or reached Step C in Appendix A positions (Public Health, Park View Health Center, and Sheriff's Nursing positions); or reached Step 3 in Appendix B positions (Craft employees); or reached Step B in Appendix C positions (Sheriff's Department positions); or reached Step D in Appendix D hourly positions.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that said amendments to the Winnebago County Administrative Salary Schedule shall become effective as of January 1, 2012.
