WHEREAS, the Corporation Counsel has surveyed available legal services in the community and has determined that it will be more efficient and cost effective to bring this work in-house, which will require additional staff; and

WHEREAS, adding one full-time attorney and one full-time paralegal to the Corporation Counsel's Office staff will enable the Office to provide representation in mental health commitment matters without relying on outside counsel, as well as reducing overtime costs and enhancing current workflow components; and

WHEREAS, adding additional staff will require budget transfers totaling \$78,057, as detailed below, to cover the remainder of the 2019 calendar year, with amounts for future years to be included in the Corporation Counsel's future budgets.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby amends the Table of Organization for the Winnebago County Corporation Counsel's Office by adding one full-time Assistant Corporation Counsel position and one full-time Paralegal position; and

RESOLUTION NO. 173-072019: Authorize Contract Between AT&T Corporation and Winnebago County (Telephone Line Service)

WHEREAS, the telephone line service contract between Winnebago County and AT&T Corporation is currently primary rate interface (PRI) in the Integrated Services Digital Network; and

WHEREAS, AT&T Corporation is working extensively to convert customers to session initiation protocol (SIP) as they phase out PRI technology; and

WHEREAS, Winnebago County needs to test existing phone-related applications as we convert; and

WHEREAS, AT&T Corporation offers competitive state contract pricing for the provision of telephone line service; and

WHEREAS, as Winnebago County proceeds to convert from PRI to SIP, each SIP line will result in a monthly cost savings compared to PRI line; and

WHEREAS, after careful review, the undersigned Committees have recommended the approval of a contract between Winnebago County and AT&T Corporation for the provision of telephone line services, for a period of five (5) years, effective upon the installation of the final SIP line.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby approves the execution of a five (5)-year contract between Winnebago County and AT&T Corporation for the provision

of telephone line services to all of Winnebago County's buildings, effective upon the installation of the final SIP line, pursuant to those terms outlined in the attached contract, which is made a part of this Resolution and incorporated herein by reference.

with only one swing set and a slide, it is appropriate to install inclusive play equipment at this site; and

WHEREAS, inclusive play equipment installed at this site will also allow the equipment to be serviced by the same accessible path being used for the nearby outdoor fitness equipment; and

WHEREAS, having inclusive play equipment centrally located at the Shelter #2 site will complement the area and will be of genuine value as it will incorporate the attributes of Universal Design standards; and

WHEREAS, by having inclusive play equipment built under Universal Design standards, Winnebago County will have in place a facility capable of providing recreational opportunities to all ages and abilities for the foreseeable future and provide a valuable resource for those with both physical and cognitive disabilities; and

WHEREAS, the Winnebago County Parks Department received a 'Meet Me at the Park' grant from the National Recreation and Park Association / Walt Disney Company that can be used to purchase and install recreation-based equipment within the confines of the Community Parks' The Natural Way; and

WHEREAS, accepting the additional funding and purchasing this equipment would be beneficial to the residents of Winnebago County.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Winnebago County Parks Department to accept a 'Meet Me at the Park' grant from the National Recreation and Park Association / Walt Disney Company in the amount of \$30,000, and appropriate the funds to purchase and install recreation-based equipment.

RESOLUTION NO. 175-072019: Authorize the Winnebago County Facilities and Property Management Department to Demolish the Williams Building at a Cost of \$100,000 to be Funded by the Undesignated General Fund Balance

WHEREAS, the Winnebago County Facilities and Property Management Department has identified the structure located at 504 Algoma Boulevard, commonly referred to as the "Williams Building," to be surplus space and not needed for current County space needs; and

WHEREAS, the Williams Building would require over \$250,000 in repairs, including masonry work, a new roof, and new windows; and

WHEREAS, alternatives for selling or relocating the building were investigated and are not viable; and

WHEREAS, the Winnebago County Courthouse parking lot is not in compliance with green buffer space and storm water requirements, and with the demolition of the Williams Building together with the reconstruction of the parking lot, these non-compliances can be remedied to conform with current Zoning Ordinances and provide needed additional parking spaces; and

WHEREAS, the remaining option is to raze the building.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the Winnebago County Facilities and Property Management Department to demolish the property known as the Williams Building, located at 504 Algoma Boulevard, at a cost of \$100,000 to be funded by the Undesignated General Fund balance.

WHEREAS, the Winnebago County UW-Extension has been operating a community garden on Sherman Road for the past 11 years; and

WHEREAS, the Sherman Road property is leased from the Wisconsin Department of Natural Resources, which is discontinuing the lease at the end of the 2019 growing season; and

WHEREAS, in April 2019 the Winnebago County Parks Department purchased a 20-acre parcel of land located at 770 East County Road Y and has agreed to allocate a field that is approximately 3 acres in size for development of a new community garden site; and

WHEREAS, the Winnebago County UW-Extension is working with the Winnebago County Highway Department to implement improvements to the site for the new community gardens to open in Spring 2020.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the transfer of \$39,500 from the Winnebago County Reserve Contingency Account to the Winnebago County UW-Extension's Maintenance Grounds Account to develop a new community garden on the Winnebago County Parks Department's land located at 770 East County Road Y.

RESOLUTION NO. 177-072019: Advocate the State Legislature to Expand Medicaid in Wisconsin

WHEREAS, Medicaid Expansion would increase the Medicaid-eligible income level up to 138% of the federal poverty rate; and

WHEREAS, for newly-eligible individuals (individuals who did not qualify for full Medicaid coverage prior to December 1, 2009), the federal government funds 90% of benefit costs in the calendar year 2020 and subsequent years; and

WHEREAS, between 2010 and 2015, the Affordable Care Act resulted in health insurance being provided to 212,000 additional individuals in Wisconsin; and

WHEREAS, according to the Wisconsin Department of Health Services, 1,182,681 Wisconsin residents are enrolled in Medicaid, including 25,995 Winnebago County residents; and

WHEREAS, according to previous Wisconsin County budgets, many budget increases in county departments were the result of rising health care costs; and

WHEREAS, Governor Tony Evers has included expanding Medicaid in his biennial budget; and

WHEREAS, expanding Medicaid could lead to approximately \$104 million in new investments in Winnebago County; and

WHEREAS, these investments could lead to new initiatives to improve health care access and quality for all Winnebago County residents; and

WHEREAS, the State Legislature has voted against expanding Medicaid.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby advocates expanding Medicaid in Wisconsin and investing those federal funds in Winnebago County.

BE IT FURTHER RESOLVED by the Winnebago County Board of Supervisors that it hereby directs the Winnebago County Clerk to forward a copy of this Resolution to the Office of the Governor for the State of Wisconsin, Wisconsin Counties Association, and all state senators and assembly members representing Winnebago County constituents.

RESOLUTION NO. 178-072019:

Authorize the Dissolution of Lakeland Care District Pursuant to §46.2895(13), Wis. Stats

WHEREAS, Lakeland Care District (LCD) is a long-term care district formed by Fond du Lac, Manitowoc, and Winnebago Counties by resolution pursuant to §46.2895, Wis Stats, for the purposes of delivering family care services as a managed care organization (MCO) under the State of Wisconsin's Family Care Program; and

WHEREAS, 2015 Wisconsin Act 215 amended §46.2895, Wis Stats, to allow a long-term care district such as LCD to organize a nonstock corporation under §181, Wis Stats, and transfer all assets, liabilities, contracts, permits, and certifications that are currently held by a long-term care district to a newly-formed nonstock corporation subject to the approval of the Department of Health Services (DHS) and Office of Commissioner of Insurance (OCI); and

WHEREAS, in July 2016, LCD's Board of Directors adopted a resolution indicating its intent to organize a nonstock corporation and transfer all assets, liabilities, contracts, permits, and certifications that were currently held by LCD to a newly-formed nonstock corporation; and

WHEREAS, the nonstock corporation, Lakeland Care Inc (LCI) was created in August 2016 to succeed LCD following approval from DHS and OCI; and

WHEREAS, in November 2016, DHS and OCI approved the transfer of all assets, liabilities, contracts, permits, and certifications of LCD to LCI and certified the corporation as an MCO effective January 1, 2017; and

WHEREAS, as of January 1, 2017, LCD has no continuing business operations and undertakes no activities related to the purpose for which it was formed, which was to contract with DHS for the provision of family care services; and

WHEREAS, the final step of winding down LCD's operations is the dissolution of the district, which requires joint action by LCD's Board and the county boards that formed the district pursuant to §46.2895(13), Wis Stats; and

WHEREAS, this Resolution is intended to act as Winnebago County's official action authorizing the dissolution of LCD; and

WHEREAS, the dissolution of LCD will have no impact on the operations of LCI and will not otherwise impact, financially or otherwise, the operations of Winnebago County; and

WHEREAS, the Secretary of DHS may rely on this Resolution as action on the part of Winnebago County authorizing dissolution of LCD.

NOW, THEREFORE, BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby authorizes the dissolution of Lakeland Care District pursuant to §46.2895(13), Wis Stats.

ORDINANCE NO. 179-072019: Create Section 7.16 of the General Code of Winnebago County: All-Terrain Vehicle/Utility Terrain Vehicle Routes and Regulations

WHEREAS, the Winnebago County Highway Committee has determined that the public interest is best served by allowing ATV/UTV use to utilize the County Highway system from 6:00 a.m. to 10:00 p.m. beginning May 1 and ending October 31 of the calendar year; and

WHEREAS, the Winnebago County Board supports recreational opportunities in Winnebago County; and WHEREAS, §23.33, Wis Stats, authorizes Winnebago County to adopt an ordinance allowing ATV/UTV use on

the county highway system. NOW, THEREFORE, THE WINNEBAGO COUNTY BOARD OF SUPERVISORES DOES ORDAIN AS FOLLOWS: Section 7.16 of the General Code of Winnebago County is hereby adopted and shall read as follows:

7.16 ALL-TERRAIN VEHICLE/UTILITY TERRAIN VEHICLE ROUTES AND REGULATIONS

(1) The Winnebago County Board of Supervisors adopts the following All-Terrain Vehicle/Utility Terrain Vehicle ("ATV/UTV") Routes and Regulations Ordinance for the operation of all-terrain vehicle/utility terrain vehicles upon Winnebago County roadways as listed in Section 4, below.

(2) PURPOSE & INTENT: Following due consideration of the recreational value to connect trail opportunities and weighted against possible dangers, public health, liability aspects, terrain involved and traffic density, these routes have been created.

(3) AUTHORITY: The provisions of this Ordinance are adopted by the Winnebago County Board of Supervisors pursuant to the authority granted in §23.33(8)(b), Wis Stats. The applicable provisions of §23.33, Wis Stats, regulating ATV/UTV operations pursuant to routes are adopted.

(5) CONDITIONS: As a condition for the use of this route, the following conditions shall apply to all operators (and passengers where applicable):

- (a) All ATV/UTV operators shall observe posted roadway speed limits.
- (b) All ATV/UTV operators shall ride single file.
- (c) All ATV/UTV operators shall slow the vehicle to 10 mph or less when operating within 150 feet of a dwelling.
- (d) Routes must be signed in accordance with NR 64.12 and NR 64.12(7)c, Wisconsin Administrative Code.

(6) ENFORCEMENT: This Ordinance shall be enforced by any law enforcement officer authorized to enforce the laws of the State of Wisconsin.

(7) PENALTIES: All-Terrrain Vehicle / Utility Terrain Vehicle penalties for the State of Wisconsin, as found in §23.33(13)(a), Wis Stats, are adopted and incorporated herein by reference.

(8) SEVERABILITY: The provision of this Ordinance shall be deemed severable and it is expressly declared that Winnebago County would have passed the other provisions of this Ordinance regardless of whether or not one or more provisions may be declared invalid. If any provision of this Ordinance or the application to any individual or circumstance is held invalid, the remainder of the Ordinance and the application of such provisions to other individual circumstances shall not be deemed affected.

(9) EFFECTIVE DATE: This Ordinance becomes effective as of the date following the date of its publication.
