Regarding the Adoption OF Chapter 17, Zoning Regulations

The town board of the Town of Winchester, Winnebago County, Wisconsin, does hereby ordain as follows:

- Chapter 17, a comprehensive code of zoning regulations, which was adopted pursuant to Wis. Stats 60.62 and 62.23(7), having placed on file and open to public inspection in the office of the town clerk, pursuant to Wis. Stats 66.0103, is hereby adopted as the general zoning regulations in and for the Town of Winchester, Winnebago County, Wisconsin.
- 2. This ordinance shall take effect upon passage and posting (or publication) as required by law.
