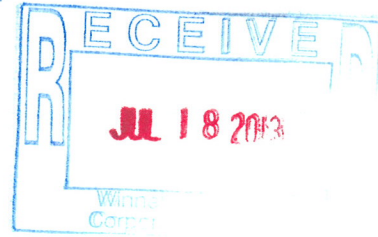

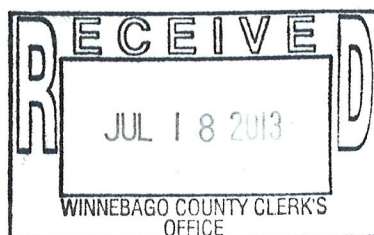
Dear Clerk Ertmer:

All evidence, documents, and proof of this claim are already compiled in the Court and D.A. Files regarding this Case: 2013-CF-240.

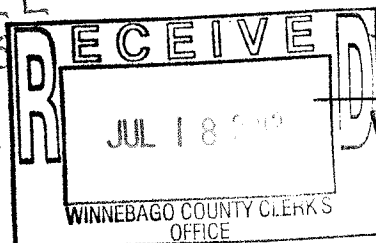
