18	programming be extended from the current 10:30 p.m. curfew to an 11:00 p.m. curfew; and

20	Vinnebago County to obtain a new City of Oshkosh Conditional Use Permit, and it would be appropriate for this			
21	ermit to reflect the standard ten (10)-year period that has typically been submitted for past racetrack Conditional
