

Winnebago County Health Department Municipalities Weekly COVID Data Summary

January 29, 2021

Summary

- As of January 28, at least 10,576 <u>COVID-19 vaccine doses</u> have been administered to Winnebago County residents that fall within <u>Phase 1a of the state's vaccination plan</u> or are at least 65 years old and 426,411 doses of COVID-19 vaccine have been administered to Wisconsin residents. Our first mass clinic site for those ages 65+ opens Monday at Sunnyview Expo in Oshkosh with online sign up starting Sunday at noon. It will take weeks to vaccinate all the currently eligible population; please be patient and see <u>our website</u> for updates. Please see these <u>tips</u> for when you do get vaccinated.
- If you are eligible for a Phase 1a vaccination and have not been offered the vaccine, please check with your employer on their vaccination plan. If you are in Phase 1a and are not affiliated with a vaccine provider, please complete this form.
- While it is very exciting that vaccine is arriving, it will take at least until the end of summer to reach an adequate level of community immunity, so we must continue to stay home, wear a mask, socially distance and practice good hand hygiene. Case rates remain very high and with the more contagious variant circulating in Wisconsin, we have to be careful to avoid another surge in virus activity.
- <u>Get tested</u> after a known or potential exposure or if you have any symptoms, even if they are mild. If you have been tested, stay home until you receive your test results and follow the guidance provided.
- If you are using options to <u>shorten quarantine</u>, be sure to continue to monitor symptoms, wear a mask, <u>social distance</u>, and avoid group activities for the full 14 days. Shortened quarantine options may not be appropriate in all settings, such as high-risk, congregate settings, including daycares and K-12 schools.
- Safely <u>support the local community</u> through curbside pickup and delivery options and seeking out businesses that engage in precautionary measures. If a business is not following recommendations, consider speaking with manager and notifying the health department through this <u>form</u>.
- There are currently 52 COVID-19 patients hospitalized in the Fox Valley.
- There have been a total of 171 confirmed COVID-19 deaths among confirmed and probable cases.
- Our confirmed + probable case burden remains very high. The confirmed + probable case rate over the past 2 weeks for our jurisdiction is 460.5 cases per 100,000 people, a decrease from 571.4 cases per 100,000 last week. The number of cases (confirmed/probable) in the first week of this 2-week timeframe was 241/111 and for this most recent week is 213/143. Individuals aged 25-29 had the highest confirmed case rates of 414.5 per 100,000. Rates are lowest in those under 18 (203.7 per 100,000).
- Over this past week, 5.9% of <u>PCR tests in Wisconsin</u> were positive and 4.7% of PCR tests across all of Winnebago
 County were positive. Many people with symptoms are only receiving antigen tests, which are excluded from our
 percent positivity calculation and likely leads to artificially lower percentages.
- Over the past two weeks, a daily average of 607 PCR tests were conducted among residents within the Winnebago County Health Department jurisdiction.
- We continue to ask for the community's help with notification of <u>close contacts</u>. Early notification and <u>quarantine</u> of exposed individuals is an important tool in limiting spread of COVID-19. View our website for updated <u>testing information</u>. WI Department of Health Services also encourages residents to download the <u>WI Exposure Notification app</u> to assist in notifying contacts of people who have tested positive for COVID-19.

Background Information

This report provides *preliminary* data on the confirmed COVID-19 cases from January 13, 2021 – January 26, 2021. A person is counted as a confirmed COVID-19 case if they had a positive confirmatory laboratory test (for example, polymerase chain reaction (PCR) tests or nucleic acid amplification tests (NAT) that detect genetic material of SARS-CoV-2, the virus that causes COVID-19). Antigen positive tests are counted as probable cases and are not currently included in the case count rates and graphs in this report. Please view the General Weekly Data Report to learn more about the confirmed and probable case counts, rates, and burden level.

Dates utilized for all graphs and tables are based on test result date and may not represent final reported case counts. Data may be underreported for recent days because results can take multiple days to be reported to the health department. This means the number of tests and percent positivity may change in next week's report. As this is a weekly report for the past 14 days, there will always be a week of overlap between reports.

*The COVID-19 data provided in this report is specific to the Winnebago County Health Department (WCHD) jurisdiction (population: 153,748). It does not include the portions of the City of Menasha or City of Appleton that fall within Winnebago County as those areas fall within the jurisdiction of the City of Menasha Health Department and City of Appleton Health Department. As of October 3, 2020, data reports from the Winnebago County Health Department do not include test results from residents in Wisconsin Department of Corrections facilities, which includes the Oshkosh Correctional Institute. This data can be found on the Wisconsin Department of Corrections website.

Data provided on the <u>Department of Health Services website</u> may be different than the information provided by WCHD because the state reports data for the entire county based on address, which includes those portions of Menasha and Appleton as well as the correctional facilities.







Case rate is determined by number of new confirmed cases during the past two weeks, divided by population in the municipality, multiplied by 100,000. Rates can fluctuate greatly with small population sizes making it difficult to call out high rates. Burden Status will only be provided for City of Neenah, City of Oshkosh, and Village of Fox Crossing due to population size. Number of cases for each Burden Status refers to the number of confirmed cases during a two-week time span.

Confirmed Case Rate Trends by Municipality

The graphs below show confirmed case rate per 100,000 people by municipalities. These case rates are based on confirmed case counts during a two-week time span.





****Due to population size, the smaller municipalities were grouped together into the following rural regions (See map on pg. 3)

- West: Towns of Nepeuskun, Poygan, Rushford, Utica, Winchester, and Wolf River
- Northeast: Towns of Clayton, Neenah, and Vinland
- Southeast: Towns of Algoma, Black Wolf, Nekimi, and Oshkosh
- Central: City of Omro, Towns of Omro & Winneconne, and Village of Winneconne

Active Cases and Total Number of Confirmed Cases by Municipality (3/11/20-1/28/21)

A person is counted as an active COVID-19 case if they had a positive confirmatory laboratory test (for example, a test that detects the virus in the nose or throat) and are currently in isolation and being followed by a disease investigator.
