

## Winnebago County Health Department COVID-19 Data by School District Geographic Boundary

February 3, 2022

Cases and hospitalizations remain critically high.

Cases are declining but your risk of exposure remains very high.

#### Summary

- The Winnebago County Health Department and Wisconsin Department of Health Services (DHS) are urging everyone to <u>take action</u> to prevent hospitalizations, deaths and further spread of COVID-19. Healthcare systems have been impacted by the record number of COVID patients and limited staff due to illness or exposure, causing some providers to defer non-urgent elective surgeries. DHS is advising everyone to get <u>vaccinated</u> against COVID-19, wear a <u>well-fitting mask</u>, avoid crowds, and get <u>tested</u> for COVID-19.
- Situational Awareness:
  - Winnebago County is at a critically high burden status and activity level. Although we are seeing a decrease
    in cases, we are likely to remain at a high level of cases for the weeks to come. If you are at high risk of
    complications from COVID-19, remain extremely cautious at this time.
  - O At this point, we have reported 10,472 confirmed + probable cases in January. This is over half of what was reported for the entire 2021 year. In 2021 we reported a total of 16,943 confirmed + probable cases.
  - Over the past 14 days, the case rate reached 2,338.2 confirmed + probable cases per 100,000 people, which is a 36% decrease from the 3,632.6 confirmed + probable cases reported in last week's report.
  - There are currently <u>97 COVID-19 patients hospitalized</u> in Fox Valley Area hospitals. Local health systems are at a crisis point and are severely strained.
  - o 31% of Winnebago County residents have received a COVID-19 booster dose and are considered "up to date" on their vaccination.
  - Due to the incredibly high number of positive COVID-19 cases, WCHD does not have the capacity to follow up with every person who tests positive at this time. If you test positive, you might receive a <u>text message</u>, voice message, and/or email from WCHD. We are asking <u>people that test positive</u> for COVID-19 to <u>reach out to all close contacts</u> themselves. Please reference <u>our website</u> for guidance following a positive test result or exposure to COVID-19.
- If you or a member of your household tested positive for COVID-19, have symptoms or were exposed, please
  follow <u>current isolation and quarantine guidance</u> to help prevent spread of the virus. Also, be sure to notify your
  workplace, school or daycare. High risk settings may have additional guidelines.
- <u>Unvaccinated people</u> account for the vast majority of severe cases, hospitalizations (over 90%) and deaths from COVID-19. <u>Vaccines</u> are proven to reduce the risk of severe illness due to COVID-19 and protect the people around you. COVID-19 vaccines are free, do not require an ID or insurance, and are available for anyone five years and older. - DHS recommends a Pfizer or Moderna booster dose at 5 months for everyone 12 years of age and older and also recommends an additional primary dose for certain immune compromised children 5- to 11- years-old.
- <u>CDC recommends</u> people receive an mRNA COVID-19 vaccine (Pfizer or Moderna) over Johnson & Johnson's COVID-19 vaccine, when possible and appropriate.
- To keep kids safe and in school, get your child vaccinated, have your child wear a well-fitting mask, stay home
  when ill, and get tested if they have symptoms or were exposed to COVID-19. If your child is ill or has been
  exposed to COVID-19, keep all other children in your household home too.
- COVID-19 testing remains an important tool in reducing spread of the virus. Whether you are vaccinated or unvaccinated, protect others by isolating if infected and get a COVID-19 test if you have symptoms, were exposed to the virus, or feel you need a test. Even if you have no symptoms or mild ones, you can infect others.
  - If you were <u>exposed to COVID-19</u>, wait 5 days from exposure to get tested. Get tested immediately if you
    have symptoms. Find additional quarantine and testing guidance on our website.

  - Sunnyview Expo Center PCR test results currently take approximately 1-2 days.

## Confirmed Cases by School District Geographic Boundary for the Past Two Weeks (January 19, 2022 – February 1, 2022)

There have been 3,140 new confirmed cases reported in the past two weeks within the geographic boundaries of the Neenah, Omro, Oshkosh, and Winneconne School Districts. An additional 168 confirmed case reported was within the geographic boundaries of other school districts that only partially fall within our jurisdiction.


## Confirmed Case Counts Among Individuals under Age 18, Trended Over Time by School District Geographic Boundary




The graphs on the following pages show how case rates by age group have changed over time for Oshkosh and Neenah School District boundaries. The first graph on each page shows the biweekly confirmed case rates per 100,000 residents. The second graph shows the cumulative confirmed case rates. Cumulative case rates will always trend upward, it is the rate of increase in that trend that helps us understand what populations are being impacted the most. Omro and Winneconne do not have similar graphs due to small population size and small confirmed case counts in these geographic areas.





Cumulative Confirmed **Case Rate** for Select Age Groups Since June 10, 2020 in the Neenah Joint School District Boundary

#### **Background Information**

This report provides *preliminary* data on the confirmed COVID-19 cases from January 19, 2022 – February 1, 2022. A person is counted as a confirmed COVID-19 case if they had a positive confirmatory laboratory test (for example, polymerase chain reaction (PCR) tests or nucleic acid amplification tests (NAAT) that detect genetic material of SARS-CoV-2, the virus that causes COVID-19). Antigen positive tests are counted as probable cases and are not currently included in the case count rates and graphs in this report. Please view the General Weekly Data Report to learn more about the confirmed and probable case counts, rates, and burden level.

Dates utilized for all graphs and tables are based on test result date and may not represent final reported case counts. Data may be underreported for recent days because results can take multiple days to be reported to the health department. This means the number of tests and percent positivity may change in next week's report. As this is a weekly report for the past 14 days, there will always be a week of overlap between reports.

Data by school district geographic boundary may differ from data provided by the respective school district. School district geographic boundaries are the geographic area from which children are **eligible** to attend a certain school district. Data by school district geographic boundary includes cases among all individuals that live within that boundary regardless of age or where they attend school. In this report, data for school age children (5-17) does not differentiate between where they actually attend school or if they are homeschooled.

\*The COVID-19 data provided in this report is specific to the Winnebago County Health Department (WCHD) jurisdiction (population: 153,748). It does not include the portions of the City of Menasha or City of Appleton that fall within Winnebago County as those areas fall within the jurisdiction of the City of Menasha Health Department and City of Appleton Health Department. As of October 3, 2020, data reports from the Winnebago County Health Department do not include test results from residents in Wisconsin Department of Corrections facilities, which includes the Oshkosh Correctional Institute. This data can be found on the Wisconsin Department of Corrections website.

Data provided on the <u>Department of Health Services website</u> may be different than the information provided by WCHD because the state reports data for the entire county based on address, which includes those portions of Menasha and Appleton as well as the correctional facilities.
