

Winnebago County Health Department Municipalities Weekly COVID Data Summary

March 11, 2021

Summary

- The Wisconsin Department of Health Services (DHS) <u>announced today</u> that people age 16 and older with certain medical conditions will be eligible for the COVID-19 vaccine beginning March 29. You can view details regarding the next eligible group on the <u>DHS website</u>.
- While it is very exciting that there are now three COVID-19 vaccines available, it may still take months before
 we have enough people vaccinated to reach an adequate level of community immunity. It is important to
 continue to practice COVID-19 prevention measures including staying home, wearing a mask, social
 distancing and practicing good hand hygiene. When you do get vaccinated, please see these tips.
- Know your status. Anyone who feels they need to be tested, should get <u>tested</u>. At-home <u>specimen collection kits</u> are available at no cost to Wisconsinites, regardless of symptoms or exposure. Case rates may be improving, but they are still considered high. Any respiratory illness should be a suspected COVID-19 case. Most PCR results are returned within 24-36 hours. Antigen testing is available at the <u>UWO Culver Welcome Center</u> with antigen results available in about 20 minutes. The Culver Center also provides PCR confirmation testing. If you have been tested, stay home until you receive your test results and <u>follow this guidance</u>.
- As kids return to in-person school, sports, and other extracurricular activities, we strongly encourage families to <u>get tested</u> for COVID-19, so we can keep our schools and sports open! Social distance, wear masks and do not host or participate in team social gathering events.
- On March 1st, education staff and staff in *licensed* child care settings were among the groups added to the <u>eligible population</u> to receive the COVID-19 vaccine. If you fall within the currently eligible population, please connect with your employer regarding the vaccination plans for their employees. It will take weeks to fully vaccinate all the population currently eligible; please be patient and see <u>our website</u> for updates and vaccine clinic locations. *Being eligible does not mean vaccine is available right now.*
- As of March 10, 52,833 COVID-19 vaccine doses have been administered to Winnebago County residents that
 are <u>currently eligible</u> to receive the vaccine, and 1,743,880 doses of COVID-19 vaccine have been
 administered to Wisconsin residents.
- Our confirmed + probable case burden remains high and relatively unchanged over the past few weeks. The confirmed + probable case rate over the past 2 weeks for our jurisdiction is 165.9 cases per 100,000 people, a slight decrease from 173.7 cases per 100,000 reported last week. The number of cases (confirmed/probable) in the first week of this 2-week timeframe was 83/41 and for this most recent week is 83/48.
- Individuals under 18 had the highest PCR confirmed case rates of 168.1 per 100,000. Rates are lowest in those aged 60+ (52.5 per 100,000).
- There are currently 10 COVID-19 patients hospitalized in the Fox Valley.
- There has been a total of 182 confirmed COVID-19 deaths among confirmed and probable cases.
- Over this past week, 2.2% of <u>PCR tests in Wisconsin</u> were positive, 2.5% of PCR tests across all of Winnebago
 County were positive, and 2.4% of PCR tests across Winnebago County Health Department jurisdiction were
 positive. Over the past two weeks, 2.1% of PCR tests were positive in our jurisdiction. Many people with
 symptoms are only receiving antigen tests, which are excluded from the percent positivity calculation and likely
 leads to artificially lower percentages.
- Over the past two weeks, a daily average of 558 PCR tests were conducted among residents within the Winnebago County Health Department jurisdiction.







Case rate is determined by number of new confirmed cases in a particular group (such as a municipality) during the past two weeks, divided by the population of that particular group, multiplied by 100,000. Rates can fluctuate greatly with small population sizes making it difficult to call out high rates. Burden Status will only be provided for City of Neenah, City of Oshkosh, and Village of Fox Crossing due to population size. Number of cases for each Burden Status refers to the number of confirmed cases during a two-week time span.

Confirmed Case Rate Trends by Municipality

The graphs below show confirmed case rate per 100,000 people by municipalities. These case rates are based on confirmed case counts during a two-week time span.





****Due to population size, the smaller municipalities were grouped together into the following rural regions (See map on pg. 3)

- West: Towns of Nepeuskun, Poygan, Rushford, Utica, Winchester, and Wolf River
- Northeast: Towns of Clayton, Neenah, and Vinland
- Southeast: Towns of Algoma, Black Wolf, Nekimi, and Oshkosh
- · Central: City of Omro, Towns of Omro & Winneconne, and Village of Winneconne

Active Cases and Total Number of Confirmed Cases by Municipality (3/11/20-3/10/21)

A person is counted as an active COVID-19 case if they had a positive confirmatory laboratory test (for example, a test that detects the virus in the nose or throat) and are currently in isolation.

Background Information

This report provides *preliminary* data on the confirmed COVID-19 cases from February 24, 2021 – March 9, 2021. A person is counted as a confirmed COVID-19 case if they had a positive confirmatory laboratory test (for example, polymerase chain reaction (PCR) tests or nucleic acid amplification tests (NAT) that detect genetic material of SARS-CoV-2, the virus that causes COVID-19). Antigen positive tests are counted as probable cases and are not currently included in the case count rates and graphs in this report. Please view the General Weekly Data Report to learn more about the confirmed and probable case counts, rates, and burden level.

Dates utilized for all graphs and tables are based on test result date and may not represent final reported case counts. Data may be underreported for recent days because results can take multiple days to be reported to the health department. This means the number of tests and percent positivity may change in next week's report. As this is a weekly report for the past 14 days, there will always be a week of overlap between reports.

*The COVID-19 data provided in this report is specific to the Winnebago County Health Department (WCHD) jurisdiction (population: 153,748). It does not include the portions of the City of Menasha or City of Appleton that fall within Winnebago County as those areas fall within the jurisdiction of the City of Menasha Health Department and City of Appleton Health Department. As of October 3, 2020, data reports from the Winnebago County Health Department do not include test results from residents in Wisconsin Department of Corrections facilities, which includes the Oshkosh Correctional Institute. This data can be found on the Wisconsin Department of Corrections website.

Data provided on the <u>Department of Health Services website</u> may be different than the information provided by WCHD because the state reports data for the entire county based on address, which includes those portions of Menasha and Appleton as well as the correctional facilities.
