

# Winnebago County Health Department Municipalities Weekly COVID Data Summary

September 24, 2020

#### Summary

- <u>Just Stay Home.</u> There is significant uncontrolled spread of COVID-19 in our community. We have seen exponential growth of cases the past few weeks. Cases in the Oshkosh-Neenah area have been increasing at the <u>fastest rate</u> in the nation, and there are thousands of people currently infected in the Fox Valley area. Avoid unnecessary travel within the community that puts you in contact with others, stay away from bars and other group gatherings, and only order takeout from restaurants to limit your exposure. This uncontrolled spread has resulted in the closing of Oshkosh schools and continues to threaten the ability of other schools and businesses to remain open.
- The current burden of confirmed COVID-19 cases is critical and the activity level is high. The number of new cases continues to accelerate upwards and is **exceeding the ability of testing and case investigation to control the spread of illness**. The number of cases in the first week of this 2-week timeframe was 378 and for this most recent week is 778 a 106% increase in cases in one week and is over five times higher than three weeks ago.
- This rapid acceleration of cases is largely being driven by the young adult population with spread to other age groups in household, workplace and educational settings. Cases will continue to accumulate at a very rapid rate. Be considerate of others if you do not practice physical distancing, you risk infecting others at home, work and in the community that may have serious or life-threatening consequences.
- The confirmed case rate over the past 2 weeks for our jurisdiction is 748.8 cases per 100,000, a 125% increase from the 332.9 per 100,000 reported last week, and the highest biweekly case rate for our jurisdiction to date. For all of Winnebago County, the case rate over the past 2 weeks is 732.2, and for the Fox Valley HERC region it is 662.8\*, putting both at a critical burden level.
- Individuals aged 18-24 had the highest confirmed case rate of 2,543 per 100,000 over the past 2 weeks. This means over 2.5% of the total estimated 18- to 24-year-old population tested positive, and this is likely a significant underestimate of the true percent of this age group currently infected.
- **Testing percent positivity is at 13.7%** for the past 2 weeks, which is up from 9% last week and trending farther away from our goal of remaining below 5% positivity. The <u>regional COVID-19 testing site</u> at Sunnyview Expo Center in Oshkosh is now running at over 750 tests per day.
- COVID-19 hospitalizations are hitting record levels across the state. In our region, COVID-19
   hospitalizations are at the highest level to date more than 5 times as high as they were one month
   ago. As of 9/23/20, Fox Valley Area hospitals had 81 COVID-19 patients hospitalized, an increase from
   the 60 hospitalized patients last week. 11 of those patients are in the ICU.
- Contact tracing capacity is significantly strained. Our goal is to reach out to all confirmed cases within 24 hours of being reported to the health department, but due to the current surge in cases we are days behind this goal. Additionally, only the highest risk close contacts are being contacted directly by public health we are asking confirmed cases to reach out to all other close contacts themselves.
- On September 23, 6 Wisconsin cities were in the <u>New York Times top 20 list</u> of metro areas where cases are rising the fastest in the United States with the Oshkosh-Neenah area ranked #1.
- Older adults and people with underlying medical conditions are most at risk. If you have cancer, chronic kidney disease, COPD, obesity, serious heart conditions, sickle cell disease, or diabetes, you should take these warnings very seriously and take extra precautions to stay safe.

#### **Background Information**

This report provides *preliminary* data on the confirmed COVID-19 cases from September 9 – September 22, 2020 for municipalities located within the Winnebago County Health Department jurisdiction. Dates utilized for all graphs and tables are based on test result date and may not represent final case counts. Data may be underreported for recent days because results can take multiple days to be reported to the health department. As this is a weekly report for the past 14 days, there will always be a week of overlap between reports.

\*The COVID-19 data provided in this report is specific to the Winnebago County Health Department (WCHD) jurisdiction (population: 154,379). It does not include the portions of the City of Menasha or City of Appleton that fall within Winnebago County as those areas fall within the jurisdiction of the <a href="City of Menasha Health Department">City of Appleton Health Department</a>. Data provided on the <a href="Department of Health Services website">Department</a> of Health Services website may differ than the information provided by WCHD because the state reports data for the entire county, which includes those portions of Menasha and Appleton.







Case rate is determined by number of new confirmed cases during the past two weeks, divided by population in the municipality, multiplied by 100,000. Rates can fluctuate greatly with small population sizes making it difficult to call out high rates. Burden Status will only be provided for City of Neenah, City of Oshkosh, and Village of Fox Crossing due to population size. Number of cases for each Burden Status refers to the number of confirmed cases during a two-week time span.

### Confirmed Case Rate Trends by Municipality

The graphs below show confirmed case rate per 100,000 people by municipalities. These case rates are based on confirmed case counts during a two-week time span.

- Central: City of Omro, Towns of Omro & Winneconne, and Village of Winneconne

# Active Cases and Total Number of Confirmed Cases By Municipality (3/11/20-9/23/20)

A person is counted as an active COVID-19 case if they had a positive confirmatory laboratory test (for example, a test that detects the virus in the nose or throat) and are currently in isolation and being followed by a disease investigator.
